Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Defined Contribution Pension Plan for Employees of Lincoln, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statements of Changes in Net Assets Available for Benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Defined Contribution Pension Plan for Employees of Lincoln's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

1. Description of Plan

The following brief description of Defined Contribution Pension Plan for Employees of Lincoln (“the Plan”) is provided for general information purposes only. Participants should refer to the Plan’s agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution tax deferred savings plan available to eligible employees of Lincoln (“the Employer”). The Plan is intended to qualify under Section 401(a) of the Internal Revenue Code (“IRC”). Generally, the Plan covers all eligible employees who have completed one year of service, as defined by the Plan, in the twelve-month period commencing with their employment date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Plan Administration

The Employer is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Employer has delegated certain responsibilities for the operation and administration of the Plan. Trustee and recordkeeping services are provided by American United Life Insurance Company (“AUL”).

Certain administrative expenses of the Plan, including recordkeeping, were paid directly by the Employer, for the years ended December 31, 2024 and 2023. Investment fees, which may vary according to the individual funds selected, are paid out of the assets of the Plan. Participants should refer to the prospectus of the individual investment funds for further details on individual investment fees.

Contributions

Under the provisions of the Plan, the Employer can elect to contribute amounts to the Plan to be credited to the accounts of the participants. No contributions are made to the Plan by participants. Effective as of July 1, 2007, the Plan changed the employer contribution rate from 9% to the following percentages: 5% of compensation for participants with less than 8 years of service, and 9% of compensation for participants with 8 or more years of service.

Participants Accounts

Each participant's account is credited with the Employer's contribution and earnings thereon and is charged with an allocation of applicable administrative expenses. Allocations are based on participant’s earnings or account balance, as defined. Participants select the allocation of investment funds to be applied to contributions credited to their account.

NOTES TO FINANCIAL STATEMENTS

1. Description of Plan, continued

Vesting

Participants are fully vested, regardless of their years of service, in the event of death, total and permanent disability, or retirement, if the participant is 55 years of age or older. In the event of termination for any cause other than death, disability, or retirement, a participant's vesting is based on a three-year cliff vesting schedule in which the participant is fully vested after three years of credited service, as defined.

Payment of Benefit

Upon termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum amount or an annuity contract calling for monthly payments for a certain period. Upon participant termination and purchase of an annuity contract for the participant, the annuity investment is excluded from the Plan assets.

Plan Loans

Participants may borrow from their accounts up to a maximum amount generally equal to the lesser of \$50,000 and 50% of their vested account balance, all loans must be repaid within 5 years unless the loan is for the purchase of a principal residence for which the loan repayment may exceed 5 years. Borrowers are required to assign 50% of the interest in their account as collateral for the loan. Additional discretionary collateral may be required to adequately secure the loan. Loans bear an interest rate of 5%, which is commensurate with local prevailing rates. Principal and interest are generally repaid through payroll deductions to the participant's segregated account.

Forfeited Accounts

Forfeitures are the non-vested amounts in the accounts of participants who terminate employment. Forfeited funds are used to pay certain plan expenses. Any remaining forfeiture will be used to reduce future contribution to the Plan.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies applied in the preparation of the accompanying financial statements is as follows:

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments in the general account and the registered investment companies, which consist of various mutual funds, are stated at fair value, as reported by AUL, as determined by quoted market prices of the underlying investments. Participant loans are valued at cost, which approximates fair value.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Fair Value Measurements

Generally accepted accounting principles provide guidance on how fair value should be determined when financial statement elements are required to be measured at fair value. Valuation techniques are ranked in three levels depending on the degree of objectivity of the inputs used with each level:

Level 1 inputs - quoted prices in active markets for identical assets

Level 2 inputs - quoted prices in active or inactive markets for the same or similar assets

Level 3 inputs - estimates using the best information available when there is little or no market

The Plan is required to measure investments at fair value. The specific techniques used to measure fair value for the financial statement element is described in the notes below that relate to the element.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures as of the date and for the period presented. Actual results may differ from those estimates.

Administrative Expenses

The Plan generally will pay the expenses of plan administration and will assess the expenses paid against the accounts of all participants in the Plan. The Plan may, from time to time, change the manner in which expenses are allocated. For the years ended December 31, 2024 and 2023, total administrative charges were \$376 and \$739, respectively.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risk. It is reasonable possible, given the level of risk associated with certain investment securities that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

The Plan's exposure to a concentration of credit risk is limited by diversification of investments across various assets classes and the utilization of investment managers.

Subsequent Events

Management has evaluated subsequent events through October 1, 2025, the date which the financial statements were available for issue. No events or transactions have occurred during this period that appear to require recognition or disclosure in the financial statements.

3. Notes Receivable from Participants

Notes receivable from participants are repaid monthly at an interest rate of 5.00%, with various maturities. Notes receivable to participants outstanding at December 31, 2024 and 2023 were \$192,148 and \$56,276, respectively.

4. Information Prepared and Certified by the Trustee

No auditing procedures were performed on investments and plan income as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

The Plan offers an interest-bearing stable value investment option through a fully benefit-responsive group annuity contract issued by AUL, backed solely by AUL's general account assets, with participants having no ownership interest in the underlying investments. As of December 31, 2024, the contract provided a net credited interest rate of 1.75%, with 2.00% declared for 2025. This rate is net of administrative and investment-related fees retained by AUL and is compounded daily to produce the stated annual yield, with no possibility of a negative rate or a stated minimum guaranteed rate. Participant account balances may be transferred or withdrawn daily at contract value, subject to standard plan provisions, except that transfers to competing investment options are subject to a 90-day equity wash restriction. In the event of plan termination, significant sponsor-initiated withdrawals, or certain plan-level events, a 12-month put provision applies before balances may be withdrawn at contract value, and no market value adjustments will be made. The investment is reported at contract value, representing contributions plus credited interest less participant withdrawals, with no fair value measurement applied.

7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan for any reason, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

8. Related Party and Party-in-Interest Transactions

ERISA defines parties-in-interest more broadly than generally accepted accounting principles' related parties, encompassing all service providers to the Plan. Management identified no related parties that were not also parties-in-interest, and no material related party transactions occurred during the Plan year regarding compensation arrangements, expense allowances, or similar items.

Parties-in-interest transactions include those with Plan fiduciaries or employees, service providers, employers with covered employees, employee organizations with covered members, and persons owning 50% or more of such employers or employee associations, along with their relatives. Trustee transactions, including revenue sharing and fee offset agreements, as well as the Plan's payment of certain plan fees and expenses, qualify as parties-in-interest transactions. Administrative fees paid by the Plan to the trustee were \$376.

The Plan's investment options include funds managed by the custodian or its affiliates. As custodian and recordkeeper, AUL's transactions qualify as exempt parties-in-interest transactions.

9. Tax Status

The Plan obtained its latest determination letter, which was dated November 30, 2020, in which the Internal Revenue Service ("IRS") stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.
