NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. THE PLAN

The following description of the TIAA-CREF Tax Deferred Annuity Plan for All Employees of Maria College (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a contributory defined contribution 403(b) plan established for employees of Maria College (the College). The Plan is administered by management of the College and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The insurance companies of the Plan are Teachers Insurance Annuity Association (TIAA) and College Retirement Equities Fund (CREF).

Eligibility

All employees of the College are eligible to begin salary deferrals upon their date of employment. Employees are eligible to receive employer matching contributions after attaining the age of twenty-one (21) and completing one (1) year of service. As of July 1, 2023, newly hired employees who were previously employed with an educational organization that provides post-secondary education and were eligible for the institutions contribution towards their retirement plan will be eligible for the College's match up to a maximum of 5%.

Contributions

Each year participants may elect to contribute a percentage of their eligible compensation, subject to the maximum dollar amount limit as determined by the Internal Revenue Code (the "Code") and regulations thereunder. Participants over the age of 50 are eligible to make catch-up contributions. In addition, participants may rollover an eligible rollover distribution from a qualified plan.

The College provides matching contributions equal to 5% of the participant's compensation provided the participant elective deferrals equal or exceed 5% of their compensation. The Plan will include catch-up deferrals in the elective deferral amount used to determine the matching contribution.

Vesting

Participants are immediately vested in their voluntary contributions, matching contributions, and actual investment earnings and losses thereon.

Investment Options

The Plan currently offers several registered investment company accounts, fixed annuity contracts, and a pooled separate account. Participants may change their investment options daily.

1. THE PLAN (Continued)

Participant Accounts

Each participant's account is credited with (a) the employee's contributions, (b) the College's matching contribution, and (c) Plan earnings/losses associated with the participant's account. Allocations are based on participant earnings or account balances, as defined in the Plan Document.

Administrative Expenses

The Plan permits the payment of Plan expenses to be made from Plan assets. Substantially all administrative expenses associated with the Plan are paid by Plan participants as a reduction of investment income.

Payment of Benefits

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the full or partial value of the vested balance in their account, installments, annuity, or ad-hoc distributions. Benefits to terminated participants are recorded when paid.

Hardship Withdrawals

Prior to age 59 ½, a participant may withdraw his or her participant contributions for reasons of hardship. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of additions and deductions during the reporting period. Accordingly, actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options in a variety of investment securities. Investment securities are exposed to various risks, such as interest rate risk, financial market risk and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statement of net assets available for benefits.

Investment Valuation and Income Recognition

The Plan invests in registered investment company accounts, pooled separate accounts, and fixed annuity contracts. Registered investment companies, pooled separate accounts, and non-benefit responsive fixed annuity contracts are reported at fair value. Fully benefit responsive fixed annuity contracts are stated at contract value, as this is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. All investments are participant-directed.

Fair Value Measurement

Accounting Standards Codification (ASC) Section 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC Section 820 are described below:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodology used for assets measured at fair value.

Registered investment company contracts accounts: Valued at the net asset value of shares held at year end based on quoted prices in active markets. Included in registered investment companies are variable annuity contracts, which are valued at year end based on quoted prices in active markets.

Pooled separate account: The fair values of interests in pooled separate accounts are measured based upon Net Asset Value ("NAV") published on a daily basis using the fair value of the fund's underlying assets.

Non-benefit responsive fixed annuity contract: Value is calculated as accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

3. CERTIFIED INVESTMENT INFORMATION

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA and CREF, have certified that the following data included in the financial statements and accompanying supplemental schedule is complete and accurate as of December 31, 2024 and 2023.

5. FIXED ANNUITY CONTRACTS

The Plan's investment in fixed annuity contracts is comprised of guaranteed insurance contracts established between the Plan's participants and TIAA and CREF. These contracts guarantee the participants' principal and a minimum interest rate. In addition, participants have the opportunity to earn amounts in excess of the guaranteed rate.

The Plan has non-benefit responsive fixed annuity contracts with TIAA and CREF, totaling \$2,193,435 and \$2,170,153 at December 31, 2024 and 2023 respectively and fully benefit-responsive fixed annuity contracts with TIAA totaling \$137 and \$131 at December 31, 2024 and 2023, respectively. TIAA and CREF maintain Plan contributions in separate accounts. The accounts are credited with contributions and earnings on the underlying investments and are charged for Plan withdrawals.

For fixed annuity contracts, TIAA and CREF determine contract value, which approximates fair value, using two different methods, a discounted cash flow model and a theoretical transfer value. The discounted cash flow method is calculated using a risk-adjusted market discount rate, which correlates closely with the Plan's fixed annuity interest rate. The interest rate associated with the Plan's Fixed Annuity Contract can range from approximately 3% to 6% based on the current market environment. The theoretical transfer value method presumes that contributions into the annuity represent transactions between a willing buyer and seller, and therefore, establish a market.

5. FIXED ANNUITY CONTRACTS (Continued)

The fixed annuity contracts guaranteed minimum returns are supported by the TIAA and CREF General Account portfolio, which invests primarily in U.S. debt instruments and investment grade corporate bonds; however, is also permitted to invest in higher risk securities, including but not limited to, sub-investment grade corporate bonds, common stock, and real estate. The assets and earnings from this portfolio are used to pay the guaranteed interest rate associated with the annuity contracts, as well as future annuity payments.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the College has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their accounts.

7. PARTY-IN-INTEREST TRANSACTIONS

The Plan allows participants of the Plan to invest in certain funds that are managed by TIAA and CREF. As such, transactions between the participants investing in these funds and the Plan qualify as party-in-interest transactions

8. TAX STATUS

The Plan is exempt from federal and state income tax under Section 403(b) of the Internal Revenue Code. The Plan is required to operate in conformity with the Internal Revenue Code to maintain its tax exemption. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income tax has been included in the Plan's financial statements.
