To the Trustee of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Chipman Corporation (the "Company"), 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1. Plan Description:

The following description of the Chipman Corporation (the "Company") 401(k) Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees who are not excluded employees as defined under the Plan document. The Plan was originally effective on January 1, 1985. The amended and restated provisions of the Plan became effective on July 1, 2015 and was further amended on October 1, 2015. Thereafter, the Plan was restated on January 1, 2022 and amended on January 1, 2023. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA).

Eligibility and Plan Entry Date

The Plan is available to employees of the Company who have attained the age of twenty-one (21) and have completed at least one (1) hour of service within the first 12 month(s) of employment. Employees may enter the Plan as of the first day of the calendar quarter coinciding with or next following the date eligibility requirements have been met.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation as defined in the plan document, subject to annual statutory limitations. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contribution is invested directly into the Plan's default fund. Participants may also contribute ("rollover") amounts representing distributions from other qualified defined benefit or contribution plans. The Company may make discretionary profit-sharing contributions. The Company may also make additional contributions in order to pass discrimination tests required under the Internal Revenue Code (IRC). In addition, the Company matches 100% of the employee's contribution up to the first \$500 annually.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) any Company contributions (b) Plan gains and losses (c) and an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeiture Accounts

If a participant is not vested or is partially vested in their account balance when they terminate employment, the non-vested portion of their account balance will be forfeited immediately following the Plan year in which the forfeiture occurs. At December 31, 2024 and 2023 forfeited non-vested accounts totaled \$11,622 and \$6,425, respectively. Forfeitures are used to reduce future Company matching contributions or non-elective contributions.

Note 1. Plan Description (continued):

Investment Options

Investments are entirely participant directed. Upon enrollment in the Plan, a participant may direct employee contributions in any of the investment options offered. A variety of investment options offer participants a diversified portfolio.

Participants may change their investment options at will.

Vesting

Participants are immediately vested in their contributions and rollovers plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service as indicated in the table below:

<u>Years of Service</u>	<u>Percentage</u>
1	20%
2	40%
3	60%
4	80%
5	100%

Generally, an employee is credited with a year of service if the employee completes at least 1 hour of service during the year.

Participants will be 100% vested in the Company's matching and discretionary contribution plus earnings if they are employed on or after their Normal Retirement Age of 55 or if they die or become disabled.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their account balance or \$50,000, reduced by the highest outstanding loan balance attributable to the participant during the 12-month period immediately prior to the new loan application date. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loans fund. Loan terms shall not exceed 5 years or 15 years for the purchase of a principal residence. The loans are fully amortized and secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Loans outstanding as of December 31, 2024 bear interest rates of approximately 3.25%-8.50%. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits

On termination of service due to termination of employment, death, disability, or retirement, a participant may elect to receive either (1) a single lump-sum payment, (b) installments over a period of not more than the assumed life expectancy or joint life expectancy, (3) partial withdrawals of at least \$1,000, or (4) partial withdrawals or installments but only with respect to minimum required distributions over a period of not more than the assumed life expectancy.

Note 2. Summary of Significant Accounting Policies:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant defaults on their loan, the balance will be reduced and reclassified as distributions in accordance with plan document.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) include the Plan's gains and losses on investments purchased and sold as well as held during the year.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS is recorded as a liability with a corresponding reduction to contributions. The Plan is required to distribute any excess contributions made during the year to the applicable participants prior to March 15 of the subsequent year. For the years ended December 31, 2024 and 2023, the excess contributions was \$0 and \$4,219, respectively.

Note 3. Fair Value Measurements:

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that provides the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Methodology Used to Determine Fair Value of Investments

Pooled Separate Accounts

The Standard's pooled separate accounts are not themselves publicly traded but are composed of assets that are either priced by a pricing service or directly by the relevant mutual fund company trading partner. The accounts are subject to unitization valuation processes. The underlying mutual funds are traded daily on an active market and all the unit values are observable.

For the years ended December 31, 2024 and 2023, there have been no significant transfers between level 1 and level 2 and no transfers in and out of level 3.

Note 4. Stable Value Contract with The Standard:

In 2018, the Plan entered into a fully benefit-responsive stable value contract with the Standard Insurance Company (the "Standard") totaling \$361,745 and \$283,307 for the years ended December 31, 2024 and 2023. The Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Stable Value contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. For the years ended December 31, 2024 and 2023, the crediting interest rate was 2.63 percent and 2.37 percent, respectively. The crediting rate is reviewed on a quarterly basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by The Standard, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. The plan sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected. If the plan sponsor views the occurrence of any of these events as probable as of the measurement date, details about market value adjustments or other withdrawal restrictions can be obtained through the plan's account manager.

The Standard may terminate the contract with 30 days advance written notice to the contract owner for reasonable cause, which includes the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification, and failure to adopt the plan in a reasonable period of time. Upon termination by The Standard, a market value adjustment or other withdrawal restrictions may apply. The plan sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected.

Note 5. Information Certified by the Custodian:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value investments, interest and dividends for the year ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by The Standard.

Note 6. Related Party and Parties-in-Interest Transaction:

Various investment options offered by the Plan are investments which are managed by The Standard, custodian of the Plan. Any purchases and sales of these funds are performed in the open market. Such transactions, while considered related party and parties-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of parties-in-interest transactions under ERISA. Fees incurred and paid directly to the investment management services at December 31, 2024 and 2023, totaled \$73,547 and \$65,892, respectively.

Note 7. Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants will become 100% vested in their account balance.

Note 8. Income Tax Status:

The Company has adopted the Standard Volume Submitter Profit Sharing Plan (the "Prototype Plan"). The Internal Revenue Service (IRS) has informed The Standard by a letter dated March 31, 2014, that the form of the Volume Submitter Plan is acceptable under section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. Since then the Plan has been amended, it has not requested a separate determination letter from the IRS because, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is qualified to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Pursuant to IRC Sec 6501(a) and (e), the Plan is no longer subject to income tax examinations for years prior to 2018. The Plan has no uncertain tax positions as of December 31, 2024 and 2023.

Note 9. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, overall market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan has implemented certain requirements by the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act), which laws change the Plan to, among others, allow certain eligible individuals to receive coronavirus-related relief for loan repayment, suspend required minimum distributions, and delay the commencement date for required minimum distributions. Written amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable law and IRS guidance.
