### **Scope and Nature of the ERISA Section 103(a)(3)(C) audit**

We were engaged to perform audits of the financial statements of Causley Trucking, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) audit. The financial statements comprise the statement of net assets available for benefits as of December 31, 2023 and 2024, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Causley Trucking, Inc. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in notes to the financial statements, is complete and accurate.

### **Disclaimer of Opinion**

We do not express an opinion on the financial statements of Causley Trucking, Inc. Retirement Plan referred to in the first paragraph. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### **Basis for Disclaimer of Opinion**

Causley Trucking, Inc. Retirement Plan does not have sufficient accounting records and supporting documents relating to Plan's prior year records, we were unable to perform auditing procedures with respect to individual participant account balances accumulated from inception of the Plan or to satisfy ourselves as to the basis on which participants' equity is stated as of December 31, 2023 and 2024, or the propriety of the distributions to participants who terminated during the years then ended. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Causley Trucking, Inc. Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Our responsibility is to conduct an audit of Causley Trucking, Inc. Retirement Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of Causley Trucking, Inc. Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits

NOTES TO FINANCIAL STATEMENTS  
YEAR ENDED DECEMBER 31, 2024

DESCRIPTION OF PLAN:

The following description of Causley Trucking, Inc. Retirement Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan was originally established on March 1, 1972. The Plan was restated, effective June 30, 2016. It is intended that the Plan, as restated, shall qualify as a profit sharing plan under the Internal Revenue Code of 1986.

General- All funds in trust are held by the Principal Life Insurance Company. Plan year end is a normal calendar year. Normal age of retirement is sixty-five years.

Vesting-A participant's balance is 100% vested.

Funding Policy-The employers' contributions are made based on the agreement with each employer.

Contributions – Each year, participants may contribute a percentage of their eligible compensation. Catch-up, Roth, bonus, and roll-over contributions may also be made. Contributions are subject to certain limitations. Participants direct the investment of their and employer contributions into various investment options offered by the Plan.

Loans to Participants – Participants may borrow from their fund accounts a minimum of \$1,000.00 up to a maximum of \$50,000.00 or 50% of their account balance, whichever is less. The notes are secured by the balance in the participants account, and interest is computed based on prime rate principal and interest paid ratably through monthly payroll deductions.

Payment of Benefits-Upon termination of service, benefits may be paid either as lump sum or monthly annuity payments. In the case of death prior to termination of employment, the benefit is payable as a lump sum to the designated beneficiaries. Further restrictions apply to these payment methods; these restrictions are listed in the Plan agreement.

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Estimates-The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments-The Plan's investments are stated at fair value.

Payment of Benefits-Benefits are recorded when paid.

OTHER COMMITMENTS:

To the best of our knowledge, there are no material lease commitments, contingent liabilities or transactions with persons known to be parties in interest as of December 31, 2024.

TERMINATION OF PLAN:

Upon termination of the Plan, the Account of each Participant shall be 100% vested and non-forfeitable.

## TAX STATUS:

The Plan obtained its latest determination letter on July 18, 2012, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code.

The Plan files Form 5500 annually with the Internal Revenue Service. The tax years that remain open for examination under the IRS are 2021, 2022, and 2023.

## BANK CERTIFICATION OF CERTAIN DATA:

Section 2520.103-8 of the Department of Labor Rules and Regulations for reporting and disclosing under ERISA permits that a bank which holds the assets of a pension plan may certify to the accuracy and completeness of certain financial information and other disclosures required by ERISA. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY:

The Plan holds a fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal Life) with Principal Trust Company as custodian. Principal backs the contract with the assets in the general account. Principal maintains the contributions in general account. The participant account is credited with earnings on the underlying investments, netted with deduction for fees, and charged for participant withdrawals. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2023 and 2024, was \$736,705 and \$455,559, respectively. The crediting interest rate is based on a formula agreed upon with the issuers, but may not be less than 1%. Such interest rates are reviewed on semi-annual basis for resetting.

The average yield for 2023 and 2024 were 2.66% and 6.479% respectively.

Benefit payments described in the contract are made at book value (i.e. no market value adjustments or surrender charge adjustments) for the plan benefit events.

An employer – level liquidation or employer initiated transfer of the Plan’s interest in the contract will be subject to either a 12-month irrevocable advance notice or a 5% surrender charge, whichever the employer chooses.

RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

RELATED PARTY TRANSACTIONS:

The Plan invests in various investments managed by Principal Trust Company. Principal Trust Company is the trustee of the Plan, therefore, these transactions qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from prohibited transactions rules of ERISA.

SUBSEQUENT EVENTS:

Management has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.
