Dear Sir or Madam,

This letter is submitted to respectfully request consideration for reasonable cause in connection with the late filing of Form 5500-SF for the above-referenced plan.

Dental Auxiliary & Professional had previously engaged **Paychex** as its payroll service provider. Paychex had consistently handled all prior Form 5500-SF filings for the organization. When the business ceased active operations and no longer had employees in 2023, Paychex prepared the final Form 5500-SF for that plan year. However, because Paychex was no longer managing our payroll account, they did not file the completed Form 5500-SF with the Department of Labor as required — and unfortunately, they did not notify us that the filing had not been submitted.

We only became aware of the oversight upon receiving a notice from the IRS. The delay was not the result of willful neglect, but rather a good faith misunderstanding and a lack of notification from our former payroll provider.

No plan participants or beneficiaries were adversely affected, and the plan was already in the process of termination with no active assets or contributions at the time of the missed filing.

We respectfully request that the Department consider these facts and not impose penalty or sanction because of the late filing.
