NOTE A - DESCRIPTION OF THE PLAN

The following description of the Menard, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan covering substantially all employees of Menard, Inc. (the Plan Sponsor or Employer) who have completed one year of service or 1,000 hours of service and attained age 21. Effective November 1, 2024, employees are eligible to participate in the plan after completing 60 consecutive days of service and 18 years of age. The Plan excludes leased employees, employees covered by a collective bargaining agreement and non-resident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

The Plan includes a cash or deferred arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants may contribute up to 50% of their pre-tax eligible compensation, subject to Plan limitations. The Plan allows participants age 50 and older to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their salary deferrals into various investment options offered by the Plan. Contributions are subject to limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Income is allocated daily based on the shares in the participant's account. Participants may change their investment options daily. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon.

Payment of Benefits

Upon termination of service, a participant may receive the value of the vested interest in his or her account in the form of a lump-sum distribution or installments. In the event the participant's account does not exceed \$1,000, the Plan Administrator will automatically distribute the balance without the participant's consent. Participants with account balances greater than \$1,000 but less than \$5,000 will receive a lump-sum distribution that is automatically rolled into an IRA for the benefit of the former participant.

The Plan allows for in-service distributions in the event of financial hardship as defined by the Plan or upon the attainment of age 59½.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

The Plan's mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value of the collective trust is determined by using net asset value (NAV) as a practical expedient based on the fair value of the underlying assets. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net Appreciation in Fair Value of Investments

Net appreciation (depreciation) in the fair value of investments represents the net realized gains (losses) and the net unrealized appreciation (depreciation) of investments. Realized gains and losses are the difference between the proceeds and either the cost of investments sold determined on an average cost basis, or fair value at the end of the previous year, whichever is applicable. Net unrealized appreciation (depreciation) is the change in the difference between fair market value and the cost of investments or the fair value at the end of the previous year, whichever is applicable.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Plan Sponsor, as provided by the Plan document. Expenses that are paid directly by the Plan Sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. Investment related expenses are included in net appreciation of fair value of investments.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Estimates also affect the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Subsequent Events

The Plan has evaluated subsequent events for recognition or disclosure through October 8, 2025, the date the financial statements were available to be issued. Effective January 1, 2025, new participants will be automatically enrolled in the Plan at a contribution rate equal to 3% of the participants' eligible compensation. The Plan is not aware of any additional subsequent events which would require recognition or disclosure in the financial statements.

- Net investment income reported on the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets,
- Quoted prices for identical or similar assets or liabilities in inactive markets,
- Inputs other than quoted prices that are observable for the asset or liability, and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open ended mutual funds. These funds are required to publish their daily NAV and transact at that price. The mutual funds are deemed actively traded.

Collective Trust Funds

Valued using the NAV, as provided by the trustee, as a practical expedient to fair value of the shares held by the plan at year-end. The NAV is based on the fair value of the underlying investments held by the funds less their liabilities.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

NOTE F - TAX STATUS

The IRS has determined and informed the Company by a letter dated July 7, 2010, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of a collective trust fund are managed by OneAmerica, the recordkeeper as defined by the Plan. In addition, Matrix Trust Company was the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Some fees charged by the Plan for investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing. In addition, the Plan paid certain expenses related to the Plan operations and investment activity to the third-party administrator and other service providers. These transactions are party-in-interest transactions under ERISA. The Company has been designated the Plan Administrator. These services are provided at no expense to the Plan.

NOTE H - EXCESS CONTRIBUTIONS PAYABLE TO PARTICIPANTS

At December 31, 2024 and 2023, the Plan recorded a liability for amounts payable to participants for contributions made in excess of amounts allowed by the IRS of \$1,120,219 and \$1,459,321, respectively.
