Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Family Guidance Centers, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 - Plan Description

The following description of Family Guidance Centers, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a contributory profit-sharing plan and a 401(k) savings plan covering all eligible employees of Family Guidance Centers, Inc. and Comprehensive Management Inc. (collectively, the "Organization"). Any employee who is a citizen or resident of the United States of America, has attained the age of 18, and has completed three months of service is eligible to participate on the first day of the month coinciding with or next following the date on which the preceding requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to contribute an amount to the Plan through 401(k) reductions of their earnings. These contributions are made out of pretax earnings and are subject to limitations established by the Internal Revenue Code. A participant's earnings consist of wages and other compensation in a plan year, not to exceed current Internal Revenue Service (IRS) regulations. Participants may also make after-tax Roth 401(k) contributions to the Plan and rollover contributions from another qualified plan. Participants who attained age 50 before the end of the year were eligible to make catch-up contributions.

The Organization may elect to make a discretionary matching contribution of up to 100 percent of the participant's contribution, not to exceed 10 percent of the employee's deferred compensation. In 2024 and 2023, the employer made discretionary matching contributions of 25 percent of the employee's deferrals.

The employer may also make a discretionary profit-sharing contribution. All participants are eligible to receive the discretionary profit-sharing contribution if they are employed on the last day of the plan year. The discretionary profit-sharing contribution is allocated to eligible participants in proportion to their compensation for the plan year. There was no discretionary profit-sharing contribution in 2024 or 2023.

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Organization's contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in contributions made by the Organization 20 percent after one year of service and an additional 20 percent per year thereafter until they become fully vested after five years of service.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable are secured by the balance in the participant's account and bear interest at a market rate. Loan terms are not to exceed five years unless the loan is for the purpose of a principal residence. Loan terms for the purchase of a principal residence will be determined at the time of the loan approval.

The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1 percent. Principal and interest are paid ratably through biweekly payroll deductions. A participant may have a maximum of two loans outstanding at any given time.

Benefit Payments

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account.

Note 1 - Plan Description (Continued)

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future organization contributions or to pay administrative expenses of the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Organization's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Charles Schwab Trust Bank (the "Custodian"). Therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

Investments held by the Plan are stated at fair value except as noted below. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

The money market fund and mutual funds are valued based on quoted market prices reported in active markets.

The participant-directed guaranteed investment contract is a group annuity contract held by The Lincoln National Life Insurance Company, which invests in the general assets of the Custodian. The Custodian considers this contract to be fully benefit responsive; however, since there are no specific securities in the Custodian's general accounts related to this contract, contract value is the best estimate of fair value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Benefit Payments

Benefits are recorded when paid.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Note 2 - Summary of Significant Accounting Policies (Continued)

Administrative Expenses

Various administrative costs are paid by the Organization.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 6, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

The Custodian holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodian.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

Note 4 - Fair Value Measurements (Continued)

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Note 5 - Investment Contracts

At December 31, 2024 and 2023, the Plan has a benefit-responsive investment contract with The Lincoln National Life Insurance Company. The Custodian maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a quarterly basis for resetting but may not be less than 1 percent. When establishing interest crediting rates for this product, the Custodian considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

Note 6 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.
