Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of The Korea Daily 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of The Korea Daily 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Note 1 – Description of Plan

The following description of The Korea Daily 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - Joong Ang Daily News California, Inc. (the “Company” or “Plan Sponsor”) established the Plan effective January 1, 2006. The Plan is a defined contribution plan covering all employees of the Joong Ang Daily News California, Inc., and all other related affiliates, who are age twenty one or older. Plan entrance dates are the first business day of semi-annual entry date (the first day of the Plan Year and the first day of the seventh month of the Plan Year). The Board of Directors of the Company is responsible for administration and management of the Plan. All investments of the Plan are participant-directed. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contribution - Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan and subject to certain limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan includes provisions for discretionary matching contributions as well as discretionary profit-sharing contributions. To be eligible for profit sharing contributions, participants must have completed 1,000 hours of service and be employed as of the last day of the Plan year.

No profit sharing contributions were approved for the Plan year ending December 31, 2024. Employer contributions made for the Plan year ending December 31, 2024 was \$45,797. Contributions are subject to certain limitations. Plan participants direct the investment of their contributions and the employer matching contribution and profit sharing contributions into the various investment options offered by the Plan.

Participant Accounts - Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Forfeited balances of terminated participants’ non-vested accounts are used to supplement future employer matching and profit sharing contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts, plus earnings thereon, is 100% following five years of continuous service.

Payment of Benefits - On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. Hardship and in-service distributions are also permitted provided certain eligibility requirements are met. The Plan allows for a mandatory cash-out of terminated participant balances of \$1,000 or less.

Participant Loans - Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum of the lesser of \$50,000 or 50% of their vested account balances. The loans are secured by the participant's account, bear a reasonable rate of interest, and have a defined repayment schedule. Principal and interest are paid through payroll deductions.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Administrative and Investment Management Expenses - Record keeping and custodial fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan. All other expenses of the Plan are paid by the Plan sponsor.

Forfeited Accounts - Forfeitures of non-vested amounts will be used first to pay any administrative expenses. Any remaining forfeitures will be used to reduce any employer contribution. There were \$747 and \$8,533 in forfeited accounts available as of December 31, 2024 and 2023, respectively.

Note 2 – Summary of Significant Accounting Policies

The accounting and reporting policies of the Plan conform to accounting principles generally accepted in the United States of America (US GAAP).

Accounting Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Basis of Accounting - The financial statements of the Plan are prepared on the accrual method of accounting.

Investment Valuation - All investments are carried at fair value or an approximation of fair value. Quoted market prices are used to value investments and shares of mutual funds are valued at the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Payment of Benefits - The Plan does not accrue non-distributed benefits related to participants who have withdrawn from the Plan, but recognizes such benefits as a deduction from net assets in the period in which such benefits are paid.

Plan Administrative Expenses - Administrative costs of the plan is absorbed by the employer and the plan.

Termination of the Plan - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 3 – Unaudited Information – Certified Investments and Notes Receivable from Participants

Substantially all information pertaining to the Plan's investments included in the financial statements, including all the associated investment income (loss) were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by American United Life Insurance Company. These information have not been audited by the independent auditors.

In accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, information certified by the trustee of the Plan regarding the current value of assets held at December 31, 2024 and 2023 and for the year ended December 31, 2024. Investment transactions entered into during the respective years were used in the preparation of the accompanying financial statements.

Note 4 – Fair Value Measurements

ASC 820-10 establishes a framework for measuring fair value as it related to financial assets and liabilities and to non-financial assets and liabilities measured at fair value on a recurring basis. Such framework provides fair value three-level valuation hierarchy based on upon observable and unobservable inputs with preference given to observable inputs.

The three levels of the fair value hierarchy are defined as follows:

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets.

Level 2 - Significant other observable inputs other than Level 1 prices such as quoted prices in markets that are not active, quoted prices for similar assets, or other inputs that are observable, either directly or indirectly, for substantially the full term of the asset.

Level 3 - Significant unobservable inputs that reflect a reporting entity's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

Note 4 – Fair Value Measurements (Continued)

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Fixed Option Accounts: The contract values of participation units held in the fixed option accounts are based on the principal invested plus interest earned. It is in the trustee’s opinion that the contract value consists entirely of Level 2 inputs and is an appropriate determination of fair value of the Fixed Option Accounts. It seeks to maintain a return similar to a short term bond fund with a risk profile similar to a money market fund and is designed for use as a constant value investment option.

Note 5 – Income Tax Status

The Plan document is an IRS approved prototype plan. The Prototype plan has received a latest opinion letter from the Internal Revenue Service. The Plan administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The related trust was tax exempt as of December 31, 2024.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

Note 6 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 7 – Party-In-Interest Transactions

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain Plan investments in fixed option accounts are managed by American United Life Insurance Company, the custodian of the Plan. Purchases and sales of these funds are performed in the open market at fair value and qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. Notes receivable from participants held by the Plan are considered party-in-interest transactions.

Note 8 – Subsequent Events

Plan management has evaluated all subsequent events to the statements of net assets available for benefits date of December 31, 2024 through the date that the financial statements were available to be issued on October 3, 2025.
