## INDEPENDENT AUDITORS' REPORT

To the Participants and Plan Administrator of

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors’ Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan’s internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

#### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## Notes to Financial Statements

December 31, 2024 and 2023

---

### NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Wood 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document and related amendments for a more complete description of the Plan’s provisions.

#### General

The Wood 401(k) Plan is a multiple employer defined contribution plan established January 1, 1999 to provide retirement and other related profit sharing benefits to the employees of the following employers related through common ownership (collectively, the “Employers”):

Wood Group U.S. Holdings, Inc. is the Plan sponsor, however that Company has no employees. The Plan was established for the exclusive benefit of participating employees and their beneficiaries. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and related rules and regulations.

During 2024, Wood Group U.S. Holdings, Inc. sold CEC Controls Company, Inc. All participants of this company, \$54,545,273 of assets, were transferred to another qualifying plan.

#### Eligibility

Employees are eligible to participate in the Plan on their date of hire.

#### Contributions

Participants may make pretax or Roth contributions ranging from 1 percent to 100 percent of their earnings as elective contributions up to the limits prescribed by the Internal Revenue Service (“IRS”). The Plan also allows participants who are 50 years old or older to make catch-up contributions up to the limits prescribed by the IRS. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants can change their contribution percentages at any time and those changes will be effective as soon as administratively feasible.

The Plan has elected a safe harbor matching contribution that matches 100 percent of the first 5 percent of salary deferrals, up to 5 percent of eligible compensation.

## **NOTE 1 – DESCRIPTION OF THE PLAN (CONTINUED)**

### Participant Accounts

Each participant's account is credited with the participant's contributions, Employers' contributions, Plan earnings and allocation of administrative expenses. Allocations are based on participant account balances, except administrative expenses which are allocated evenly among the active participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately 100% vested in qualified employer matching contributions.

### Notes Receivable from Participants

The Plan allows for notes receivable from participants, subject to the provisions as set forth in the Plan. The loan amount shall not exceed the lesser of \$50,000 or 50% of the sum of the participant's total vested balance. Interest accrues on the unpaid balance at the prime rate as of the date of borrowing. Principal and interest are paid ratably through payroll deductions in each pay period.

### Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account as a lump sum distribution, installment payments or partial payments. For a termination of employment, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account as a lump sum distribution or rollover. On termination, participants with vested account balances greater than \$1,000 but less than \$5,000 are automatically distributed in accordance with the terms of the Plan.

The Plan also provides for in-service withdrawals by participants who have attained the age of 59 ½. Withdrawals from a participant's accounts may also be made in the event of a financial hardship or under other certain circumstances, in accordance with the provisions specified in the Plan.

### Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$764,452 and \$657,830, respectively. These accounts may be used to reduce future Employers' contributions and pay for administrative expenses. During 2024 and 2023, \$46,841 and \$1,617,311, respectively, of the forfeitures balance were utilized to reduce Employers' contributions, and \$84,838 and \$84,737, respectively, were utilized to reduce administrative expenses.

### Investment Options

Participants in the Plan elect how their participant contributions and employer contributions are to be invested in 1 percent multiples into various investment options offered under the Plan.

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

## NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

### Payment of Benefits

Benefits are recorded when paid.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a deemed distribution benefit payment is recorded.

### Expenses

The Plan is sponsored by the Employers. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employers. Personnel within the Employers perform various administrative services for the Plan, including maintenance of participant records. The payroll and related overhead costs associated with these services are not included as Plan expenses but are paid by the Employers. Expenses that are paid by the Employers are excluded from these financial statements. Expenses paid by the Plan consist of transaction-based fees charged directly to the participant's account, loan origination fees charged directly to the participant's account and Plan administration fees that are included in administrative expenses. Investment related expenses and fees are included in net appreciation/depreciation in fair value of investments.

### Subsequent Events

The Plan has monitored and evaluated subsequent events from December 31, 2024 through October 7, 2025, the date on which financial statements were available to be issued.

## NOTE 3 – FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the input to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

### NOTE 3 – FAIR VALUE MEASUREMENTS (CONTINUED)

#### *Level 1 Fair Value Measurements:*

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. The funds must to publish their daily net asset value (“NAV”) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The fair value of the pooled separate accounts are valued on the observable NAV of the underlying investments, which consist solely of mutual funds.

The fair value of the self-directed brokerage accounts are valued at the closing price on the active market on which the individual securities are traded.

#### *Investments not classified:*

The Plan invests in a common/collective trust fund for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the NAV provided by the trustee as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the common/collective trust fund, the issuer reserves the right to require 12 months’ notification in order to ensure that securities liquidations would be carried out in an orderly business manner. The common/collective trust fund is not required to be classified within a level on the fair value hierarchy. There were no participant redemption restrictions for the common/collective trust fund; the redemption notice period was only applicable to the Plan. As of December 31, 2024, there were no unfunded commitments, daily redemption restrictions and a 12-month redemption notice period.

#### **NOTE 4 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employers have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### **NOTE 5 – TAX STATUS**

The Plan is a proto-type plan. The Internal Revenue Service has informed Empower Trust Company, LLC, (“Empower”), by a letter dated June 30, 2020, that the form of the proto-type plan is acceptable under section 401(a) of the Internal Revenue Code. As such, the Plan is exempt from federal income tax, and amounts contributed by the employers will not be taxed to the participant until the participant receives a qualifying distribution from the Plan. The Plan has been amended since Great-West received the opinion letter, but the Employers believe that the Plan is operating in accordance with the applicable sections of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 6 – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Empower, the trustee, therefore these transactions qualify as party-in-interest. Empower and NFP Retirement Inc. perform certain administrative advisory and recordkeeping services for the Plan. For the year ended December 31, 2024, Empower and NFP Retirement Inc. were paid \$521,137 and \$74,990 respectively, for these services. For the year ended December 31, 2023, Empower and NFP Retirement Inc. were paid \$527,307 and \$99,972, respectively, for these services. For the years ended December 31, 2024 and 2023, fees paid to other related parties-in-interest for investment management and administration were \$586,835 and \$596,014, respectively.

The Plan provides for loans to participants. Transactions in such investments qualify as party-in-interest transactions as defined by ERISA.

#### **NOTE 7 – CERTIFIED INVESTMENTS**

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower, the trustee of the Plan

#### **NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan provides for various investment options. The underlying investments held by the registered investment companies may include stocks, bonds, fixed income securities and other investment securities. Such investments are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant’s account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
