We have performed an audit of the financial statements of NexGen Data Systems 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Notes to Financial Statements

1. Description of the Plan

The following brief description of the NexGen Data Systems 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution plan and was originally adopted by NexGen Data Systems, Inc. (the Company) effective January 1, 2007, and with the latest restatement on January 1, 2021, to provide deferred tax benefits to eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

The Plan covers all employees of the Company, except collectively bargained employees and non-resident aliens. Employees must be 21 years of age and have 500 hours of service within 6 months following their date of hire or 1,000 hours and one year of service to be eligible for the Plan. Eligible Participants may enter the Plan immediately after satisfactory completion of the requirements listed above. Long-term part-time employees who met eligibility requirements under SECURE 2.0 Act of 2022 are also eligible to participate in the Plan.

Contributions

Eligible employees may elect to contribute, on a pretax or post-tax basis, up to 100% of their eligible compensation to the Plan, not to exceed the limit under the Internal Revenue Code (IRC). In addition, employees who are age 50 or older are permitted to make additional contributions of up to the maximum allowed by the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company provides for a safe harbor matching contributions equal to 100% of salary deferrals up to 6% of the Participant's eligible annual compensation. The Company may make a discretionary matching contribution to the Plan as well. Discretionary employer matching contribution amounts are based on a percentage of a Participant's elective deferrals. The Company had discretionary matching contributions of \$445,216 for the year ended December 31, 2024.

The Company may also make additional discretionary employer profit-sharing contributions. Discretionary employer profit-sharing contributions are determined by the Company. The Company did not make any discretionary employer profit-sharing contributions for the year ended December 31, 2024.

Participant Accounts

Each Participant's account is credited with the Participant's contributions and allocations of the Company's contributions and Plan earnings (losses). Allocations are based on Participant compensation, deferrals or account balances, as defined. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account balance.

Notes to Financial Statements

1. Description of the Plan (cont.)

Vesting

Participants are vested immediately in their elective deferrals, catch-up contributions and Company safe harbor contributions plus actual earnings thereon.

Vesting in the Company's matching and discretionary profit-sharing contribution portion of their accounts is based on years of continuous service as follows:

Payment of Benefits

Participant accounts may be withdrawn upon retirement, death, disability, attainment of age 59½ or termination of employment as a lump sum or in the form of installments as specified in the Plan. If a terminated Participant's vested balance is less than or equal to \$7,000, the amount may be automatically distributed in the form of rollover to an individual retirement account designated by the Company. The Plan also allows for in-service withdrawals at age 59½ or when the Participant has reached the Plan's normal retirement age. In certain circumstances in-service withdrawals are also allowed in the event of a financial hardship.

Notes Receivable from Participants

A Participant may borrow the lesser of \$50,000 or 50% of his or her vested account balance. Loans are secured by the Participant's account balance. If a Participant ceases to make loan repayments and the Plan administrator deems the Participant loan to be in default, the Participant loan balance is reduced, and a benefit payment is recorded. Interest rates on all outstanding loans as of December 31, 2024 range from 4.25% to 9.50%. Principal and interest are repaid ratably through regular payroll deductions over a period not to exceed five years, unless the notes receivable were used to purchase a primary residence in which case the note receivable terms may exceed five years.

Forfeitures

The Plan allows for forfeited non-vested accounts to be used to reduce future Company contributions or pay certain Plan expenses. Forfeitures of \$81,621 were used during the year ended December 31, 2024, to offset Company matching contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$71,832 and \$79,026, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan were prepared using the accrual basis of accounting. The Plan follows accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets accounting principles generally accepted in the United States of America (GAAP).

2. Summary of Significant Accounting Policies (cont.)

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income (Loss) Recognition

The investments of the Plan are reported at fair value with the exception of the fully benefit-responsive investment contract which is valued at contract value. Contract value is the relevant measurement for that portion of the net assets available for benefits because contract value is the amount Participants would normally receive if they initiate permitted transactions under the terms of the Plan.

The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market Participants at the measurement date (the exit price). The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company.

Purchases and sales are recorded on a trade-date basis. Interest is recorded when earned and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan Participants and the contributions from the Company are recorded in the year in which the contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from Participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a Participant ceases to make loan repayments and the Plan administrator deems the Participant loan to be in default, the Participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefit payments to Participants are recorded upon distribution.

Plan Expenses

Certain administrative expenses related to distributions and other Participant-initiated transactions are charged to the account of the Plan Participant. Other administrative expenses and investment management fees are paid from the Plan's forfeitures and through reductions of investment returns under the Plan's investment options.

3. Certified Information

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Empower Annuity Insurance Company of America (EAIC) and Empower Trust Company, LLC (ETC) (collectively, "Empower"), the Custodian of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from Participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from Participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

4. Investment Contract with Insurance Company

The Plan holds a fully benefit-responsive guaranteed investment contract with EAIC, originally issued by Talcott Resolution Life Insurance Company (Talcott). EAIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for Participant withdrawals and administrative expenses. The guaranteed interest account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula agreed upon with the issuer, but it may not be less than three percent. The credit rate is reviewed on a semi-annual basis for resetting. The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest is based on a formula agreed upon with the issuer but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value. Such events include the following: amendments to the Plan documents, changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with Plan Participants, is probable.

5. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs in which little or no market data exists (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described below:

Basis of Fair Value Measurement

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

Basis of Fair Value Measurement (cont.)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds - Valued at the quoted market prices of shares held by the Plan at year-end. The fair values of these investments are determined by reference to the fund's underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds traded on national securities exchanges are valued at the net asset value (NAV) as of December 31, 2024 and 2023. It is not probable that the mutual funds will be sold at amounts that differ materially from the NAV of shares held.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market Participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Tax Status

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA (Pre-Approved Plan) sponsored by Spectrum Retirement Services Corporation. The Internal Revenue Service (IRS) has opined and informed Spectrum Retirement Services Corporation by a letter dated June 30, 2020, stating that the form of the document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the Pre-Approved Plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate the tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, Participants would become 100% vested in their Company contributions.

8. Related Parties and Party-In-Interest Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company, and certain others. The Plan invests in a guaranteed interest account provided by Empower. Empower is the Custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Various administrative expenses of the Plan are paid directly by the Company. Notes receivable from Participants are defined by ERISA as party-in-interest transactions. Such transactions are exempt from the prohibited transaction rules.

9. Risks and Uncertainties

The Plan's investments include funds which invest in various types of investment securities and in various companies within various markets. Investment securities are exposed to several risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

10. Delinquent Participant Contributions

During 2024, employee withholdings of \$1,839 were not remitted within the appropriate time period by the Company. These transactions constituted prohibited transactions as defined by ERISA. The Plan sponsor remitted this contribution to the Plan in 2025 and plans to remit the lost earnings during 2025. The Employer has elected to correct the contributions and lost earnings but not to do so through the Voluntary Fiduciary Correction Program (VFCP) given the immateriality of the amounts.

11. SECURE 2.0 Act of 2022

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act of 2022 did not have a material effect on the Plan's financial statements.

12. Subsequent Events

The Plan has evaluated, for consideration of recognition or disclosure, subsequent events that have occurred through the date of issuance, October 06, 2025, and has determined that no significant events occurred after December 31, 2024, but prior to the issuance of these financial statements, that would have a material impact on these financial statements.
