Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Hennebery Eddy Architects, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTES TO FINANCIAL STATEMENTS

1. Plan Description

The following description of Hennebery Eddy Architects, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of the Plan's provisions. The most recent restatement of the Plan is effective November 8, 2021. The trustees and Plan administrator oversee the governance of the plan.

General

The Plan is a defined contribution plan covering substantially all employees, except union employees, of Hennebery Eddy Architects, Inc. 401(k) Plan (the Employer). The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Employer is the Plan's sponsor and serves as Plan Administrator. Eligible participants enter the Plan immediately. There are no age or service requirements to participate in the Plan.

Contributions

Participant Contributions – Each year, participants may contribute up to 100 percent of annual compensation on a pre-tax or Roth (after-tax) basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans or individual retirement accounts. The Plan includes an automatic enrollment provision whereby newly eligible participants are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5 percent of eligible compensation, which increases automatically by 1 percent annually up to 10 percent.

Safe Harbor Contributions – The Employer makes a required Safe Harbor contribution equal to 3 percent of participant eligible compensation. Participants are eligible for Safe Harbor matching immediately upon hire. The safe harbor contribution for the year ended December 31, 2024 was \$339,358.

Profit Sharing Contributions – The Employer may make discretionary contributions allocated on an employee-by-employee basis in amounts determined by the Employer. Participants must be employed as of the last day of the Plan year with over 1,000 hours to be eligible to receive any employer paid profit sharing contributions, except in the event of death, disability, or retirement. The plan made discretionary contributions for the year ended December 31, 2024 of \$602,266.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer's contributions, and earnings (losses) on the participant's account balances. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

1. Plan Description, continued

Vesting

Participants are vested immediately in their participant and Employer safe harbor contributions plus actual earnings thereon. Vesting in the Employer's profit-sharing contribution portion of their accounts is based on years of continuous service. Participant is considered to be 100 percent vested in instances of death, disability, or retirement. Participants vest in the Employer's profit-sharing contributions are based on the following schedule:

Payment of Benefits

Upon retirement, disability, death, or termination of employment, a participant may elect to receive the value of the participant's vested interest in his or her account in a lump-sum, installments, or a life annuity, or roll it over to another qualified plan. The Plan allows in-service distributions after a participant has reached age 59 1/2, as defined by the Plan. The Plan allows hardship distributions from elective deferral balances. Participants may also withdraw funds from rollover contributions at any time. In 2024, the Plan elected to allow for domestic abuse victim withdrawals, terminal illness penalty exception requests, qualified disaster relief withdrawals and increased the mandatory force-out distribution limit from \$5,000 to \$7,000 under SECURE Act 2.0.

Forfeitures

The non-vested account of a participant will be forfeited if a participant is terminated. Nonvested accounts forfeited during the year ended December 31, 2024 totaled \$13,409. Forfeited accounts can be used to reduce employer profit share contribution or pay administrative expenses. At December 31, 2024 and 2023, unused forfeited accounts totaled \$299 and \$270, respectively. Forfeitures of \$13,473 were used to offset employer contributions for the year ended December 31, 2024.

Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Loan terms range from 1 to 5 years or up to or up to 15 years for the purchase of a principal residence. The loans are secured by the vested balance in the participant's account and bear an interest rate at 1 percent plus the prime rate. Principal and interest installments are paid ratably through deductions. Participants may have no more than three loans outstanding with the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Contributions

Participant contributions, employer safe harbor and profit-sharing contributions are recorded in the year in which the underlying compensation is paid.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit responsive investment contract which is reported at contract value. See Note 5 for a discussion of investments at contract value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 7 for a discussion of fair value measurements.

Interest and dividend income are recorded on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administration Expenses and Fees

Plan administrative expenses, excluding certain transaction fees and quarterly asset fees paid by the Plan from Plan assets, are paid by the Employer or may be paid from participant forfeitures. Expenses paid by the Employer are excluded from these financial statements. Investment related expenses are included in, or as a reduction from, investment income. Quarterly asset and transaction fees associated with distributions are included in administrative expenses and charged directly to the participant's account.

Revenue Sharing

The plan contains a revenue sharing expense offset arrangement where the Plan is credited a monthly amount based on a percentage of plan assets which is used to pay investment advisory expenses. For the year ended December 31, 2024, \$38,672 was credited to the account and used to pay investment advisory expenses. There was no balance in the Plan's revenue sharing account as of December 31, 2024.

3. Information Certified by the Trustees

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America (EAICA) and Empower Trust Company, LLC, acting as the trustees for the Plan, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate as of and for the year ended December 31, 2024:

4. Tax Status

The Plan is a nonstandardized pre-approved profit sharing plan with CODA. Empower Retirement LLC, the sponsor of the pre-approved plan, has received an opinion letter from the Internal Revenue Service (IRS) dated November 14, 2022, that the basic Plan document satisfies Internal Revenue Code (IRC) Section 401. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

5. Investment Contract

The Plan's fixed account investment option is provided through a fixed annuity contract with Empower Annuity Insurance Company of America classified as a general insurance contract. Under the terms of the contract, a crediting rate is established for amounts invested in the fixed account. Participants may direct permitted withdrawals and/or transfer transactions of all or a portion of their account balance at contract value. Contract value represents contributions plus credited interest less participant withdrawal and fees. The fixed account investment option is considered fully benefit responsive notwithstanding the liquidation value events under the contract that limit the ability of the Plan to transact at contract value. The declared interest rate as of December 31, 2024 and 2023 was 1.41 percent and 1.23 percent, respectively.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to their fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: The Plan's investments are units of mutual funds held within a group annuity contract valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and considered to have a readily determinable fair value.

Pooled separate accounts: Recorded at fair value based on the stated net asset value (NAV) of the separate account, which is used as a practical expedient to estimate fair value. Participant transactions may occur daily at NAV. Pursuant to Accounting Standards Update (ASU) 2015-07, Fair Value Measurements, the pooled separate accounts measured at NAV have not been classified in the fair value hierarchy. All pooled separate account investments held by the Plan are held within a group annuity contract and have no unfunded commitments, and the investments may be redeemed by participants on a daily basis with no required notice period.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain Plan Investments are maintained and managed by the custodians of the Plan, and therefore these transactions qualified as party-in-interest transactions. Administrative fees paid to Empower Annuity Insurance Company of America for 2024 totaled \$32,371. Additionally, investment management fees paid to Empower Advisory Group, LLC, an affiliate of the custodian, totaled \$3,110. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

9. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of full or partial Plan termination, affected participants would become 100 percent vested in their Employer contributions.
