Note A – Description of Plan

The following description of the ConnectWise, LLC. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution safe harbor plan covering all employees of ConnectWise, LLC. (the “Company” or “Employer”). The Plan was formed on January 1, 2010 and last restated on April 18, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Employees become eligible to participate in the Plan and any Employer match when they have completed one month of employment. Eligible employees enter the Plan on the date upon which eligibility requirements are met. Eligible employees may change, on a prospective basis, his salary reduction agreement as of the beginning of each payroll period.

Employees that are not eligible to participate in the Plan are non-resident aliens who do not receive any compensation from U.S. sources, employees covered by a collective bargaining agreement, interns, and independent contractors.

The Company made a safe harbor matching contribution for all eligible participants in an amount equal to 100% of the first 4% of each participants’ eligible compensation.

In September 2024, ConnectWise, LLC. acquired SkyKick, LLC and eFolder, Inc. dba Axcient. As a result of the acquisition, SkyKick, LLC 401(k) Plan and Axcient 401(k) and Profit Sharing Plan were terminated. Effective October 3, 2024, the Plan was amended to include SkyKick, LLC and eFolder, Inc. dba Axcient as participating employers.

Administration

The Plan is administered by the Company. The Plan’s assets for the year were maintained and administered by Fidelity Management Trust Company (the “Trustee”). The Plan’s recordkeeping services and maintenance of participant account records are managed by Fidelity Management Trust Company.

Contributions

Participants may contribute up to 100% of their Compensation subject to the maximum allowed by law imposed by the Internal Revenue Code (“IRC”) Section 401(k) limitations. The maximum participant deferral for the year ended December 31, 2024 was \$23,000. A participant who has attained the age of 50 may also make catch up contributions, subject to Internal Revenue Service (“IRS”) limitations of \$7,500 for the year ended December 31, 2024. The Plan also allows employee after-tax contributions up to 50% of the compensation. Participants may also contribute amounts representing distributions from other qualified plans. Contributions received from participants are net of excess deferral contributions refunded, as required to satisfy the relevant nondiscrimination provisions of the Plan. Participants also have the option to make Roth rollover, but the Plan will not accept rollovers of after-tax participant contributions.

Participants are enrolled automatically upon hire at 4% of eligible compensation. Individuals can opt out of participation using the provider website. Under the terms of the Plan, the Company may make a discretionary matching contribution equal to 100% of the first 4% of salary deferrals per bi-weekly pay period.

Participant Accounts

Each participant's account is credited and/or reduced with the participant's elective referral contributions and distributions, the Company's contributions, and an allocation of the Plan's investment earnings/losses, investment fees and any administrative expenses paid out of the Plan. Allocations are based on participant earnings or account balances, as defined in the Plan.

Vesting

Participants with balances in the Plan are fully vested in their elective contributions, any rollover contributions, as well as matching Employer contributions plus or minus any earnings or losses thereon except as noted below.

Participants who entered the Plan from the Perch Security 401(k) Plan are 100% vested in their frozen ER profit share after 5 years of service as follows:

Notes Receivable from Participants

Participants may borrow from their fund accounts, provided that specific hardship criteria is met, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account, or other acceptable collateral, and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. The maximum note repayment period is five years unless the note is for the purchase of a primary residence in which case the repayment schedule may be for a term in excess of five years. Principal and interest payments with respect to the notes are credited solely to the account of the borrowing participant from which the note was made.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. In the event of default, the unpaid portion of the participant's loan will be treated as a taxable distribution as of the first day of the second calendar quarter following the calendar quarter in which the participant failed to make a required installment payment.

Distribution of Benefits

After age 59 ½, upon termination of service due to death, as a qualified reservist, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, as defined in the Plan agreement, less any applicable taxes. Participants may request a hardship withdrawal for qualifying expenses from their accounts using only participant deferral balances for distribution.

Forfeitures

As all participants are 100% vested in all contributions, the forfeitures account represents undeposited withdrawal balances. Forfeitures occur when terminated participants do not cash distribution checks. Forfeitures may be first utilized to reduce Plan expenses at the discretion of the Company. Any remaining forfeitures are used to reduce the Employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$17,000 and \$17,000, respectively. During the year ended December 31, 2024, the Company used approximately \$2,000 to reduce Plan expenses and Employer contributions.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, each participant's account will become fully vested and non-forfeitable. All appropriate accounting provisions of the Plan will continue to apply until the accounts of all participants have been distributed.

Note B – Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and the changes in net assets available for benefits and disclosure of contingent assets and liabilities during the reporting period. Actual results could differ from these estimates.

Valuation of Investments

The Plan's investments are stated at fair value. Quoted market prices are used to value investments. Shares of money market funds, mutual funds, and common-collective trust are valued at the net asset value ("NAV") of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded at the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Fair Value Measurements

The FASB has established a framework for measuring fair value in ASC 820, *Fair Value Measurements*. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market funds: Valued at amortized cost, which approximates fair value. The amortized cost of an instrument is determined by valuing it at its original cost and thereafter amortizing any discount or premium from its face value at a constant rate until maturity.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note C – Certified Investments

As of December 31, 2024 and 2023, and for the year ended December 31, 2024, the Plan Administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by Fidelity Management Trust Company, except for comparing such information to the related information included in the financial statements, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note D – Income Tax Status

The Plan has received a determination letter from the IRS dated June 30, 2020 for its prototype plan stating that the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is exempt from taxation. Subsequent to the issuance of the determination letter, the Plan was amended and the Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC.

The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements. The Plan is no longer subject to examination by taxing authorities for years prior to 2021.

Note E – Risks and Uncertainties

The Plan provides for various investment options which are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to the changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note F – Party-In-Interest Transactions

Fees paid during the year for accounting and other services rendered by parties-in-interest were based on customary and reasonable rates for such services. Certain Plan investments and the related transactions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, were in investment funds managed by the Trustee; therefore, these investments and transactions qualify as party-in-interest transactions. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants. Fees paid to the parties-in-interest by the Plan for services amounted to approximately \$265,000 during the year ended December 31, 2024.

Note G – Subsequent Events

Subsequent events have been evaluated through September 10, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan was amended to treat qualified student loan repayments as eligible for Employer matching contributions under the SECURE 2.0 Act of 2022.
