Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Geron 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matter

Notes to Financial Statements

Note 1 – The Plan and Its Significant Accounting Policies

General – The following description of the Geron 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan that was established in 1993 by Geron Corporation (the Company) to provide benefits to eligible employees, as defined in the Plan document. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (the Code) and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration – The Company has appointed the 401(k) Committee (the Committee) to manage the operation and administration of the Plan. Prior to July 1, 2023, the Company contracted with Prudential Bank & Trust Company, F.S.B. (Prudential Trust), and Prudential Retirement Insurance and Annuity Company (Prudential) to act as the trustee and custodian. On April 1, 2022, Empower Annuity Insurance Company of America acquired Prudential Financial, Inc., which includes the entities of Prudential Trust and Prudential. In October 2022, Prudential was renamed Empower Annuity Insurance Company (Empower). Effective July 1, 2023, the Plan was amended and restated in conjunction with a change from Prudential and Empower as trustee and custodian to Fidelity Management Trust Company (Fidelity) as trustee and custodian and an affiliate of Fidelity to serve as the recordkeeper to process and maintain the records of participant data. The Company stock is held by Fidelity. Substantially all expenses incurred for administering the Plan are paid by the Plan.

Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Basis of accounting – The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Forfeited accounts – Forfeited nonvested accounts may be used to offset Plan administrative expenses or to reduce future employer contributions.

Investment valuation and income recognition – The investments are reported at fair value and contract value.

Fidelity and Empower certify the contract value of the guaranteed investment contract and the fair market value of all other investments as of December 31, 2024 and 2023. If available, quoted market prices are used to value investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought or sold as well as held during the year.

Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Contributions – Contributions from participants and corresponding matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants – Notes receivable from participants (notes receivable) are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions upon the occurrence of a distributable event based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payments of benefits – Benefits are recorded when paid.

Expenses – Administrative expenses paid by the Plan may include notes receivable and distribution fees charged to participants' accounts and administrative Plan fees. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

Income taxes – The Plan has adopted a pre-approved plan document that received a favorable opinion letter from the Internal Revenue Service on December 4, 2020, which stated that the plan, as then designed, was in accordance with applicable sections of the Code. Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes (ASC 740-10), management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Risks and uncertainties – The Plan provides for various investment options, including Company stock. Investment securities are exposed to various risks, such as interest rate risks, market fluctuations, and credit risks. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates, or other factors in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Subsequent events – The Plan has evaluated subsequent events through October 7, 2025, which is the date the financial statements were available to be issued.

Note 2 – Fair Value Measurements

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology are measured using the market approach and include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common stock – Valued at the closing price reported on the active market on which the individual securities are traded.

Mutual funds and money market fund – Valued at the daily closing price as reported by the fund. Mutual funds and the money market fund held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 3 – Guaranteed Income Fund

The Plan has a fully benefit-responsive insurance company issued general account backed evergreen (no maturity date) group annuity contract with Empower known as the Guaranteed Income Fund (the GIF). Empower maintains the contributions in a general account. Under the group annuity insurance contract that supports the GIF, participants may ordinarily direct permitted withdrawals or transfers of all or a portion of their account balance at contract value within reasonable time frames. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single “portfolio rate” approach. Under this methodology, a single interest crediting rate is applied to all contributions made to the investment regardless of the timing of those contributions. Interest crediting rates are reviewed on a semi-annual basis for resetting. When establishing the interest crediting rates for the GIF, Empower considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account. These rates are established without the use of a specific formula. The minimum crediting rate under the contract is 1.5%.

Generally, there are not any events that allow the issuer to terminate the contract, and which require the Plan to settle at an amount different than the contract value paid either within 90 days or over time. There is no market value adjustment upon discontinuance.

Note 4 – Related-Party Transactions

Certain Plan investments are managed by Fidelity, Prudential and Empower. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

As allowed by the Plan, the Company may elect to make discretionary matching contributions in the form of Company common stock (Note 7).

Note 5 – Participation and Benefits

Participant contributions – Participants may elect to have the Company contribute their eligible pre-tax and after-tax compensation (as Roth contributions) to the Plan up to the amount allowable under the Plan document and current income tax regulations. Participants who elect to have the Company contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable or taxed compensation. Contributions withheld are invested in accordance with the participant's direction.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions.

Employer contributions – The Company is allowed to make discretionary matching contributions as defined in the Plan and as approved by the Board of Directors. A participant must be employed on the last day of the Plan year to be eligible for a matching contribution. In 2024 and 2023, the Company matched 50% of each eligible participant's annual contribution up to \$10,000 per employee or \$13,000 for any employee who is eligible to make catch-up contributions to the Plan up to a maximum of \$13,000. The Company's matching contribution for the years ended December 31, 2024 and 2023, was \$1,668,582 and \$1,093,683, respectively, which the Company paid in cash.

The Plan also allows for a discretionary nonelective contribution. A participant must have at least 1,000 hours of service during the year and be employed on the last day of the Plan year in order to be eligible for a discretionary nonelective contribution. No discretionary nonelective contribution has been made for the years ended December 31, 2024 and 2023.

Vesting – Participants are immediately vested in their contributions and the employer's discretionary contributions allocated to their account.

Participant accounts – Each participant's account is credited with the participant's contributions, earnings or losses, and an allocation of the Company's discretionary contributions, if any. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Payment of benefits – Upon termination, the participants or beneficiaries may elect to leave their account balance in the Plan or receive their total benefits in a lump sum amount, partial payments, or in installments equal to the value of the participant’s interest in their account. The Plan allows for the automatic distribution of a participant’s account balance that does not exceed \$5,000.

Notes receivable from participants – The Plan allows participants to borrow up to the lesser of \$50,000 or 50% of their vested account balance. The notes receivable are secured by the participant’s account balance. Such notes receivable bear interest at the available market financing rates and must be repaid to the Plan within a five-year period, unless the proceeds are used for the purchase of a principal residence in which case the maximum repayment period may be longer. The specific terms and conditions of such notes receivable are established by the Committee. The outstanding note receivable at December 31, 2024, bears interest rates ranging from 8.75% to 9.5% with maturity dates through January 2030.

Note 6 – Certified Investment Information

The following information related to investments was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust and Empower, qualified institutions:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net realized and unrealized appreciation in fair value of investments, dividends and interest, and interest income from the notes receivable, reflected on the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investments reflected on the schedule of assets (held at end of year) as of December 31, 2024.

Note 7 – Nonparticipant-Directed Investments

Employer contributions may be allocated to participant accounts in Company stock (Note 4). Participants may direct such contributions to other investments after they have been allocated. The number of shares of common stock in the Geron Corporation Stock Fund (the Fund) was 278,098 and 348,051 shares as of December 31, 2024 and 2023, respectively. The Fund is largely composed of Company common stock with a fair value of \$985,545 and \$735,413 at December 31, 2024 and 2023, respectively, using the closing share price of \$3.54 and \$2.11 at December 31, 2024 and 2023, respectively.
