As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 31, 2024 and 2023, and for the year ended August 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate to the best of their knowledge.

### Opinion

As discussed in Notes 1 and 7 to the financial statements, the Plan Sponsor of the Plan issued a formal request to terminate the plan on May 14, 2024, with an effective date of May 31, 2024. Management determined liquidation was imminent as of May 14, 2024. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the August 31, 2023, financial statements to the liquidation basis used in presenting the August 31, 2024, financial statements. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

### Notes to Financial Statements

---

#### Note 1. Plan Description

The following description of the Profit Sharing Plan and Trust Agreement of Wade Manufacturing Company (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a noncontributory defined contribution plan sponsored by Wade Manufacturing Company (the Plan Sponsor or the Company) covering all employees of the Plan Sponsor who have been credited with 1,000 hours of service in the preceding 12 months of the Plan and are at least 18 years old. The Board of Trustees is responsible for oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Trustees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On May 14, 2024, the Plan Sponsor issued a formal plan termination request to terminate the Plan effective May 31, 2024.

**Contributions:** The Company makes annual profit sharing contributions to the Plan in discretionary amounts as determined by the Company's Board of Trustees. The profit sharing contributions to the Plan are not to exceed the greater of 15% of compensation paid during the year to all participating employees or the amount deductible for income tax purposes. Profit sharing contributions are recognized upon authorization by the Board of Trustees in the plan year that the profit sharing contribution relates to. Participant contributions are not permitted, but rollover contributions from other qualified plans are allowed. There were no profit sharing contributions to the Plan for the year ended August 31, 2024.

**Investment options:** Upon enrollment in the Plan, participants may direct the Company's profit sharing contributions into various investment options. All investments are held by Voya Retirement Insurance and Annuity Company (Voya). Participants may change their investment options daily.

**Participant accounts:** Each participant's account is credited with allocations of any profit sharing contribution and Plan earnings/losses and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their rollover contributions and earnings thereon. Participants are vested in the Company profit sharing contributions, forfeitures and earnings thereon based on years of service (1,000 hours are required for a year of service). The participant is 0% vested until three years of service and is then 100% vested after three years of service. Upon the decision to terminate the Plan, all participants became fully vested in their benefits.

**Payment of benefits:** Prior to the decision to terminate, the Plan permitted withdrawals when a participant terminated employment, retired or became disabled or deceased. Benefits were payable in lump-sum payments or annual installments with certain exceptions. Through August 31, 2024, final distributions to participants were processed as part of the Plan termination totaling approximately \$7.6 million.

**Forfeitures:** Forfeitures are allocated to participants as an additional contribution based on account balance. Forfeited nonvested accounts totaled \$0 and \$1,122 at August 31, 2024 and 2023, respectively. During the year ended August 31, 2024, \$1,203 of forfeitures were allocated to participants.

**Notes receivable from participants:** Prior to the decision to terminate the Plan, participants could borrow from their accounts a minimum of \$1,000 up to a maximum of the minimum of: (1) 50% of vested balance or (2) \$50,000 reduced by the excess of highest loan balance during the 12-month period ending on the date of the loan over the participant's current outstanding loan balance on the date of the loan. Loan terms ranged up to 57 months or over a reasonable period of time for the purchase of a participant's primary residence, as established by the Plan Administrator at the time of the loan. The loans were collateralized by the vested balance in the participant's account and bore interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Principal and interest were paid ratably through payroll deductions. As a result of the Plan's termination, all unpaid loans were deemed distributed by the Plan Administrator and recorded as benefit payments in the year ended August 31, 2024.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** Due to the decision in May 2024 to terminate the Plan, management determined that liquidation of the Plan was imminent and the August 31, 2024, financial statements have been prepared using the liquidation basis of accounting. The August 31, 2023, financial statements were prepared on the going concern basis using the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value) as of August 31, 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments at August 31, 2024, are reported at liquidation value due to the Plan termination discussed at Note 7. Fair value approximates liquidation value. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully-benefit responsive investment contracts. Contract value is the relevant measurement for the portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate a permitted transaction under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the liquidation basis, including amounts expected to be earned through the final liquidation. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan's participants invest in various investment securities offered by the Plan. These investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make the scheduled repayments and the Plan Administrator deems the participant to be in default, the participant's note receivable is reduced, and a benefit payment is recorded based on the terms of the Plan. No allowance for credit losses has been recorded as of August 31, 2024 and 2023.

**Payment of benefits:** Benefits are recorded when paid. Through August 31, 2024, final distributions to participants were processed as part of the Plan termination totaling approximately \$7.6 million.

**Expenses:** Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment-related expenses are included in net appreciation of fair value of investments.

**Adoption of accounting pronouncement:** In April 2013, the Financial Accounting Standards Board (FASB) issued Accounting Standards Update 2013-07, *Presentation of Financial Statements (Topic 205): Liquidation Basis of Accounting*. This Update requires an entity to prepare its financial statements using the liquidation basis of accounting when liquidation is imminent. The Update requires disclosures about an entity's plan for liquidation, the methods and significant assumptions used to measure assets and liabilities, the type and amount of costs and income accrued, and the expected duration of the liquidation process. The amendment is effective for entities that determine liquidation is imminent during annual reporting periods beginning after December 15, 2013, and interim reporting periods therein. Entities should apply the requirements prospectively from the day that liquidation becomes imminent. As the Plan liquidation was determined to be imminent effective May 14, 2024, the Plan adopted this Update for the plan year ended August 31, 2024, and the impact of adopting this Update is reflected throughout the August 31, 2024, financial statements.

**Subsequent events:** The Plan has evaluated its subsequent events (events occurring after August 31, 2024) through October 6, 2025, the date on which the financial statements were available to be issued.

Voya also certified to the completeness and accuracy of \$440,079 of net appreciation in fair value of investments and \$108,720 of interest and dividends related to the aforementioned plan assets for the year ended August 31, 2024.

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at August 31, 2024 and 2023.

**Pooled separate accounts:** Valued at the net asset value (NAV) of shares in each account held by the Plan at year-end. The NAV is not a publicly quoted price in an active market. The NAV, as provided by the insurance carrier, is used as a practical expedient to estimate fair value.

In accordance with the Fair Value Measurements topic, investments that were measured at NAV per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy.

- (g) Mid cap growth funds are pooled investments, such as a mutual fund, focusing on companies with market capitalization in the middle range of listed stocks.
- (h) Money market fund primarily invests in government securities, cash and repurchase agreements collateralized fully by government securities or cash.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

#### **Note 5. Fully-Benefit Responsive Investment Contract**

The Plan has a traditional, fully benefit-responsive guaranteed investment contract with Voya that is reported at contract value. Voya maintains the contributions in a general account. The accounts are credited with contributions, earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 3% for the Voya Fixed Account and not less than 1% for the Voya Fixed Account A. Such interest rates are reviewed on an annual basis for resetting. The contract has no stated maturity date.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code (IRC) or the failure of the trust to be tax-exempt under Section 501(a) of the IRC
2. Premature termination of the contract
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreement without the consent of the issuer

#### **Note 6. Related-Party and Party-in-Interest Transactions**

Voya is the Custodian of the Plan's assets; therefore, the transactions with Voya qualify as party-in-interest transactions. Fees paid by the Plan to the Custodian totaled \$2,300 for the year ended August 31, 2024. The Plan Sponsor also paid certain administrative expenses of the Plan.

#### **Note 7. Plan Termination**

On May 14, 2024, the Plan Sponsor issued a formal request to terminate the plan, with an effective date of May 31, 2024. As a result, management determined liquidation was imminent. Through August 31, 2024, final distributions to participants were processed as part of the Plan termination totaling approximately \$7.6 million.

In February 2022, the Plan Sponsor's Rockingham facility was sold to a third party. Manufacturing operations ceased and employees at the Rockingham facility were terminated from the Plan Sponsor in conjunction with the sale. This resulted in a partial plan termination that affected 35 participants, 23 of whom took distributions from the Plan during the year ended August 31, 2023. All benefits were paid as of August 31, 2024. All participants affected by the partial plan termination became fully vested in their accounts prior to distributions being taken.

#### **Note 8. Tax Status**

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating the form of the preapproved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes that the Plan is designed, and is being operated, in compliance with the applicable provisions of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any significant uncertain tax positions that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 9. Non-Exempt Transactions**

During the years ended August 31, 2024 and 2023, the Plan Sponsor inadvertently failed to deposit \$13,674 and \$26,762, respectively, of participant loan repayments within the requirement timeframe as stated by the DOL regulations. The Plan Sponsor intends to deposit lost earnings, file Form 5330 and pay the applicable excise tax in 2025. The excise tax payments will be made from the Plan Sponsor's assets and not from the assets of the Plan.
