## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the JE Dunn Employee Stock Ownership Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit).

The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

As discussed in Note 4, the financial statements include the Plan's investment in the JE Dunn Construction Group, Inc. common stock representing approximately 84% and 82% of total assets as of December 31, 2024 and 2023, respectively, whose fair value has been estimated by an independent appraisal, in the absence of a readily ascertainable fair value, with the assistance of management and approved by the Trustee. Because of the inherent uncertainty of the valuation, the estimated value may differ significantly from the value that would have been used had a market for the investment existed, and the difference could be material. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other Matter—Supplemental Schedule Required by ERISA**

The supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).

#### Note 1. Description of Plan

The following brief description of JE Dunn Employee Stock Ownership Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** J.E. Dunn Construction Group, Inc. (the Plan Sponsor or the Company) established the Plan effective as of January 1, 2010. The Plan operates as an employee stock ownership plan (ESOP), is designed to comply with section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (the Code), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is administered by an ESOP Administrative Committee comprising up to five persons appointed by the Plan Sponsor's Board of Directors. The trust department of TI-Trust, Inc., an independent third-party bank, is the Plan's trustee (the Trustee). The Plan covers employees of J.E. Dunn Construction Group, Inc.

**Eligibility:** Full-time employees who have completed 30 days of continuous employment are eligible to receive a discretionary employer matching contribution. In addition, full-time employees who have completed one year of service and are employed at December 31 are eligible to receive an employer discretionary contribution. Certain classes of employees are excluded from eligibility, such as those covered by a collective bargaining agreement.

**Contributions:** The Plan Sponsor makes a discretionary employer matching contribution to the Plan for any participant making elective deferral contributions to the Dunn 401(k) Retirement Plan for such plan year. Discretionary employer matching contributions include any and all forfeitures allocable to participants for the plan year. Participants receive an allocation of discretionary employer matching contributions and forfeitures in an amount equal to the discretionary matching percentage times the participant's eligible elective deferral contribution for such plan year. The Plan Sponsor may also make employer discretionary contributions to the Plan as determined by the Board of Directors, in cash or Plan Sponsor stock, to be allocated to eligible participants. Plan participants are not permitted to make contributions to the Plan. Contributions shall not be made in amounts that cannot be allocated to the participants' accounts due to specific limitations described in the Plan.

As of December 31, 2024, the Plan Sponsor has contributed a total of 4,869,786 shares of the 17,675,000 shares of the outstanding common stock of the Plan Sponsor to the Plan. The Plan Sponsor contributed 100,110 shares, valued at \$10,736,798, during the 2024 plan year for the discretionary matching contribution and the employer discretionary contribution. The Plan Sponsor also contributed \$19,500,000 in cash to the Plan during the year ended December 31, 2024.

**Participant accounts:** The Plan is a defined contribution plan under which two separate accounts (a stock account and an account housing cash and mutual funds) are maintained for each participant in the Plan. Each participant's account is credited as of the last day of each plan year with an allocation of shares of the Company's common stock or cash contributed from the Plan Sponsor as an employer discretionary contribution and a discretionary employer matching contribution. Only those participants who are eligible employees of the Company as of the last day of the plan year or who met qualifications for retirement, death or disability will receive an allocation of the employer discretionary contribution. Each participant's account is also credited as of the last day of the plan year with an allocation of cash dividends. Each participant's account is adjusted for his or her share of Plan Sponsor contributions (stock or cash), reallocated forfeitures, withdrawals, forfeitures due to termination, certain income and gains (or losses), and recycling adjustments related to existing participants.

#### Note 1. Description of Plan (Continued)

**Vesting:** Participants with less than the minimum required years of service are not partially vested in their accounts. In the cases of termination due to normal or late retirement (after attaining age 60), disability or death, a participant has a nonforfeitable right to his or her account. Participants are vested in their accounts based on the years of service as shown below:

Years of Service	Vesting Percentage
Less than 2	0%
2	20%
3	40%
4	60%
5	80%
6	100%

**Payment of benefits:** Participants become eligible for distributions from the Plan upon death, disability, retirement or termination. A participant shall receive distribution of his or her vested accounts in a lump sum. Distributions from a participant's stock account shall be made in the form of cash and are distributed once per year. In the case where an employee terminates due to normal retirement, disability or death, distribution of the full value of the participant's account shall commence as soon as reasonably practicable after the plan year in which the normal retirement, disability or death occurred.

**Voting rights:** The Trustee shall vote all Company stock held by the Plan. In the case of any corporate matter that involves the voting of shares with respect to the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets of a trade or business, or similar transaction, each participant or beneficiary shall be entitled to direct the Trustee with respect to the voting of all shares allocated to their account at such time. If not timely exercised, the Trustee will vote such Company stock at the direction of the Plan Administrator or ESOP Administrative Committee.

**Diversification:** Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into another qualified defined contribution plan of the Company offering at least three investment options meeting the requirements of section 401(a)(28) of the Code and regulations thereunder. During the six plan years after a participant reaches age 55 and has completed 10 years of participation in the Plan, a participant may elect to diversify a portion of his or her Company stock account. In each of the first five years, a participant may diversify up to 25% of the sum of the number of shares allocated to his or her account as of the end of the preceding plan year, less any shares previously diversified. In the sixth year, the percentage changes to 50%.

**Forfeited accounts:** Forfeitures can be used to reinstate forfeitures, satisfy contributions, pay expenses, or be reallocated to participants. In 2024, cash forfeitures of \$909,106 and shares forfeitures of 8,093 valued at \$602,152 were used to partially satisfy the discretionary employer contributions and reallocated to eligible participants. There were no unallocated forfeitures at December 31, 2024 and 2023.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are presented using the accrual method of accounting.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustee determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Plan Sponsor dividends:** The Plan Sponsor paid a dividend to the Plan of \$20,867,155 during 2024.

**Administrative expenses:** Expenses paid by the Plan are recorded when accrued and allocated to participant accounts. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses of the Plan paid by the Plan Sponsor are excluded from these financial statements.

**Payment of benefits:** Benefit payments to participants are recorded upon distribution.

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification Topic 820 are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**J.E. Dunn Construction Group, Inc. common stock:** The fair value of the Company common stock held by the Plan is valued at fair value based upon an independent appraisal. This appraisal was based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected discounted cash flow and net income, return on assets, return on equity, market comparables in earnings, and revenue. Plan management has concluded that a market participant would also recognize a discount for lack of marketability.

The valuation process involves Plan management's selection of an independent appraiser. Plan management accumulates the data for the appraiser from the financial statements of the Company and affiliates.

**Interest-bearing cash:** Interest-bearing cash is valued at carrying value, which is fair value.

**Mutual funds:** The mutual funds are valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. This fund is required to publish its daily net asset value and to transact at that price. The mutual funds held by the Plan is deemed to be actively traded.

#### Note 6. Federal Income Tax Status

The Internal Revenue Service (IRS) has determined and informed the Plan Sponsor, by a letter dated August 24, 2017, that the Plan is qualified and the trust established under the Plan is tax-exempt under the appropriate section(s) of the Code. The Plan Administrator believes the Plan and trust are operating in a manner that did not jeopardize this tax status.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 7. Related-Party and Party-in-Interest Transactions**

The investment in the J.E. Dunn Construction Group, Inc. common stock represents a related-party transaction with the Plan Sponsor. The fair value of the investment in the Plan Sponsor's stock is determined through an independent valuation using the Market Approach—Guideline Public Company Method and the Income Approach—Discounted Future Returns Method.

#### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

#### **Note 9. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to ERISA. If the Company completely or partially terminates the Plan or contributions are completely discontinued, the accounts of the affected participants will become fully vested and nonforfeitable. The accounts of each affected participant shall be distributed as soon as administratively feasible, unless the Company, in its discretion, and if permitted by the Code and the regulations thereunder, directs that the accounts of the affected participants continue to be held in the trust to be distributed upon each participant's retirement, death, disability, termination of employment, or otherwise in accordance with the terms of the Plan.

#### **Note 10. Subsequent Events**

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.
