(1) Description of Plan

The following description of the Robert D. Gilmore & Associates, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Robert D. Gilmore & Associates, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Trustees are responsible for oversight of the Plan, determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Eligibility

All employees of the Company, except union employees, nonresident aliens, leased employees, interns, and residents of Puerto Rico, become eligible to participate in the Plan upon attainment of age 21 and three consecutive months of service. A participant's entry date into the Plan is the first day of the calendar month coinciding with or next following the date on which the eligibility requirements were satisfied.

Contributions

Each year, participants may contribute a percentage of their pre-tax annual compensation, as defined in the Plan, subject to limitations specified in the Internal Revenue Code (IRC). The Plan also allows for participants to make elective Roth deferral contributions to the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investments of their contributions into various investment options offered by the Plan.

The Plan has an automatic enrollment provision. Employees hired or rehired by the Company that meet the eligibility conditions shall be automatically enrolled in the Plan at a deferral rate of 5% of compensation unless, during their initial election period, participation is waived, or they elect to contribute a different amount.

The Company may make discretionary nonelective profit sharing contributions to active participants. Such contributions are allocated to eligible participants based upon each participant's pro rata share of total active participant's eligible compensation for the Plan year, subject to certain limitations. Participants are eligible to receive discretionary Company contributions if they are employed on the last day of the plan year and they have completed more than 500 hours of service during the plan year. No discretionary nonelective profit sharing contributions were made for the year ended December 31, 2024. Additionally, at its discretion the Company may also make a matching contribution. No discretionary matching contribution was made in 2024.

Contributions, Continued

Effective January 1, 2023, the Plan adopted a safe harbor matching provisions whereby safe harbor matching contributions are made in an amount equal to equal to 100% of participant elective deferrals up to 3% of the participant's compensation plus 50% of participant elective deferrals between 3% and 5% of the participant's compensation. The Company's safe harbor matching contributions totaled \$663,044 for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. The Company's safe harbor matching contributions plus earnings thereon are immediately 100% vested. Vesting in the Company's matching contributions and discretionary nonelective profit sharing portion of their accounts plus earnings thereon is based on years of service according to the following schedules:

Participants become fully vested upon death, total and permanent disability, or retirement.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lessor of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant is entitled to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, participants will receive the vested interest in their account as a lump-sum distribution. In addition, a participant may elect to receive an in-service distribution from the Plan upon attaining age 59½ and 10 years of service. A participant may be permitted to take hardship withdrawals from their account if certain conditions are met, as defined by the plan document.

Forfeited Accounts

Forfeited nonvested accounts may be used to pay administrative expenses of the Plan or to reduce future employer matching contributions. Forfeited amounts are available as of the earlier of (1) the last day of the plan year in which the former participant incurs 5 consecutive 1 year breaks in service or (2) the distribution of the entire vested portion of the participant's account. At December 31, 2024 and 2023, forfeited nonvested accounts total \$1,008 and \$1,629, respectively. During 2024, forfeitures were used to reduce administrative expenses in the amount of \$14,489.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's 401(k) Committee determines the Plan's valuation policies utilizing information provided by the custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(2) Summary of Significant Accounting Policies, Continued

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent loans are treated as distributions based upon the terms of the plan document.

Contributions

Contributions from plan participants and matching (safe harbor and discretionary) and nonelective profit sharing contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of the Plan are paid by the Company and are therefore excluded from these financial statements. Fees related to the administration of notes receivable from participants and participant transaction fees are charged directly to participant accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

(3) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. The funds held by the Plan are open end funds that are registered with Securities and Exchange Commission and are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Common collective trusts: Valued at the NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

(5) Guaranteed Investment Contract with Insurance Company

The Plan has a fully benefit-responsive guaranteed investment contract with Standard. Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer and averaged 3.04% in 2024. The interest rate is reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events that causes a significant withdrawal from the Plan, or (4) the failure of prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The contract can be terminated at any time at the election of the Company. Distributions will be made in accordance with the contract.

(6) Related Party Transactions and Party-In-Interest Transactions

Certain plan investments are units of common collective trusts managed by Reliance and a guaranteed investment contract managed by Standard. Reliance and Standard are the custodians, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions, which are exempt from prohibited transaction rules. Fees incurred by the Plan for investment management services are included in net appreciation in the fair value of investments. The Company provides personnel to perform administrative functions and facilities for the Plan at no charge to the Plan.

(7) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

(8) Tax Status

The Plan uses a standardized pre-approved plan document sponsored by Standard Retirement Services, Inc. The Internal Revenue Service (IRS) has determined and informed Standard Retirement Services, Inc. by a letter dated June 30, 2020, that the prototype plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(9) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statement of net assets available for benefits.
