NOTE 1 - DESCRIPTION OF PLAN

The following description of the Ditch Witch Midwest Salary Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a contributory, defined contribution plan covering employees of the participating employers (the Company) who have completed five hundred hours of service during six consecutive months and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The following employers affiliated by common ownership have adopted the Plan for their employees:

Ditch Witch of Illinois, Inc. d/b/a Ditch Witch Midwest
Progressive Leasing Company
Illini Power Products Company (ceased effective January 19, 2024)

Contributions

The Plan is funded by participants' contributions and discretionary contributions by the Company. Participants may contribute up to 100% of their annual compensation up to the maximum allowable limits of Code Section 401(k). The Company also has the option to make employer matching contributions based on an annual election. For the plan year ended December 31, 2024, the Company matched twenty-five percent of each participant's contributions that were not in excess of five percent of the participant's compensation. Each year, the Company also has the option to make a discretionary profit-sharing contribution. For the year ended December 31, 2024, the Company made a discretionary profit-sharing contribution of \$335,170.

Participant Accounts

Each participant's self-directed 401(k) account is credited with the participant's contributions and earnings on the participant's contributions, and is charged with plan expenses. Each participant has separate self-directed 401(k) accounts for employer matching contributions and employer profit-sharing contributions, which consist of the Company's contributions and earnings on the Company's contributions, and which are charged with plan expenses.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company matching and profit-sharing contributions portions of their accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested after five years of credited service.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Description of Investment Options

The Plan's assets are held in a trust administered by Minnesota Life Insurance Company. Participants may elect to have their account contributions invested in one or a combination of investment options provided by the Plan. The investment options consist of various pooled separate accounts and a group annuity contract as selected by the Plan Administrator.

Payment of Benefits and Distributions

On termination of service due to death, disability, retirement, or other reasons, a participant will receive an amount equal to the value of the participant's vested interest in a lump-sum payment or in a series of partial payments. In addition, the Plan provides for in-service withdrawals under certain circumstances.

Notes Receivable from Participants

The Plan contains provisions which allow for loans to participants, subject to certain restrictions. The maximum loan amount is the lesser of one half of the vested balance or \$50,000 reduced by the highest outstanding loan balance in the account during the prior 12 month period. Up to 50 percent of the vested balance may be used as collateral for the loan. These loans, which have a maximum term of five years (longer, if used to acquire a participant's principal residence), are to be repaid through regular scheduled payments. The interest rate charged for loans from the Plan is established by the Plan Administrator.

Administrative Expenses

Certain administrative expenses have been paid by the Company. Administrative expenses paid by the Plan include investment advisory and management fees.

Forfeited Accounts

Forfeitures may be used to pay administrative expenses, reduce employer contributions, or increase employer discretionary contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$20,558 and \$25,755, respectively. During the year ended December 31, 2024, forfeitures of \$25,755 were reallocated to eligible participants.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Administration

The Plan is administered by the Plan Administrator.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balance plus any accrued but unpaid interest.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and that also affect revenues and expenses during the reporting period. Actual results could differ from those estimates.

Date of Management's Review

For the current reporting period, subsequent events were evaluated through October 7, 2025, which represents the date the financial statements were available to be issued.

NOTE 3 - INVESTMENTS

The financial information relating to the Plan's investments is included in the accompanying financial statements based on information provided by the custodian. Minnesota Life Insurance Company was the custodian of the Plan's investments at December 31, 2024 and 2023. All investments are participant directed utilizing the investment options provided by the Plan.

NOTE 5 - FAIR VALUE MEASUREMENTS

The Fair Value Measurements and Disclosure Topic of the Financial Accounting Standards Board Accounting Standards Codification establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued based on the latest quoted market prices of the underlying securities.

Guaranteed investment contract: Contract value, as provided by the custodian, is determined to be the most appropriate determination of fair value based upon the following characteristics: (1) absence of a liquid market as the contract is not tradable, nor is it assignable, (2) no defined maturity, so timing of future cash flows is unknown, and (3) participant withdrawals are always made at contract value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 - GROUP ANNUITY CONTRACT

The Plan has entered into a traditional benefit-responsive investment contract (group annuity contract) with Minnesota Life Insurance Company (MLIC). MLIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Subject to certain restrictions, participants may ordinarily direct the withdrawal or transfer a portion of their investments at contract value. The group annuity contract is a traditional investments contract. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Participant-initiated transfers between funds always occurs at contract value, but the full amount may not be accessible from the general account at one time. Up to 20% of the contract value or \$2,000, whichever is greater, may be withdrawn at one time, and the remaining balance is inaccessible for twelve months. As a result of this limitation, the group annuity contract is a non fully benefit-responsive investment contract and therefore is reported at fair value.

NOTE 6 - GROUP ANNUITY CONTRACT (Continued)

The Plan's ability to receive amount due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against fair value for credit risk of the contract issuer or otherwise. The fair value of the group annuity contract as of December 31, 2024 and 2023 was \$1,637,442 and \$2,398,733, respectively. The crediting interest rates are based on a formula agreed upon with the issuer, but it may not be less than 1 percent. Such interest rates are reviewed on an annual basis for resetting.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include termination of the Plan, termination of the recordkeeping agreement, or written notice of termination provided either by the Plan Administrator or the issuer. In the event of the issuer terminating the contract, the issuer will pay all participant account values to another provider or trustee as directed by the Plan Sponsor. The Plan Administrator believes that occurrence of such events that would limit the Plan's ability to transact at contract value is not probable.

Liquidation of the entire contract may cause a one-time adjustment to the aggregate contract value, resulting in a fair value different from the contract value. This total liquidation is a contingent event, which cannot be initiated by the Plan's participants, and can only be initiated by the Plan Administrator upon termination of the Plan or complete termination of the contract.

NOTE 7 - TAX STATUS

The pre-approved plan sponsor has obtained an opinion letter dated June 30, 2020, in which the IRS stated that the non-standardized pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator timely adopted the restated volume submitter plan.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the Plan is no longer subject to income tax examinations for years prior to the year ended December 31, 2021.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 - PARTY IN INTEREST TRANSACTIONS

Certain Plan investments include a group annuity contract and pooled separate accounts managed by Minnesota Life Insurance Company. Minnesota Life Insurance Company is the custodian of the Plan and, therefore, these transactions qualify as a party-in-interest transactions. Fees paid by the Plan to the custodian are included as a reduction of the return earned on the group annuity contract and pooled separate accounts.

NOTE 10 - EXCESS CONTRIBUTIONS

The Plan failed certain discrimination testing for the years ended December 31, 2024 and 2023. Excess participant contributions amounting to \$27,979 and \$14,579, respectively, were recorded as a liability in the accompanying statements of net assets available for benefits at December 31, 2024 and 2023 and as a decrease in participant contributions for the respective years ended December 31, 2024 and 2023.
