## **Opinion**

We have audited the accompanying financial statements of Charter Homes Building Company Group Medical Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits and statement of benefit obligations as of December 31, 2024, and the related statement of changes in net assets available for benefits and statement of changes in benefit obligations for the year then ended, and the related notes to the financial statements.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**A - DESCRIPTION OF THE PLAN**

The following description of the Charter Homes Building Company Group Medical Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined benefit health and welfare plan providing coverage to all active full-time employees of Charter Homes Building Company (the "Company"), CH&N Site Construction, Inc (an affiliated company) and CP Management Services, Inc. (an affiliated company) working at least 30 hours per week. Employees are eligible on the first day after which 30 days of full-time employment is provided. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Charter Homes Building Company Health Benefit Trust (the "Trust") was established to hold the assets to fund the employee welfare benefits under the Plan as the Company shall determine.

Upon formation, the Plan became a member of Veris Benefits Consortium, LLC, which operates as a health insurance consortium under which the members negotiate and establish employee welfare plans for their employees. The employees are required to pay for a portion of the cost of the benefit.

**Contributions**

The Company shall contribute such amounts to the Plan as necessary for timely payment of all claims and administrative expenses of the Plan. The Plan provides for stop loss insurance over a specified amount as per agreement with the reinsurance carrier, with the premiums being paid by funds deposited by the Company. Employee and COBRA participant's contributions are determined on a fixed fee basis. The amount varies depending on the selection of individual or eligible dependent coverage.

**Self-Insured Benefits**

All medical and prescription benefits are self-insured. The claims are processed by the Plan's third-party claims processor under administrative services only (ASO) arrangements. The claims processor pays claims directly to on behalf of participants and are then reimbursed by the Plan's trust. The Plan also utilizes a pharmacy benefit manager which may receive refunds based on the Plan's actual utilization pattern of specific drugs. These refunds are kept by Veris and credits are provided against the ASO fees. Despite the Plan's utilization of a third-party claims processor, ultimate responsibility for payments to providers and participants is retained by the Plan.

**Stop Loss Insurance**

The Plan has a stop loss insurance arrangement whereby the stop loss insurance will cover the Plan's obligations for any plan participant's claims in excess of a fixed dollar amount (self-insured retention). The self-insured retention was \$75,000 per covered person for the year ended December 31, 2024. In addition, the Plan has an aggregate stop loss insurance arrangement whereby the aggregate stop loss insurance will cover the Plan's obligations if all claims exceed a fixed dollar amount. Premiums for stop loss insurance are included in the accompanying statement of changes in net assets available for benefits. Stop loss refunds of \$372,230 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

**COBRA Insurance**

The Plan allows for coverage under Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA) for a specified time period. If a participant's medical coverage terminates because of a life event known as a "qualifying event," then the participant and eligible family members may have the right to purchase continued coverage for a temporary period of time. Each qualifying individual pays their premium directly to the third-party administrator. COBRA claims are paid by the third-party administrator.

**B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, claims incurred but not yet reported (IBNR), claims payable and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Payment of Benefits**

Claim payments are recorded when paid.

**Administrative Expenses**

The Plan pays expenses related to administrative fees paid to third-party claims administrators and broker expenses. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses.

**Cash Equivalents**

The plan considers all highly liquid short-term investments purchased with an original maturity of three months or less to be cash equivalents. However, no such investments were owned by the Plan during 2024.

**C - CLAIMS INCURRED BUT NOT REPORTED**

Plan obligations at December 31, 2024 for claims incurred by active participants but not reported at that date are estimated by the Plan's actuary. Such estimated amounts are reported in the accompanying statement of benefit obligations. As of December 31, 2024, the amount of claims incurred but not reported totaled \$165,927.

**D - TAX STATUS**

The Trust established under the Plan to hold the Plan's assets is a taxable trust, accordingly, the trust's net investment income is not exempt from income taxes. The trust files annual tax returns as required. The trustees believe that the Trust and Plan are currently designed and being operated in compliance with the applicable requirements of the IRC. Taxes due and payable by the trust are not material; therefore no tax provision has been recorded.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**E - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to modify the benefits provided to participants, the right to modify the contributions required of participants, the right to discontinue its contributions, and the right to terminate the Plan, subject to the provisions of ERISA. In the event the Plan terminates, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Plan Sponsor or be used for purposes other than for the exclusive benefit of the Plan's participants.

**F - RISKS AND UNCERTAINTIES**

Claims incurred but not reported are calculated based on historical trends of claims reported but not yet settled and claims that have been incurred but not reported. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

The Plan's interest-bearing checking account is maintained at one financial institution. Such balances are insured by the Federal Deposit Insurance Corporation up to \$250,000. At December 31, 2024 there was no uninsured balance.

**G - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS**

As described in Notes A and B, the Plan has several arrangements with service providers; these transactions are party in interest transactions under ERISA. Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.
