### *Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit*

We have performed an audit of the financial statements of Silver State Schools Credit Union 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities For The Audit Of The Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis For Opinion On The Financial Statements***

**NOTES TO FINANCIAL STATEMENTS  
December 31, 2024 And 2023**

**1. Description Of The Plan**

The following description of Silver State Schools Credit Union 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General**

The Plan consists of the following: (1) a defined contribution employer-matching plan covering all employees of Silver State Schools Credit Union (the Company) and, (2) an IRS Section 401(k) feature which is a salary deferral arrangement covering all employees who elect to participate upon hire. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions**

Each year, participants may elect to have up to 50% of their annual pre-tax compensation contributed as pre-tax 401(k) or Roth 401(k) contributions, as defined in the Plan Agreement. Participants may also rollover amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan provides for an automatic enrollment feature. Employees are automatically enrolled at a default rate of 6% of eligible compensation to be contributed to the Plan. Participants of the Plan can affirmatively choose not to participate or choose a different salary deferral percentage. The automatic contribution arrangement applies to new participants or re-hired participants as they enter the Plan.

The Company provides a safe harbor matching contribution of 100% of salary deferral contributions up to 6% of compensation. In addition, the Company at the discretion of its Board of Directors shall have the right to make an additional discretionary matching contribution which shall be allocated to each eligible employee in proportion to his or her compensation as a percentage of the compensation of all eligible employees. These contributions, if any, are fully vested when contributed. For the year ended December 31, 2024, the Board of Directors decided not to make any discretionary contributions.

**Vesting**

Participants are vested immediately in their contributions. Vesting in the Company's discretionary matching contributions and in the Company's safe harbor matching contributions plus actual earnings thereon, is based on years of continuous service. A participant is 50% vested after one year of service and 100% vested after two years of service. A participant is fully vested upon reaching normal or early retirement age, death, or total disability as defined in the Plan Agreement.

**Participant Accounts**

Each participant's account includes the participant's salary reduction contribution, the Company's matching contribution, any rollover deposited from qualified participant accounts, an allocation of Plan earnings or losses, and an allocation of the Company's nonelective contribution, if any. Allocations are based on participant elective deferrals or compensation, as defined. Participants direct the investment of their contributions into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Payment Of Benefits**

On termination of service, death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum amount or in installments. The Plan allows for in-service distributions if a participant reaches age 59 and 1/2 and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan Administrator will authorize the benefit payment without the participant's consent. Participant account balances of \$1,000 to \$5,000 will be distributed from the Plan to an individual retirement account if not otherwise directed by the participant.

**Notes Receivable From Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balances. Only one loan is allowed outstanding to a participant at any one time. Loans are for a period not exceeding five years. The loans are secured by the balance in the participant's account and bear a reasonable fixed rate of interest, as determined by the Plan Administrator.

**Forfeitures**

In the absence of Plan expenses, forfeitures may be used to reduce Company contributions. For the year ended December 31, 2024, the amount of forfeitures used to reduce Company contributions was \$50,221. As of December 31, 2024 and 2023 there were no forfeitures available to reduce Company contributions.

**Administrative Expenses**

The Company pays a portion of administrative expenses incurred by the Plan. Some administrative fees, loan fees and participant requested services, are paid by the participants.

**2. Summary Of Significant Accounting Policies**

**Basis Of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

**Estimates And Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

**Investment Valuation And Investment Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions Receivable And Credit Loss Policy**

The Plan accounts for employer contributions receivable in accordance with Accounting Standards Codification Topic 326, *Financial Instruments – Credit Losses*. The standard requires entities to record an estimate of expected losses on financial assets for the remaining estimated life of the asset. This estimate includes consideration of historical experience, current conditions and reasonable and supportable forecasts.

The Company has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment Of Benefits**

Benefits are recorded when paid.

**Subsequent Events**

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

**3. Certified Financial Information**

Financial information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023 and dividends and net change in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Principal Life Insurance Company and Principal Global Investors Trust Company (collectively Principal), the Custodians.

#### **4. Fair Value Measurements**

The Plan utilizes an established framework for measuring fair value of investments. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

**Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Pooled Separate Accounts (PSAs) And Common Collective Trust (CCT)**

Pooled separate accounts values are not publicly quoted but are available to current investors via the Employer website or when Plan participants access their account values. PSAs are valued at the NAV reported by the investment manager of the accounts. The NAV is determined by dividing the net assets, at fair value, of the fund by the number of units outstanding on the day of valuation. Pooled separate accounts are primarily comprised of shares of registered investment companies held through subaccounts of a separate account of an insurance company at December 31, 2024 and 2023. The Plan has concluded that the NAV as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the insurance company represents fair value of the investments. These funds file as Direct Filing Entities (DFE).

The Common Collective Trust value is not publicly quoted but is available to current investors via the Employer website or when Plan participants access their account values. CCTs are valued at the NAV as reported by the investment manager of the accounts. The NAV, as provided by the trustee of the investment fund, is a readily determinable value and is calculated daily by the trustee. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The fund files as a DFE.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in valuation methodologies used at December 31, 2024 or 2023.

## 5. Income Tax Status

The Plan was restated effective February 17, 2022 through the adoption of a pre-approved plan document sponsored by Principal Life Insurance Company. Principal obtained an opinion letter dated June 30, 2020, which states that the pre-approved plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the Internal Revenue Service (IRS). However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**7. Party In Interest Transactions**

Certain Plan investments are managed by Principal Life Insurance Company and Principal Global Investors Trust Company, the Custodians as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Administrative expenses paid by the Plan were \$61,061 for the year ended December 31, 2024.

**8. Risks And Uncertainties**

The Plan invests in various investment securities, which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and those changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
