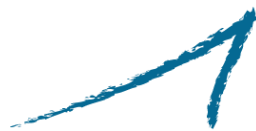

## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of the  
G.W. Lisk Company, Inc. Employee Stock Ownership Plan

### **Opinion**

We have audited the financial statements of the G.W. Lisk Company, Inc. Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### **Emphasis of Matter**

As discussed in Note 3, the financial statements include an investment representing 99.7% and 98.7%, respectively, of total assets for the years ended December 31, 2024 and 2023, whose fair value has been estimated by an independent appraisal, in the absence of readily ascertainable fair values, with the assistance of management and approved by the trustee. Because of the inherent uncertainty of the valuation, the estimated value may differ significantly from the value that would have been used had a market for the investment existed, and the difference could be material. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedule Required by ERISA**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

***Note 1***     **Description of Plan**

The following description of the G.W. Lisk Company, Inc. Employee Stock Ownership Plan (the Plan or the ESOP) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

**General**

G.W. Lisk Company, Inc. (the Company) established the ESOP effective January 1, 1994. In connection therewith, G.W. Lisk common stock held by the G.W. Lisk Company, Inc. Profit Sharing Retirement Plan (the Profit Sharing Plan) was transferred to the ESOP in March, 1994. The remaining assets in the Profit Sharing Plan were transferred to the G.W. Lisk Company, Inc. Employees' Savings and Investment Plan on December 31, 1994. The Plan, which has operated as a non-leveraged ESOP since December 31, 1999, is designed to comply with §4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (the Code) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Effective January 1, 2022, eligible employees of Island Components Group, Inc., a subsidiary of the Company, joined the Plan.

Effective January 1, 2023, eligible employees of Badge Actuation, Inc., a subsidiary of the Company, joined the Plan.

**Eligibility**

Employees of the Company are generally eligible to participate in the Plan after completing at least one year of service and reaching age 21. Effective April, 2021, the age to participate was lowered to age 18. Participants who do not have at least 1,000 hours of service during the Plan year or are not employed on the last working day of the Plan year are generally not eligible for an allocation of the Company's contributions for such year. The Plan allows employees that retire, die, or become disabled during the year to receive allocations.

**Administration**

The Plan is administered by an ESOP Committee, consisting of one or more persons appointed by the Company's Board of Directors. The Plan Trustees consist of one or more persons appointed by the ESOP Committee.

**Contributions**

As described in the Plan document, funding is determined at the discretion of the Board of Directors of the Company.

**Participant Accounts**

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of the Company's contribution of shares of the Company's treasury stock. Allocations are based on a participant's eligible compensation relative to total eligible compensation.

**Vesting**

Vesting of benefits in the Company's contributions is determined by completed years of service as defined by the Plan. Partial vesting begins after completion of two years of service and graduates annually until completion of six years of service, at which time the participant becomes fully vested. A participant's account also becomes fully vested upon death, disability or attainment of age 62 while still employed by the Company.

**Put Option**

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and that cannot be readily traded on an established market, or is subject to trading limitations, includes a put option. The put option is exercisable at either the price of the stock during the year of termination, or within 60 days of the notification of the value of the stock the year following termination from the Plan. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash. If the employee chooses not to exercise either of the put options, there is no obligation for the Company to purchase the stock.

**Diversification**

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution to the G.W. Lisk Company, Inc. Employees' Savings & Investment Plan.

**Forfeitures**

Upon termination of employment, participants forfeit any portion of the balance credited to their account which is not vested at the date of termination. Forfeitures are reallocated among active participants based on eligible compensation. During the years ended December 31, 2024 and 2023, respectively, the ESOP reallocated 11.64 and 28.53 shares to participants.

**Voting Rights**

The Company stock held in the Plan will normally be voted by the Plan Trustees at the direction of the ESOP Committee. However, participants may direct the ESOP Committee as to the manner in which the Company stock allocated to their accounts is to be voted with respect to important corporate transactions, as defined by the Plan.

**Distributions**

No distributions from the Plan will be made until a participant reaches age 62, has 10 years of participation in the Plan, retires, dies (in which case payment shall be made to his or her beneficiary or, if none, his or her legal representatives), or otherwise terminates employment with the Company. Distributions are made from the ESOP in shares, with partial shares paid in cash. However, the portion of the participant's account deriving from the former Profit Sharing Plan, ESOP shares valued at less than \$7,000 effective January 1, 2024, and participant's cash amounts, are paid out directly from the ESOP. In no event may the commencement of distribution be deferred beyond the calendar year in which the participant attains age 72, unless the participant is still actively employed by the Company.

Effective date of January 1, 2024, participants who have terminated employment with G.W. Lisk will have their account balances converted out of company stock and into cash and separated from active employees. Separated employees who are eligible for distributions in a plan year and have not elected a distribution will have their ESOP shares purchased for cash. These cash balances will be moved to the participant's G.W. Lisk Company, Inc. Employees' Savings & Investment Plan account. Any shares that are purchased back from segregated employees will be redistributed to current employed participants.

**Plan Termination**

The Plan is intended by the Company to be a permanent program to provide retirement benefits for employees. The Company has the right under the Plan to discontinue contributions at any time and/or to terminate the Plan subject to the provisions of the Plan. In the event of a Plan termination, the Board of Directors shall determine the method of distribution of the participant's accounts in accordance with the provisions of the Plan.

**Note 2 Summary of Accounting Principles and Practices**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Subsequent Events**

In preparing the financial statements, management has evaluated events and transactions for potential recognition or disclosure through October 1, 2025, the date that the financial statements were available to be issued.

**Administrative Expenses**

During 2024 and 2023, expenses of the Plan were paid by the Company.

**Benefit Payments**

Benefits are recorded when paid.

**Risks and Uncertainties**

The Plan invests in investment securities, which are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as inflation, a pandemic or international conflict. Due to the level of risk associated with these securities, it is at least reasonably possible that changes in their values will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Use of Estimates**

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Note 3**      **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan follows the fair value measurement guidance required by accounting principles generally accepted in the United States of America for financial and nonfinancial assets and liabilities. That guidance defines fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2    Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3    Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value:

The common stock of the Company is valued at estimated fair value on December 31, 2024 and 2023, respectively. The estimated fair value is determined by the Board of Trustees based on annual valuations of the Company's common stock by an independent appraiser using the guideline company method. The common stock is considered a Level 3 asset.

Cash is valued at cost, which approximates fair value, and is considered a Level 1 asset.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5 Federal Income Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated March 19, 2015, that the Plan and related trust were designed in accordance with the applicable regulations of the Internal Revenue Code (IRC). The Plan has been amended since the effective date of the determination letter. The Company and the Plan Administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and the Plan and related trust continue to be tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

***Note 6***     **Other Transactions**

During 2024 and 2023, the Company repurchased 1,335 and 2,084 common shares, respectively, from participants who requested cash distributions directly from the ESOP.

***Note 7***     **Party-in-Interest Transactions**

Certain Plan assets are shares of common stock of G.W. Lisk Company, Inc., the Plan Sponsor and, therefore, transactions involving these assets qualify as party-in-interest transactions.
