INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
of Gurwin Tax Deferred Annuity Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Gurwin Tax Deferred Annuity Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Gurwin Tax Deferred Annuity Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Gurwin Tax Deferred Annuity Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Gurwin Tax Deferred Annuity Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

December 31, 2024 and 2023

Note 1 - Description of Plan

General

Gurwin Jewish Nursing & Rehabilitation Center Tax Deferred Annuity Plan (“the Plan”), a contributory tax-deferred annuity plan, was established on January 1, 1989 and covers all eligible employees of The Rosalind and Joseph Gurwin Jewish Geriatric Center of Long Island, Inc. d/b/a Gurwin Jewish Nursing & Rehabilitation Center (the “Center”).

Effective August 7, 2019, the plan merged with three related deferred annuity plans and changed the name of the plan to the Gurwin Tax Deferred Annuity Plan. In addition to the Center’s eligible employees, the Plan covers the following eligible employees of:

- Gurwin Home Care Agency, Inc. (the “Agency”)
- Gurwin Jewish Healthcare Foundation (the “Foundation”)
- Gurwin Jewish-Fay J. Lindner Residence (“GJ-FJLR”)
- Gurwin Independent Housing Inc. d//b/a Fountaingate Gardens (“FGG”) effective April 1, 2023

The employers listed above are collectively referred to as the “Sponsor” or the “Employers”.

The following description of the Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

Contributions

The Plan has an auto-enrollment provision whereby all eligible new hires and rehires, on or after January 1, 2006, are automatically enrolled in the Plan within 30 days, unless they affirmatively elect not to participate. Automatically enrolled participants have their pre-tax deferral rate set at 3 percent of eligible compensation and their contributions invested in the default investment fund designated by the Plan Administrator. Prior to January 1, 2025, the automatic enrollment feature did not apply to employees of the Agency; however, the Plan was amended effective January 1, 2025, to include the Agency in the auto-enrollment feature.

All employees whose employment is at least 975 hours per year are eligible for employer contributions. A participant who leaves the Sponsor’s employment and is later rehired is included in the Plan depending on the hours completed during the 12-month period prior to termination of employment, as well as prior years of service. The employer contributions for all eligible employees are equal to 4% of employee compensation.

In addition, effective July 1, 2020, an employer bonus may be made on behalf of any one or more non-highly compensated employee participants, with a plan amendment, at the discretion of the Chief Executive Officer of the Plan Sponsor.

Upon enrollment in the Plan, a participant may direct contributions in a variety of investment options offered by the Plan. Participants may change their investment options at any time. The Plan does accept rollovers and transfers from other qualified plans.

Note 1 - Description of plan (Continued)

Contributions (continued)

A participant's total elective deferrals in any calendar year may not exceed a certain dollar limit, which is set by law ("elective deferral limit"). A participant may also defer more than the elective deferral limit if eligible to make "catch-up deferrals" as described below.

Participants age 50 or who will attain age 50 before the end of a calendar year may make additional deferrals (called "age 50 catch-up deferrals") for that year and following years. If the participant meets the age 50 requirement and exceeds the elective deferral limit described above, then any excess will be an age 50 catch-up deferral, subject to IRC limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Employer's contributions, and (b) the participant's share of earnings on their chosen investment options. Plan income and expenses are credited or debited to participant accounts based on the pro rata share of the participant's individual account balance to total plan assets, except for transaction fees which are charged directly to the participant's accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts is based on years of continuous service. The total value of a participant's account balance in the Employer's portion vests incrementally based on years of continual services and is fully vested upon six years of employment if hired on or after January 1, 2009 or upon three years of employment if hired prior to January 1, 2009, unless the participant is disabled, over 65, or receives a Volunteer Incentive Resignation Program (VIRP) bonus payment; in such cases, vesting is immediate.

Payment of Benefits

On termination of service due to disability or retirement, a participant (or a designated beneficiary) may elect to receive the vested interest in his or her account in either a lump sum amount or annual installments. If the participant dies before distribution begins, the vested interest in the Plan will be distributed to the surviving spouse or designated beneficiary within 5 years after the participant's death. For termination of service resulting from other reasons, a participant may elect to receive the value of the vested interest in his or her account as a lump-sum distribution or maintain his or her vested interest within the Plan. If a participant terminates service and the value of the participant's vested account balance is not greater than \$1,000, the participant will receive a lump-sum distribution of the value of the entire vested portion of such account balance and the non-vested portion will be treated as forfeiture. If the value of the participant's vested account balance exceeds \$1,000 and does not exceed \$5,000, the balance will be rolled over to an IRA.

Note 1 - Description of plan (Continued)

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to \$50,000 for a period not to exceed 5 years unless the loan is for the purchase of a principal residence. Participants are limited to borrowing a maximum of 50% of the present value of the participants' vested account balance. The loans bear interest at a rate of 1% above the USA Today prime rate in effect at the date of the loan. Principal and interest are paid ratably through payroll deductions over the term of the loan. Interest rates charged range from 4.25% to 9.50%. Loans determined to be uncollectible based on periodic review by management are directly written off and considered as deemed distributions. During 2024 and 2023, there were deemed distributions of \$14,800 and \$48,762, respectively. There was no allowance for uncollectable loans at December 31, 2024 and 2023.

Forfeitures

Participants who terminate employment before becoming vested will forfeit the nonvested portion of their employer contribution accounts. These forfeited amounts will be held in the Plan for use by the Sponsor to meet any obligations with respect to employer contributions or pay plan expenses. At December 31, 2024 and 2023, non-vested forfeited accounts had a balance of \$56,060 and \$43,407, respectively. During 2024 and 2023, there was \$99,339 and \$62,231 of new forfeitures, and \$1,434 and \$1,740 of forfeiture earnings, respectively. Forfeitures resulting from non-vested accounts of \$86,253 and \$140,273 were used to reduce employer contributions in 2024 and 2023, respectively.

Note 2 - Summary of significant accounting policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investments in Guaranteed Investment Accounts with Empower Annuity Insurance Company of America ("EAIC") and Transamerica Financial Life Insurance Company ("TFLIC") are recorded at contract value. Contract value represents contributions made under the contract, plus a minimum rate of interest earned, at a rate determined by GWLA and TFLIC, less withdrawals and transfers to other accounts. These accounts do not have any liquidity restrictions, are fully benefit-responsive, and have been classified as Guaranteed Investment Accounts (see Note 9 for a further discussion of the Guaranteed Investment Accounts).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. As applicable, interest income is recorded on the accrual basis, and dividend income is accrued on the ex-dividend date. The income or loss of each investment option, including the change in market value of investments, is allocated to participant accounts based on each participant's proportionate interest in the investment option. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are deemed as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses are paid by the Plan sponsor. Fees paid to Empower Annuity Insurance Company of America for contract administration and investment service fees are paid by the Plan. Investment management fees paid to Transamerica are included as a reduction of the investment returns (see Note 5).

Date of Management's Review

Subsequent events were evaluated through October 3, 2025, the date the financial statements were available to be issued.

Note 3 - Fair Value Measurements

Fair Value Measurements establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below. Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. Level 2 inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability. Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 compared to those used at December 31, 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

- Mutual funds - Valued at the net asset value ("NAV") of shares held by the Plan at year end. The mutual funds held by the Plan are deemed to be actively traded.
- Pooled separate account - Valued at the net asset value ("NAV") of shares held by the Plan at year end. This account has readily determinable fair values and transacts at NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Party-in-Interest and Related party transactions

Administrative expenses consist of service fees charged by Empower Annuity Insurance Company of America (“EAIC”), (a subsidiary of Empower Retirement LLC, formerly known as Great-West Life & Annuity Insurance Company), which were paid by the Plan. Certain plan investments are also managed by EAIC. Fees paid by the Plan to EAIC for contract administration and investment service fees for the years ended December 31, 2024 and 2023 were \$169,493 and \$94,669, respectively. Other plan investments are managed by Transamerica. Investment management fees paid to Transamerica were included as reduction of the investment return on each fund. In addition, Sentinel Pension Advisors (“Sentinel”) is the investment advisor. Advisory fees paid to Sentinel from the Plan during the years ended December 31, 2024 and 2023 were \$55,000 and \$55,000, respectively. These transactions qualify as party-in-interest transactions, which are deemed to be “exempt” from the Prohibited Transactions Rules, as defined by Department of Labor regulations.

Note 6 - Tax status

The Sponsor has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated April 7, 2021, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 7 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100 percent vested in their deferral accounts and will become 100 percent vested in their employer contribution accounts.

Note 8 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 - Guaranteed Investment Accounts with Empower Annuity Insurance Company of America (EAIC) and Transamerica Financial Life Insurance Company (TFLIC)

The Plan entered into a benefit-responsive guaranteed investment contracts with EAIC (*a subsidiary of Empower Retirement LLC, which was formerly known as Great-West Life & Annuity Insurance Company and acquired the retirement business of Massachusetts Mutual Life Insurance Company*) and TFLIC companies totaling \$31,187,791 and \$33,197,108 as of December 31, 2024 and 2023, respectively. EAIC and TFLIC maintain the contributions in a general accounts. These accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment accounts issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate are based on a formula agreed upon with the issuer, but may not be less than 1%.

The guaranteed investment accounts meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may normally direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the Plan's ability to transact at contract value with the contract issuer. Such events include the following:

- The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974
- Premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.
- Amendments to the Plan documents (including complete or partial plan termination or merger with another plan)
- Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions,
- Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan

In addition, certain events allow the issuers to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer

No events are probable of occurring that might limit the ability of the Plan to transact at the contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

The guaranteed investment accounts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 10 - Reconciliation to form 5500

The differences between the information reported in the financial statements and the information reported in the Form 5500 arise primarily from presenting the financial statements on the accrual basis of accounting.
