NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the 401(K) Profit-Sharing Plan for Employees of Cazenovia Recovery Systems, Inc. (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Cazenovia Recovery Systems, Inc. (the Plan Sponsor). The Plan was established effective January 1, 1987, and was amended and restated effective January 1, 2022, to conform to the latest tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility

Employees are eligible to begin making elective deferrals on their date of hire. Employees must be twenty-one years of age and have completed one year of service in order to be eligible for Plan Sponsor matching contributions and Plan Sponsor profit sharing contributions.

Contributions

Participants are automatically enrolled into the Plan at 3% beginning on the 1st of the month following 30 days of employment but may elect to dis-enroll via electronic means. If participants do not make a deferral election, the automatic deferral amount will increase one percent after the second year and thereafter until a maximum of 6% is reached. Participants may elect to contribute a specific percentage or dollar amount of their annual compensation (as defined in the Plan agreement) as a pre-tax or Roth after-tax contribution, limited by the amount imposed by law. Additionally, participants age 50 or older may elect to make a catch-up contribution limited to the amount imposed by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (i.e., rollovers). Rollover contributions amounted to \$4,144 and \$89,807 during the years ended December 31, 2024 and 2023, respectively.

In accordance with the Plan agreement, the Plan Sponsor will make matching contributions equal to 50% of the first 3% of compensation contributed to the Plan by each eligible participant. The Plan Sponsor can also make a discretionary profit sharing contribution to the Plan. In order to receive profit sharing contributions, participants must be employed by the Plan Sponsor on the last day of the Plan year. Discretionary profit sharing contributions amounted to \$132,164 and \$131,966 for the years ended December 31, 2024 and 2023, respectively.

Participant Accounts

Individual accounts are maintained for each Plan participant. Participant accounts are increased by participant contributions, Plan Sponsor contributions, and the participant's share of Plan earnings. Participant accounts are decreased by participant distributions and the participant's share of Plan expenses and losses. The allocation of earnings and losses to participant accounts is based upon the value of an individual account in relation to the total assets of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants are vested immediately in their contributions and Plan Sponsor's contributions plus actual earnings thereon.

Payment of Benefits

Upon termination of service due to retirement, death, disability, or as required by law, a participant may elect to receive installment distributions or a lump-sum distribution in an amount equal to the vested value of their account. The Plan permits in-service distributions for participants older than age 59½.

Hardship Withdrawals

A participant may, under certain defined conditions, withdraw any part of his or her vested account attributable to his or her elective deferral contributions credited to his or her account. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

Forfeitures

The total balances of participant accounts for those participants who have ceased employment with the Plan Sponsor are forfeited upon the earlier of the distribution of the participant's vested account balance or the occurrence of a consecutive five-year break in service. At the Plan Sponsor's discretion, forfeitures arising during any Plan year may be used to reduce the Plan Sponsor's contributions. There were no employer contributions reduced by previous forfeitures during the years ended December 31, 2024 and 2023, respectively. There were no unused forfeitures for the years ended December 31, 2024 and 2023, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan agreement to discontinue its contributions at any time and to terminate its participation in the Plan, subject to the provisions of ERISA. In the event of partial or complete Plan termination, participants will continue to be fully vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

The Plan's investments consist of separate account funds which are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

The Plan presents in the accompanying statements of changes in net assets available for benefits the net appreciation (depreciation) in fair value of investments, which includes both realized gains and losses and unrealized net appreciation or depreciation in the fair value of investments. Realized gains and losses on disposition of investments were based on actual costs and selling prices. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition (Continued)

The general account fund's value is calculated as accumulated cash contributions and interest credited to the Plan's account, less any withdrawals. The value is the redeemable value of the fund. There are no deferred sales charges, load assessments, interest rate adjustments, or surrender charges that would affect the value as a result of a withdrawal request.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes in the values of investments could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

Benefit Payments

Benefit payments are recorded when paid.

Administrative Expenses

Certain accounting and administrative expenses of the Plan are paid by the Plan Sponsor. Expenses relating to investment activity are paid by the Plan.

Income Taxes

The Plan is exempt from federal income tax under Section 401(k) of the Internal Revenue Code. The Plan is required to operate in conformity with the Internal Revenue Code in order to maintain its tax exempt status for Plan participants. The Plan obtained its latest determination letter on November 30, 2020, in which, the Internal Revenue Service states that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

Estimates

The preparation of financial statements in accordance with GAAP requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

- Level 1 Unadjusted quoted prices in active markets for identical, unrestricted assets or liabilities that are accessible at the measurement date.
- Level 2 Quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets or liabilities in markets that are not active. This level also includes inputs other than quoted prices that are observable, either directly or indirectly, for substantially the full term through corroboration with observable, independent market data. This includes investments valued at quoted prices adjusted for legal or contractual restrictions specific to the security.
- Level 3 Pricing inputs are unobservable for the asset or liability. That is, inputs that reflect the reporting entity's own assumptions about the assumptions that market participants would use in pricing the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the valuation methodologies used during the years ended December 31, 2024 and 2023. Following is a description of the valuation methodology used for assets measured at fair value:

4. FAIR VALUE MEASUREMENTS (Continued)

Separate Account Funds

The separate account fund's assets are invested in domestic stocks, international stocks, and fixed securities, such as asset or mortgage-backed securities and corporate bonds, and in mutual funds that hold such investments. The net asset value of the separate account fund is not publicly quoted. The values of the underlying investments are used in determining the net asset value of the separate account. Underlying equity securities have observable quoted pricing inputs. Underlying fixed securities have observable pricing inputs, including quoted prices for similar assets in the active or non-active markets. Underlying mutual funds are valued at publicly quoted pricing inputs.

There are no restrictions in connection with the transfer among or withdrawal from any of the investment alternatives in the separate account, other than that excessively frequent transfers or redemptions might be rejected. Each underlying fund has reserved the right to reject any aggregate purchase of fund shares that it determines to be inconsistent with their fund's policies and procedures relating to market timing.

The separate account funds currently invest in various underlying funds, which have different investment objectives, investments policies, and risks. The investment strategies of these funds will vary based on the participant's chosen risk preferences. The separate account fund does not have any unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

General Account Fund

The general account fund's asset is invested in group annuity contracts that have a guarantee of principal and previously credited interest to protect against market risk. The guarantee is based on Mutual of America's financial strength and claims-paying ability. Mutual of America assumes the investment risk of the underlying investments of the Interest Accumulation Account.

Mutual of America guarantee's that they will credit interest for the life of the annuity contracts in the general account fund at a rate at least equal to the greater of (1) any contractual minimum guarantee provided by the contract or (2) the minimum rate required by applicable state law or, if no state law minimum rate is applicable to a contract, the guaranteed minimum credited interest rate will be set pursuant to National Association of Insurance Commissioners (NAIC) standard nonforfeiture law. The NAIC minimum rate is determined in accordance with a formula and cannot be less than 0.15% or more than 3.00% in any event. Interest is compound daily on the contract amounts on the annuity contracts in the general account fund to produce an effective annual yield that is equal to the stated interest rate.

Certain Plan investments are managed by the custodian, Mutual of America, and therefore, these transactions qualify as party-in-interest transactions.

6. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October X, 2025, which is the date the financial statements were available to be issued.
