NOTE 1 - DESCRIPTION OF THE PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Plan Description

The following description of the Total Education Solutions, Inc. 401(k) Plan (the "Plan") is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the Plan document.

A. General

Effective January 1, 1998, Total Education Solutions, Inc. (the "Company") established the Plan as a defined contribution plan under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. Employees are immediately eligible for participation, and are eligible to receive Company matching contributions if they are 21 years old and have completed one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

B. Contributions

Participants may elect to defer a percentage of compensation, as defined in the Plan, subject to limitations set forth by the IRC. The Plan also allows catch-up contributions and rollovers from qualified plans. The Company makes a safe harbor matching contribution equal to 100% of salary deferrals that do not exceed 3% of participant compensation, plus 50% of participant salary deferrals over 3%, up to 5% of compensation. The safe harbor matching contribution is fully vested and is referred to as a Basic Matching Contribution. Matching contributions totaled \$499,420 for 2024.

C. Vesting

Participants are immediately vested in all contributions.

D. Payment of Benefits

Upon termination of employment, including termination due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the vested interest in his or her account. Normal retirement age is 59½. Early retirement age is 55. Hardship distributions are allowed. Benefits are recorded when paid.

E. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

F. Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

G. Administrative Expenses

Most expenses related to administering the Plan are paid by the Company.

H. Investment Valuation and Income Recognition

Participants select how their share of plan assets will be invested among those investment vehicles made available. Participants may change their investment options at any time during the Plan year.

Accounting guidance on measuring fair value establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Plan investments consist of mutual funds reported at fair value using net asset value per share (NAV) as a practical expedient and have not been classified in the fair value hierarchy. The investments may be redeemed any time at net asset value. There are no restrictions on redemptions and no unfunded commitments to purchase additional shares for these investments. The Plan also offers a fixed income option (see Note 2).

Interest and dividends are recorded on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis.

I. Risks and Uncertainties

The Plan provides for various investment options in any combination of investments offered by the Plan. Investments are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the risk associated with investments, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the financial statements. The Plan's exposure to the credit loss in the event of nonperformance of investments is limited to the carrying value of such investments.

J. Notes Receivable from Participants

At the discretion of the Plan's administrator, a participant may borrow from the custodian a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of his or her vested account balance. Loans are secured by a collateral account. The minimum loan repayment period is five years, or ten years for a loan used to purchase the participant's primary residence. Principal and interest are paid ratably by the participant to the custodian. Loans bear interest at rates set by the custodian, which ranged from 2.50% to 5.50% as of December 31, 2024, but participants' accounts are credited with the guaranteed collateral account rate of 3.0%.

NOTE 2 - FIXED INCOME OPTION

The Plan maintains a fully benefit-responsive group annuity contract with Variable Annuity Life Insurance Company ("VALIC") through the Fixed Income Option ("Unallocated Insurance Contracts"). Contributions to the Unallocated Insurance Contracts are maintained in an insurance company general account and credited for interest and charged for participant withdrawals and administrative expenses. VALIC is contractually obligated to repay principal and a specified rate of interest that is guaranteed to the Plan. The Unallocated Insurance Contracts meet fully benefit-responsive investment contract criteria and are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants when they initiate permitted transactions under the terms of the Plan.

The crediting rate is based on a formula established by VALIC but may not be less than 1% percent. The crediting rate is reviewed on a monthly basis for resetting. Crediting rates in 2024 ranged from 2.75% to 3.00%.

The Plan's ability to receive amounts due is dependent on VALIC's ability to meet its financial obligations. There are no reserves against contract value for credit loss. Certain events might limit the ability of the Plan to transact at contract value, including premature termination of Plan investments in the Unallocated Insurance Contracts. The plan administrator does not believe that any events limiting the Plan's ability to transact at contract value are probable of occurring.

NOTE 3 - FINANCIAL INFORMATION CERTIFIED BY THE CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by VALIC, the custodian of the Plan.

NOTE 4 - INCOME TAX STATUS

The Plan is based upon a prototype plan document that has received an opinion letter dated June 30, 2020 from the Internal Revenue Service, stating that the form of the Plan is acceptable under Section 401 of the IRC. The Plan has since been amended; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are 100% vested in their accounts and Plan assets will be distributed based upon the participants' account balances at that time.

NOTE 6 - RELATED PARTY TRANSACTIONS

Certain investments held by the Plan are issued and managed by the custodian or its affiliates. Transactions related to these investments qualify as party in interest transactions; however, they are exempt from the prohibitions under ERISA.
