Scope and Nature of the ERISA Section 103(a)(3)(c) Audit

NOTE A – DESCRIPTION OF PLAN

The following description of Neighborhood House, Inc. 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan covering all eligible employees of Neighborhood House, Inc., the Plan Sponsor. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute pretax annual compensation, up to the maximum amount allowed by law, as defined in the Plan.

The Plan provides for an employer match of 50% of a participant's deferrals up to 4% of the participant's gross pay and an employer discretionary contribution of 2% of the participant's compensation following an initial three-month waiting period after a new employee's date of hire.

Participant accounts

Individual self-directed accounts are established for each plan participant. The accounts are credited with the employee elective deferrals, rollovers from other qualified plans or trusts, employer discretionary and matching contributions, and any earnings or losses thereon. The accounts are charged with an allocation of custodial and fund expenses. Participants may invest in the full range of investment options provided by T. Rowe Price Investment Services, Inc.

The majority of the Plan accounts are held at T. Rowe Price Investment Services, Inc., the current plan custodian since February 1999. T. Rowe Price offers no-load stock, bond, money market, and blended asset funds, which provide an array of growth, income or stability investment alternatives. In addition, a small number of participants remain with Mutual of America, an earlier custodial account established in July 1986. In 1999, most accounts were transferred to T. Rowe Price and no additional contributions have been made to Mutual of America funds.

Participants may prospectively change their investment allocations at any time, subject to any limitations that may be set by T. Rowe Price Investment Services, Inc.

Vesting

Participants are fully and immediately vested in all amounts contributed to the Plan when the contributions are made. These amounts are nonforfeitable.

Payment of benefits

Benefits under the Plan are distributed upon termination of service, retirement, death, or disability.

NOTE A – DESCRIPTION OF PLAN (Continued)

Upon termination of service, the participant may elect to receive his or her account balance in a single cash payment, receive installment payments over a period of years, rollover his or her balance to another qualified plan, or continue to participate in the Plan, if eligible. Participants may at any time request distribution of all or any portion of the participant's account attributable to a rollover from another plan.

NOTE B - SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan have been prepared on an accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America as applied to defined contribution plans, and in accordance with the Plan agreement.

Valuation of investments and income recognition

The Plan's investments are carried at fair value to recognize currently any unrealized gains or losses. Unrealized gains and losses are recorded in each participant's individual account. Purchases and sales of securities are reflected on a confirmation date basis. Dividend income, interest income, and realized gains and losses from investments are recorded as earned, on an accrual basis, in each participant's individual account.

Fair value measurements

In accordance with financial accounting standards, a three-tiered hierarchy of input levels is used for measuring fair value. Financial accounting standards define fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Valuation techniques utilized to determine fair value are consistently applied. The three tiers of inputs used for fair value measurements are as follows:

Level 1: Fair values are based on quoted prices in active markets for identical assets and liabilities.

Level 2: Fair values are based on observable inputs that include: quoted market prices for similar assets or liabilities; quoted market prices that are not in an active market; or other inputs that are observable in the market and can be corroborated by observable market data for substantially the full term of the assets.

Level 3: Fair values are calculated by the use of pricing models and/or discounted cash flow methodologies, and may require significant management judgment or estimation. These methodologies may result in a significant portion of the fair value being derived from unobservable data.

Benefits paid to participants

Benefits paid to participants are recorded when paid.

NOTE B - SIGNIFICANT ACCOUNTING POLICIES (Continued)

Use of estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires that the plan administrator make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE C - ERISA 103(a)(3)(c) AUDIT

The audit for the year ended December 31, 2024 was an ERISA 103(a)(3)(c) audit. The certification of the Plan custodian, T. Rowe Price, apply to the investment assets, transactions, and income, as well as to the schedule of assets relating to accounts held by the respective custodian.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, Neighborhood House, Inc. has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE F - RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE G - TAX STATUS

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

NOTE H - PARTY-IN-INTEREST TRANSACTIONS

Plan investments include shares of registered investment companies managed by T. Rowe Price and Mutual of America and funds held in the Mutual of America Insurance Company general account. These organizations are the custodians of the Plan and, therefore, transactions with these entities qualify as exempt party-in-interest transactions. Fees paid by the Plan for account services were \$16,685 for the year ended December 31, 2024.

NOTE I - PLAN AMENDMENTS

During 2023, the Plan was amended to permit participants to take hardship withdrawals from their accounts, subject to IRS and DOL regulations and amended Plan provisions.

The plan administrator believes the Plan meets the qualification requirements under Section 401(a) and is tax exempt under provisions of the Internal Revenue Code (the Code). Although the Plan has been amended, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.
