The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024, and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 1 to the financial statements, is complete and accurate.

### Opinion

### **Basis for Opinion**

**1. DESCRIPTION OF PLAN:**

The following brief description of the Plan provides only general information. Participants should refer to the Plan document for complete information.

**General**

The Club One Casino Inc. 401(k) Plan (the Plan) is a defined contribution plan and was adopted effective January 1, 2022, for all eligible full-time employees (participants) of Club One Casino, Inc. (the Company). The Plan is subject to the provisions of the Employees Retirement Income Security Act of 1974 (ERISA).

**Eligibility and Vesting**

An employee who is not a member of an excluded class becomes eligible for participation in the Plan upon attainment of his twenty-first birthday, and after completing three months of service. Upon satisfying the eligibility requirements, employees may participate in the Plan immediately upon eligibility. Participants are immediately 100 percent vested in their voluntary contributions including catch-up contributions, rollover contributions, plus actual earnings thereon. Vesting in the Company's nonelective contributions is based on years of service. Participants are credited with a period of service for 1,000 hours earned. A participant is 100 percent vested after six years of credited service for discretionary contributions.

**Notes Receivable from Participants**

Participants who are active employees may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance. Loan terms range from 1-5 years. The loans are secured by the balance in the participant's account and bear interest at rates as reflected in the Wall Street Journal on date of loan plus 1% per year. Principal and interest is paid ratably through monthly payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of 2024 or 2023. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the entire principal balance and interest will become immediately due and payable. The amount of the outstanding loan is treated as a taxable distribution to the participant. Loans were discontinued in 2024.

**1. DESCRIPTION OF PLAN (CONTINUED):**

**Certified Investments**

The Plan administrator elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator limited auditing procedures with respect to the investment information certified by the Custodian, which included total investments as of December 31, 2024 and 2023, the total investment income for the year ended December 31, 2024, and all information included in the supplemental schedule H, line 4i – schedule of assets (held at end of year), which was certified as complete and accurate by Matrix Trust Company (the custodian of the Plan).

**Contributions**

Each year, participants may elect to contribute up to 90% of pretax annual compensation up to the dollar limit for the current year (\$23,000), as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. At the discretion of the plan administrator, participants may be permitted to deposit or “rollover” into the Plan, distributions they have received from other plans and certain IRAs. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make discretionary nonelective contributions which will be allocated in accordance with the plan document provisions. Participants must be employed on the last day of the plan year to be eligible to receive discretionary nonelective contributions. The Company contributes Safe Harbor matching amounts equal to 100% of the employee's elective deferral which is not over 4% of the employee's pay. The Plan currently offers various mutual funds. Contributions are subject to certain statutory limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, allocation of the Company's contributions, and Plan earnings or losses and charged with an allocation of administrative expenses. Allocations may be charged based on either the size of the participant's account balance or equal to each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Forfeited Accounts**

Forfeitures represent the non-vested portion of terminated participants' accounts. The Plan allows forfeitures of non-vested Company contributions to be used in the following ways: reduce Company contributions, pay administrative expenses, reallocated as Company contributions, and supplement Company contributions. At December 31, 2024 and 2023, there were \$0 and \$0 of forfeited non-vested accounts, respectively. During 2024 and 2023, \$7,001 and \$4,014 in forfeitures were used, respectively.

**1. DESCRIPTION OF PLAN (CONTINUED):**

**Investment Options**

Upon enrollment in the Plan, a participant may direct the contributions made to the Plan, for or on behalf of the participant, to any one or more of the investment funds determined at the discretion of the Plan Administrator and Plan Sponsor and in such multiples as the participant prescribes. A participant may change his or her investment direction with respect to future contributions or redirect the investment of his or her account balances.

**Payment of Benefits**

Benefits are recorded when paid. On termination of service, disability, or retirement, a participant is entitled to receive a distribution equal to the value of the participant's vested interest in his or her account. Federal law requires the Plan to automatically roll vested account balances of \$1,000 up to \$7,000 into an IRA if the participant has not reached age 65 and has not elected to have the amount paid in a single sum or rolled into another retirement plan of their choice. Distribution of a deceased participant's account will be made to the designated beneficiary. Both hardship and in-service distributions are allowed by the Plan. At December 31, 2024 and 2023, amounts allocated to withdrawing participants for benefit claims that have been processed and approved for payment, but not yet paid is \$2,480 and \$0, respectively.

**Termination**

Although termination of the Plan is not presently contemplated, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their respective accounts. The Company will direct the distribution of the participant's account in a manner permitted by the Plan as soon as practicable.

**Accounting Method**

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. (GAAP).

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States ("GAAP") requires the Plan to make estimates that affect the amounts reported in the financial statements, accompanying notes, and supplemental schedules. Actual results could differ from these estimates.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

**Investment Valuation and Income Recognition**

As of December 31, 2024 and 2023, investments of the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Matrix Trust Company determines the Plan’s valuation policies. Purchases and sales of investments are accounted for as of the trade date. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year and are presented in the statement of changes in net assets available for benefits.

**3. INVESTMENTS:**

The Plan’s investments held by Matrix Trust Company, a party-in-interest, (including investments bought, sold and held during the year) are stated at fair value. Fair values and appreciation (depreciation) in value are summarized as follows:

**4. FAIR VALUE MEASUREMENTS:**

Certain provisions of Accounting Standards Codification (ASC) 820 established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1 - Inputs to valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
  1. Quoted prices for similar assets or liabilities in active markets
  2. Quoted prices for identical or similar assets or liabilities in inactive markets
  3. Inputs other than quoted market prices that are observable for the asset or liability
  4. Inputs that are derived principally from or corroborated by observable market data, by correlation or other means
  5. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**4. FAIR VALUE MEASUREMENTS (CONTINUED):**

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques that are used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for the investments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**6. INCOME TAXES:**

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and ERISA and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the statute of limitations for the federal and state to assess taxes on a plan expires three and four years from the due date of the return or the date on which it was filed, whichever is later.

**7. RISKS AND UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits. The ultimate effect of the current economic conditions cannot be determined at this time.

**8. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS:**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or relatives of such persons.

Plan investments in the self-directed brokerage fund are managed by the Custodian; therefore, these transactions qualify as party-in-interest transactions. Transactions with parties-in-interest also include fees paid during the year for trustee, accounting, and other services, as well as contributions paid to the Plan by the Company and loans made to participants. All of these transactions are exempted from prohibited transaction rules under ERISA.

**8. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS  
(CONTINUED):**

Fees incurred by the Plan for the investment management services are included in the net appreciation in fair value of the related investment, as they are paid through revenue sharing rather than a direct payment. During 2024, the Plan made direct payments of \$15,730 for administration and advisory fees. The Plan sponsor pays directly any other fees related to the operation of the Plan.

**9. PROHIBITED TRANSACTIONS:**

As required by ERISA Section 2510.3-102, the Plan sponsor is required to segregate employee contributions to the Plan from its general assets as soon as practicable. Unsegregated late contributions are considered prohibited transactions. Total contributions for the affected pay periods were \$43,969, all of which represented employee salary deferrals.

The Company has calculated lost investment earnings of \$24 related to the affected pay periods and has compensated the Plan for the lost earnings in May 2024. See supplemental information for Schedule of Delinquent Participant Contributions.

**10. SUBSEQUENT EVENT:**

Management has evaluated subsequent events through October 1, 2025, the date at which the financial statements were available to be issued. No significant subsequent events were discovered by management.
