## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and the Participants of  
the SC3 401(k) Retirement Savings Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the SC3 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the SC3 401(k) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the SC3 401(k) Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the SC3 401(k) Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the SC3 401(k) Retirement Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the SC3 401(k) Retirement Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedules Required by ERISA**

The supplemental schedule of nonexempt transactions for the year ended December 31, 2024 and schedule of assets held as of December 31, 2024 are presented for the purpose of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### 1. DESCRIPTION OF THE PLAN

The following description of the SC3 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan established March 1, 2008 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers former employees of the Strategic Intelligence Group, Computer Security Solutions, Inc., SC3, LLC, and Catapult Technology, Ltd. (the Company or SC3), with the exception of leased employees and nonresident aliens who do not receive any earned income from the Company which constitutes United States source income. The Plan was amended on December 29, 2017 to change the Plan Sponsor to General Dynamics Corporation (GDC); however, not all employees of GDC and affiliates are eligible to participate in the Plan. As of December 29, 2017, only former employees of SC3 and related affiliates were eligible to participate. The Plan was frozen effective December 31, 2018. The Plan was amended and restated effective September 24, 2021 to reflect required regulatory changes and was most recently amended effective June 30, 2023, to allow participants to elect distributions under a systematic withdrawal plan.

The Plan Oversight Committee of the Company oversees the operation and administration of the Plan. Fidelity Management Trust Company serves as the Trustee of the Plan. The custodian and recordkeeper of the Plan is Fidelity Investment Institutional Operations Company, Inc. (Fidelity), who is responsible for its administration.

#### **Participant Contributions**

Prior to the Plan being frozen effective December 31, 2018, participants were able to defer up to 100% of their compensation, as defined by the Plan, not to exceed the maximum allowable contribution under Section 402(g) of the Internal Revenue Code (the Code). Participants were also able to contribute post-tax Roth elective contributions. A participant's Roth elective contributions are allocated to a separate account maintained for such contributions. Roth elective contributions were treated as elective contributions for all purposes under the Plan. Participants were permitted to make rollover contributions from other qualified plans.

#### **Company Contributions**

Prior to the Plan being frozen effective December 31, 2018, the Company made safe harbor matching contributions of 100% on the first 4% of participant deferrals. Such contributions were calculated and contributed on a per payroll basis.

Prior to the Plan being frozen effective December 31, 2018, at the discretion of management, an additional matching contribution could be made on behalf of each eligible participant in an amount equal to a percentage of the eligible contributions made by each eligible participant during the Plan year.

#### Company Contributions – cont'd.

Prior to the Plan being frozen effective December 31, 2018, additional discretionary non-elective profit sharing contributions could be made at the option of the Company's management. Such contributions were allocated based on employee groups and relative eligible compensation for each participant. To be eligible to receive a discretionary non-elective profit sharing contribution, participants must have been employed on the last day of the Plan year. Contributions were subject to certain limitations.

#### Participant Accounts

Each participant's account is participant-directed and credited with the participant's contributions and Company contributions in accordance with the investment options selected by each participant. Plan earnings, losses, and administrative expenses are allocated to each participant's account based upon the balance in each account. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

#### Vesting

Participants are vested immediately in their contributions and the Company's safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's profit sharing and additional matching contributions are based on years of continuous service. Generally, profit sharing contributions are vested after three years of service and additional matching contributions are vested after two years of continuous service. However, additional vesting schedules may apply based on employee groups. Also, the Plan has preserved prior vesting schedules for certain participants hired prior to January 1, 2012. Upon reaching normal retirement age (age 65), death, plan termination, or disability during employment at the Company, a participant becomes 100% vested in his or her Company contributions.

#### Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balance, not to exceed \$50,000, without regard to the intended use of the funds. The minimum note amount is \$1,000. Participants may have no more than two notes outstanding at any given time. Notes are collateralized by the participant's vested account balance. Note repayments are facilitated directly by participants with interest based on rates comparable to those offered by financial institutions at the time of note origination. Notes for reasons other than the purchase of a primary residence are to be repaid within five years. Notes for the purchase of a primary residence may be repaid over a ten year period. Participants who work with participating companies that have adopted the Plan (see Note 1) will continue to be subject to the Plan provisions of their prior plan if the provisions of the prior plan are more advantageous. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Notes will be considered in default if any loan payment is not paid within 90 days of the payment due date.

#### Payment of Benefits

Upon termination of service, death, disability, or attainment of age 59½, a participant or his or her beneficiary in the event of death, is entitled to a distribution of his or her vested account balance. If the vested balance in a participant's account is at least \$5,000, such amount may be distributed in cash, rolled over into another employer's qualified plan or into an individual retirement account (IRA) of the participant's choice, or the vested balance may remain in the Plan and will be considered an inactive participant account. Terminated participants with a vested account balance of less than \$1,000 will receive an automatic lump-sum cash distribution upon termination. If the vested account balance is greater than \$1,000 but less than \$5,000, and the participant does not elect to have such distribution paid directly to an eligible retirement plan, the distribution will be paid in form of a direct rollover to an IRA designated by the Plan administrator.

Upon proof, to the satisfaction of the Plan administrator of an immediate and heavy financial need, the participant's vested account balance may be withdrawn for a hardship purpose. Certain income taxes and penalties may apply to distributions taken prior to age 59 ½.

Distributions are subject to the applicable provisions of the Plan agreement. Benefit payments to participants are recorded upon distribution. As of December 31, 2024 and 2023, there were no net assets available for benefits of the Plan allocated to participants who had elected to withdraw from the Plan but had not received such distributions prior to year-end.

#### Forfeitures

Participants forfeit their non-vested balances upon five consecutive years of termination or distribution of their entire vested balance. As of December 31, 2024 and 2023, forfeited non-vested accounts, on an accrual basis, totaled \$173,813 and \$128,145, respectively. These accounts are to be used to pay Plan expenses and to reduce Company contributions. The forfeitures used to pay Plan expenses were not significant for the year ended December 31, 2024.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

#### Risks and Uncertainties

The Plan provides for investments in assets that are exposed to risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of these investments could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received by the Plan to sell an asset or paid by the Plan to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain administrative expenses are paid by the Company on behalf of the Plan. The Plan Document provides that the Company is entitled to reimbursement for expenses paid by the Company on behalf of the Plan. The Company did not seek reimbursement for these expenses in 2024. The administrative expenses paid by the Company on behalf of the Plan were not significant for the year ended December 31, 2024.

### 3. INVESTMENTS

All investment information contained in the accompanying financial statements and supplemental schedules, including assets held as of December 31, 2024 and 2023, and interest and dividend income and net appreciation in the fair value of investments for the year ended December 31, 2024, was obtained or derived from the information supplied to the Plan administrator and certified as complete and accurate by the Trustee of the Plan, Fidelity Management Trust Company.

### 4. FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Interests in registered investment companies:* Valued at the closing price reported in the active market in which the individual funds are traded (Level 1).

*Interest in common/collective trust:* The fair value of this investment security is determined using the net asset value as provided by the fund manager (Level 2). Investments in the collective trust are redeemable daily at net asset value, and there are no restrictions on redemptions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

### 5. INCOME TAX STATUS

Effective September 24, 2021, the Plan adopted a preapproved plan, which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020. The Plan has been amended since receiving the latest favorable opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. There are currently no audits in progress for any tax periods. Under the applicable IRS statute of limitations, the Plan is no longer open to income tax examinations for years prior to 2021.

### 6. OPERATIONAL FAILURES

The Company and Plan Sponsor performed a review of participant data from prior years (2014-2016). Corrections, if any, are not both probable or estimable at this time. The Plan Sponsor, with the assistance of legal counsel, filed an application for a compliance statement under the IRS Voluntary Correction Program during 2024. The submission requested a review and approval by the IRS of applicable proposed Plan correction methodology.

Corrections are not estimable until such approval. As of the date of the financial statements, the corrections are pending IRS review and approval. If corrections related to Plan operations are deemed to be necessary, the Company intends to correct each of the operational failures in accordance with the IRS Employee Plans Compliance Resolution System described most recently in Revenue Procedure 2021-30.

### 7. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Fidelity, which is a related entity to the Trustee. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each fund. The Plan allows participants to take out notes against their vested account balances. The Company provides certain accounting and administrative services to the Plan for which no fees are charged. Such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

### 8. PLAN TERMINATION

Although it has not expressed the intent to do so, the Company has the right under the Plan to discontinue, modify, amend or terminate the Plan in total, or in part, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### 10. NONEXEMPT TRANSACTIONS
