Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Ace Metal Crafts Co 401(k) Profit Sharing & Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 – PLAN DESCRIPTION

The following description of Ace Metal Crafts Co 401(k) Profit Sharing & Retirement Plan (the "Plan") provides only general information. The Plan document, related adoption agreement, and individual statements provided to each Plan participant should be referred to for more complete information.

A. GENERAL

The Plan is a defined contribution plan established on October 30, 1985 of Ace Metal Crafts Co. and any of its affiliated companies (the "Company"), under the provisions of Section 401(a) of the United States Internal Revenue Code (the IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company and any adopting participating employers.

The Plan investments are administered and held in a trust by the Plan's investment custodian, Empower Trust Company, LLC, (the "Investment Custodian"), which also serves as the recordkeeper of the Plan. The Plan administrator is responsible for overseeing and ensuring compliance with the Plan document. The Investment Custodian, recordkeeper and the Plan administrator are appointed by the Company.

B. ELIGIBILITY

Employees of the Company who have attained the age of 21, completed one year of service with 1,000 hours are eligible to participate in the Plan provided the employee is not part of unions covered under a collective bargaining agreement ("CBA"), unless such agreement provides for participation in the Plan. Eligible employees may participate in the Plan on the first day of the quarter following their fulfillment of the service-eligibility requirement.

C. PARTICIPANT CONTRIBUTIONS

Participants may contribute up to 100% of their eligible compensation, as defined by the Plan, on either a pretax or after tax (Roth) basis, subject to maximum deferral limitations established by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

D. EMPLOYER CONTRIBUTIONS

The Company may contribute a discretionary matching amount. For the year ended December 31, 2024, the Company matched 25% of participant contributions, up to 6% of the participant's eligible compensation, totaling \$35,995. Matching contributions were temporarily suspended during interim period for approximately four and half months, with no match being made during that time. The suspension was applied uniformly to all participants.

In addition, the Plan allows for a Company discretionary non-elective contribution to be made to eligible employees, as defined by the Plan. No such discretionary non-elective contributions were made by the Company for the year ended December 31, 2024.

E. PARTICIPANT ACCOUNTS

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan administrator establishes and maintains a separate account for each participant, which is credited with rollover and voluntary contributions the participants make, Company contributions, and Plan earnings, gains, losses and expenses. Income earned and net appreciation or depreciation on Plan investments, for a given investment, are allocated in proportion to the participant's account balances in that fund. A participant is entitled to the amount in his or her vested Plan account.

F. VESTING

All participant salary deferral contributions, rollover contributions and earnings thereon are immediately vested. Participants vest in their Company discretionary matching and nonelective contributions on a graduated basis based on years of vesting service, as defined by the Plan:

A participant becomes fully vested upon attainment of normal retirement age while an employee, death while an employee, or upon suffering a disability while an employee. Vesting years are subject to minimum hours requirement.

G. PAYMENT OF BENEFITS

The normal retirement age is defined as when the participant reaches the age of 65. At the normal retirement date, death, or disability, a participant (or participant's beneficiary in the event of death) is entitled to 100% of their account balance. The Plan does not provide for a retirement date prior to the normal retirement date. A participant, who becomes disabled, as defined in the Plan document, is eligible for a disability retirement, as defined.

Upon retirement, hardship, termination, death or disability, or attainment of age 59 ½, vested benefits are distributed at the participant's or beneficiary's election via a lump sum distribution or partial installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Hardship withdrawals are also permitted from participant's deferral amounts for specific situations as defined by the Plan. For those participants taking withdrawals in excess of the Required Minimum Distributions per the IRC can elect various forms of installments.

G. PAYMENT OF BENEFITS – (CONTINUED) –

On termination of service, participants or beneficiaries with an account balance of less than \$1,000 will automatically receive a lump-sum distribution in the first Plan year beginning the year after employment is terminated. If the account balance is over \$1,000 but does not exceed \$5,000, the distribution will be rolled over automatically to an IRA if the participant does not elect to receive or rollover the distribution. If the account balance is greater than \$5,000, participants or beneficiaries may elect to receive the benefit in a single lump-sum payment or partial installments. Spousal beneficiaries may make a direct rollover to an IRA.

H. PLAN EXPENSES

Administrative expenses, including preparation fees for filing the annual return with the Internal Revenue Service, costs associated with the annual audit of the plan, and record-keeping and custodian fees are to be paid out of the Plan or by the Company. When paid from the Plan, expenses are covered first by forfeitures, if any, with remaining amounts paid from the Plan's trust funds and allocated to participants on a pro rata basis. Company-paid expenses are not reflected in these financial statements. Recordkeeping fees are charged directly to participant accounts utilizing a plan revenue sharing account and are included in administrative expenses and included in administrative expenses. Investment expenses are allocated to participants based on their account balances. Investment-related expenses are allocated proportionately to participants based on their respective account balances.

I. PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, no further contributions will be made to the Plan and all amounts credited to the participant's account will become 100% vested. The Company will direct the distribution of the participants' account in a manner permitted by the Plan as soon as practicable. Presently, there is no intention on the part of the Company to terminate the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. FINANCIAL REPORTING FRAMEWORK AND BASIS OF ACCOUNTING

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with U.S. GAAP, as promulgated by the Financial Accounting Standards Board ("FASB") in the Accounting Standards Codification ("ASC").

B. ESTIMATES

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are stated at contract value, see Note 7). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments, including realized gains and losses on sales during the year and current changes in unrealized appreciation (depreciation) in the market value of investments held at year end, is presented in the statement of changes in net assets available for benefits.

D. CONTRIBUTIONS

Contributions from Plan participants and employer contributions, if any, are recorded in the year in which the participant contributions are withheld from compensation.

E. PAYMENT OF BENEFITS

Benefit payments to participants or beneficiaries are recorded when paid.

F. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

G. SUBSEQUENT EVENTS

The Plan evaluated subsequent events through October 8, 2025, which is the financial statement issuance date. All items which are required for disclosure have been included in the accompanying financial statements and notes thereto.

NOTE 3 – FORFEITURES

According to the Plan document, forfeitures are to be used to pay for administrative expenses and to be applied to future employer matching contributions. Forfeited, non-vested account balances were approximately \$6 and \$27,800 as of December 31, 2024 and 2023, respectively. Approximately \$32,000 of forfeiture was used to reduce employer contributions and pay for administrative expenses for the year ended December 31, 2024.

NOTE 4 – INFORMATION PREPARED AND CERTIFIED BY TRUSTEES

The Plan's investments are held in a trust fund administered by the Investment Custodian, the trustee of the Plan. The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by the Trustee.

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income (loss) and other income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 5 – TAX STATUS

The Plan sponsor adopted a plan which received a favorable determination letter from the Internal Revenue Service dated June 30, 2020, which states that the Plan is designed in accordance with the applicable sections of the IRC and is, therefore, not subject to tax under present income tax law. The Plan has been amended since receiving the determination letter. The Plan is required to operate in conformity with the IRC to maintain its qualifications. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not, based on the technical merits, would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the statute of limitations for the IRS to assess taxes on a plan expires three years from the due date of the return or the date on which it was filed, whichever is later.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

A related party is any party who can control or significantly influence Plan management or operating policies. Parties-in-interest are defined under DOL regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator ("TPA"), investment managers, investment advisors, legal counsel, and Plan auditor.

Certain investment assets of the Plan are managed by Empower. Empower is Trustee of the Plan, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. As of December 31, 2024 and 2023, investment assets classified as party-in-interest transactions totaled \$979,235 and \$730,907, respectively.

NOTE 7 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan has a fully benefit-responsive group annuity contract with the Investment Custodian, which is called the Key Guaranteed Portfolio Fund. The contract is a traditional investment contract. The Investment Custodian maintains the contributions in an unallocated fund, which is included in its general account, to which it adds interest. Since the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The group annuity contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The account balances were \$979,235 and \$730,907 as of December 31, 2024 and 2023, respectively.

Certain events limit the Plan's ability to transact at contract value with the insurance company including plan termination and other events as specified in the group annuity contract. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The insurance company may not terminate the contract at any amount less than the contract value.

The insurance company is contractually obligated to pay the principal and specified interest rate that is guaranteed by the Plan. The crediting interest rate is based on a formula agreed upon with the insurance company. Such interest rates are reviewed on a quarterly basis for resetting. The crediting interest rate is based on a formula established by the contract issues but may not be less than zero percent. The average interest for 2024 and 2023 was 1.41% and 1.23%, respectively.

NOTE 8 – FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement).

In accordance with the framework, the Plan groups assets and liabilities measured at fair value into three levels based on the markets in which the assets and liabilities are traded and the reliability of the assumptions used to determine fair value. These levels are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 8 – FAIR VALUE MEASUREMENTS – (CONTINUED) –

The asset’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuations techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds — valued based on the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
