## **INDEPENDENT AUDITOR'S REPORT**

To the Board of Trustees of  
**Fred Haas Interests 401(k) Plan**

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Fred Haas Interests 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Fred Haas Interests 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). **NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Fred Haas Interests 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**

The Plan has adopted a nonstandardized prototype plan from Empower Retirement LLC. The plan sponsor is Fred Haas Motors, Ltd. The Plan is established for the benefit of the employees of Fred Haas Motors, Ltd., Fred Haas Country, L.P., and Fred Haas Nissan, L.P. (collectively, the “Companies”). The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan covers all employees who have completed 2 months of service and have attained the age of 21. Entry dates into the Plan are the first day of each month following the satisfaction of eligibility requirements. The Plan is participant directed and participants may change their investment options at any time.

**Contributions**

Participants may elect to make pre-tax and/or Roth salary deferral contributions to the Plan up to 75% of their annual eligible compensation, but not more than the limit established by the Internal Revenue Service (IRS). Roth elective contributions are made after-tax. Participants age 50 or over in the plan year may also make catch-up contributions into the Plan. Participants may change their contribution rates on the first day of each month or elect to stop contributing at any time.

The Plan allows for participants in a former employer’s qualified plan to contribute direct rollovers to the Plan prior to meeting the Plan’s eligibility requirements.

The Companies may, at their discretion, contribute for each participant a matching contribution equal to a percentage of each participant’s elective contribution. The Companies made matching contributions equal to 10% of each participant’s contribution up to 4% of each participant’s eligible compensation on a pay period basis.

The Companies may also make an additional discretionary contribution, which shall be allocated to each eligible employee in proportion to his or her eligible compensation as a percentage of the eligible compensation of all eligible employees. No such contributions were made during 2024.

**Participant Accounts**

Each participant’s account is credited with the participant’s contributions and the Companies’ contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

For vesting purposes, a participant must be credited with at least 1,000 hours during the plan year to qualify as one year of service and count toward vesting. Participants are at all times fully vested in their participant and rollover contribution accounts and the appreciation or depreciation thereon. Vesting in the Companies' contributions portion of their accounts plus earnings thereon is based on years of continuous service. Participants vest 20% per year after two years of service and are 100% vested after six years of service. A participant shall be immediately vested upon death, retirement, or termination of employment due to permanent disability.

**Forfeited Accounts**

Forfeitures of nonvested employer contributions shall be used to reduce the Companies contributions or pay Plan administrative expenses. The forfeitures balance was \$1,451 and \$3,169 at December 31, 2024 and 2023, respectively. During 2024, forfeitures of \$9,770 were used to reduce the Companies' contributions, and no forfeitures were used to pay Plan administrative expenses.

**Payment of Benefits**

Participants may elect to withdraw any part of their vested account balance upon retirement, termination of employment, death or disability, or attainment of age 59½. Normal retirement age is 65. Hardship withdrawals of vested balances due to immediate and heavy financial need are also permitted, subject to the terms of the Plan document.

Distributions from the Plan are made in lump-sum payments or in alternative structures as allowed by the Plan. All vested benefits in the Plan that are less than \$7,000 may be distributed in a single lump-sum payment without consent from the terminated participant.

**Plan Termination**

Although it has not expressed any intent to do so, the Companies have the right to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested and receive benefits based on their account balances accumulated to the date of termination of the Plan.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Investment Valuation and Income Recognition**

Investments are reported at fair value except for a fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. The plan administrator is responsible for determining the Plan's valuation policies utilizing information provided by the investment advisors. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes gains and losses on investments bought and sold, as well as held during the year.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Companies and are excluded from these financial statements. Fees related to record keeping, advisory services, and participant related services are allocated to participants' accounts and are included in administrative expenses. Other investment-related expenses are included in net appreciation in fair value of investments.

**Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

**Contributions**

Contributions from Plan participants and the matching contributions from the Companies are recorded in the plan year in which the participant contributions are withheld from compensation.

**Nondiscriminatory Refunds**

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Code (IRC) are recorded as a liability. At December 31, 2024 and 2023, liabilities of \$120,997 and \$73,266, respectively, are recorded for amounts refundable by the Plan. The Plan distributed the nondiscriminatory refunds to the applicable participants in 2025 and 2024, respectively.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

Various inputs are used in determining the fair value of the Plan's investments. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy, including the types of Plan investments that fall under each category and the valuation methodologies used to measure fair value, are described below:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Level 2* - Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

*Level 3* - Inputs to the valuation methodology are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The inputs and methodologies used for valuing securities are not an indication of the risk associated with investing in those securities. There have been no changes in the methodologies used at December 31, 2024 or 2023.

**NOTE 4 - CONTRACT VALUE INVESTMENT**

The Plan has a group annuity contract with Empower Annuity Insurance Company of America (EAICA) that invests contributions in the Key Guaranteed Portfolio Fund. The Key Guaranteed Portfolio Fund is a general account product. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Contract value, as reported to the Plan by EAICA, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. EAICA, as the contract issuer, is contractually obligated to repay the principal and interest at a specified crediting interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Interest is credited on the balance using a single “portfolio rate” approach. Under this methodology, a single interest-crediting rate is applied to all contributions made to the contract regardless of the timing of those contributions. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The crediting interest is reset quarterly.

Certain events limit the ability of the Plan to transact at contract value with EAICA. Such events include the following: (i) amendments to the Plan document (including complete or partial Plan termination or merger with another plan), (ii) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (iii) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the Plan, or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions exemption under ERISA.

The plan administrator does not believe that the occurrence of any such events, which would limit the Plan’s ability to transact at contract value with participants, is probable.

**NOTE 5 - INFORMATION CERTIFIED**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, custodian of the Plan, has certified to the completeness and accuracy of all investments reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, and the related investment income reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS**

The Plan provides for investments in a contract account managed by an entity affiliated with Empower Trust Company, LLC. Empower Trust Company, LLC is the custodian of the Plan and, therefore, qualifies as a party in interest. This transaction is covered by an exemption from the prohibited transaction provisions.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan provides for various investments. In general, such investments are exposed to various risks such as significant world events, interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 - INCOME TAX STATUS**

The Plan has adopted a nonstandardized prototype plan, which obtained its latest opinion letter dated November 14, 2022 in which the IRS stated that the prototype document satisfies the applicable provisions of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, contributions to the Plan and earnings from its assets are not currently taxable to the Plan or its participants.

**NOTE 9 - INCOME TAX STATUS (CONTINUED)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 10 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued.
