INDEPENDENT AUDITOR'S REPORT

To the Participants and Administrator of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Starboard Group 401(k) Plan, (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 6, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period January 1, 2024 to December 6, 2024 and for the year ended December 31, 2023, and the related notes to the financial statements.

NOTES TO THE FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Starboard Group 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is administered by John Hancock Life Insurance Company, appointed by Management of Starboard Group Employment Services (the “Company”). The Plan was established effective October 1, 2014.

Eligibility

Employees who complete two months of service with the Company and attain the age of at least 21 years old are eligible to join the Plan.

Crew Members are eligible if they are at least 21 years of age, complete two (2) Months of Eligibility Service and enter the plan coincident with or next following the a) first day of the first month of the Plan Year or b) first day of the seventh month of the Plan Year. "Year of Eligibility Service" for employees paid on an hourly basis means an Eligibility Computation Period during which the employee completes at least 1,000 hours of service.

Contributions

Participants may enter the plan on the first day of the first and seventh month of the plan upon the attainment of eligibility requirements. Each year, participants may contribute up to 100 percent of pre-tax or after-tax (Roth 401k) eligible compensation, as defined in the plan, subject to certain limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Active participants may also contribute amounts representing distributions from other qualified benefit or defined contribution plans.

The Company may make discretionary matching contributions equal to a uniform percentage of a participant’s salary deferral. Each year, the Company will determine the discretionary percentage. The Company did not make discretionary matching contributions for the period January 1 to December 6, 2024 and for the year ended December 31, 2023.

Participants may direct the investment of their contributions into various pooled separate accounts offered by the plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's contribution and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in the participant’s account. Loans must bear a reasonable rate of interest, not to exceed the legal limit. The interest rate is determined by the Certifying Entity and is reevaluated every quarter.

NOTE 1 – DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately vested in their own contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested after four years of credited service.

A participant will also be 100% vested under any of the following circumstances:

- Death before retirement date.
- Disability before retirement date.
- Attainment of normal retirement age.
- Termination of the Plan.

Payment of Benefits

Participants may receive an amount equal to the value of their vested interest upon termination of employment, death, disability or retirement. On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest, or annual installments over a ten year period. For termination of service due to other reasons, a participant may receive the value of the vested interest as a lump sum distribution.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions to net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants / Participant Loans

Participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 6, 2024 and December 31, 2023.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

Risk and Uncertainties

The Plan provides for various investment options. These investments are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of such investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits and statement of changes in net assets available for plan benefits.

Income Taxes

The Plan has adopted a standardized prototype plan. The prototype plan received a favorable determination letter from the IRS on March 31, 2014, which stated that the plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the plan has been amended, since receiving the determination letter, the plan administrator believes the plan is designed and is currently operating in compliance with the applicable requirements of the IRC and therefore believes that the plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that for the period January 1, 2024 to December 6, 2024 and for the year ended December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

NOTE 3 – INFORMATION CERTIFIED BY THE CERTIFYING ENTITY

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 6, 2024 and December 31, 2023, and net appreciation in fair value of investments and interest income on notes receivable from participants for the period January 1, 2024 to December 6, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company, the Certifying Entity of the Plan.

NOTE 4 – PARTY-IN-INTEREST TRANSACTIONS

John Hancock Life Insurance Company is the Certifying Entity of the Plan and qualifies as a party-in-interest per Department of Labor guidelines.

Certain employees of the Plan had outstanding loans (notes receivable from participants) with the Plan as of December 31, 2023. These loans are considered party-in-interest according to Department of Labor Guidelines. Total notes receivable as of December 6, 2024 and 2023 were \$0 and \$107,689, respectively.

NOTE 5 – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits.

ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available. ASC 820 establishes a three-level valuation hierarchy for measurement and disclosure of fair value. The valuation hierarchy is based upon the transparency of inputs used to measure fair value. The three levels are as follows:

Level 1 – asset value is based on actual quoted prices in active markets for identical securities (mark-to-market).

Level 2 – other significant observable inputs are used to arrive at fair value (including yield, quality, coupon rate, maturity, issue type, quoted prices for similar securities, prepayment speeds, trading characteristics, etc.).

Level 3 – significant unobservable inputs (including management's own assumptions in determining the fair value of investments).

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

NOTE 5 – FAIR VALUE MEASUREMENTS (Continued)

The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 6, 2024 and December 31, 2023.

General account –unallocated contracts: Unallocated contracts consist of cash. These are Level 1.

Pooled separate accounts: Valued, as a practical expedient, at the net asset value (NAV) of units held by the plan at year end. The NAV of these accounts is based on the market value of its underlying investments. The NAV is not a publicly-quoted price in an active market.

The Plan’s investments at December 31, 2024 and December 31, 2023 are reported at fair value in the accompanying statement of net assets available for benefits.

On May 1, 2024, the Company exercised its right under the Plan to discontinue its contributions and to terminate the Plan subject to the provisions set forth in ERISA. Because the plan was terminated, all assets were distributed. As of December 6, 2024, the Plan had zero net assets available for benefits.
