Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Notes to Financial Statements

December 31, 2024

1. Description of the Plan

The following brief description of Garden City Hospital Osteopathic Employee Pension Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document and Summary Plan Description for more complete information.

General

The Plan is a noncontributory defined benefit pension plan that covers substantially all employees of Garden City Hospital (the “Hospital”) and provides for retirement, death, disability, and termination benefits. Participants’ benefits vest after five years of credited service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended. The Hospital is the Plan’s sponsor and serves as plan administrator.

Effective May 15, 2004, the Plan was frozen to new participants, and no additional benefits accrue to existing participants.

Pension Benefits and Vesting

Employees with five or more years of service are entitled to annual pension benefits beginning at normal retirement age 65 equal to 1.25% of their highest five-year average annual compensation out of the ten latest consecutive years for each year of service earned prior to January 1, 2002. After January 1, 2002, employees with five or more years of service are entitled to annual pension benefits beginning at normal retirement age 65 equal to 0.50% of their highest five-year average annual compensation out of the ten latest consecutive years for each year of service earned multiplied by their sum of years of service, or benefit service. The Plan permits early retirement at ages 60 to 64. If employees terminate before rendering five years of service, they forfeit the right to receive the portion of their accumulated plan benefit. Employees may elect to receive the value of their accumulated plan benefit as a lump-sum distribution upon retirement or termination up to \$10,000, or they may elect to receive their benefit as a life annuity payable monthly from retirement. The Plan also permits in-service distributions for participants who have attained age 62. Such benefit shall be equal to the early retirement benefit the participant would have received had the participant retired and elected early retirement.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Death and Disability Benefits

If an active employee dies at age 60 or older, a death benefit equal to the value of the employee's accumulated plan benefit is paid to the employee's beneficiary. Active employees who become totally disabled receive annual disability benefits that are equal to the normal retirement benefit they have accumulated as of the time they become disabled. Disability benefits are paid until normal retirement age at which time disabled participants begin receiving normal retirement benefit computed as though they had been employed to normal retirement age with their annual compensation remaining the same as at the time they became disabled.

Use of Estimates

The preparation of financial statements in conformity with the United States (U.S.) generally accepted accounting principles (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements. Actual results could materially differ from those estimates.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements have been prepared in accordance with U.S. GAAP, using the accrual basis of accounting.

Investment Valuation

The investments are held by Principal Bank, Principal Trust Company (Trustees) and John Hancock Life Insurance Company (Custodian) as of December 31, 2024, and 2023. Investments are stated at fair value.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurement.

Notes to Financial Statements (continued)

2. Summary of Significant Accounting Policies (continued)

Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net appreciation or depreciation in fair value of investments consists of both the realized gains or losses and unrealized appreciation or depreciation of those investments.

Payment of Benefits

Benefit payments are recorded when paid.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Administrative Expenses

The Plan's expenses are paid by the Plan or the Hospital.

Notes to Financial Statements (continued)

3. Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries.

The accumulated plan benefits for active employees are based on their average compensation in the duration of five years ending on the date as of which the benefit information is presented (the valuation date). Benefits payable under all circumstances (retirement, death, disability, and termination of employment) are included, to the extent they are deemed attributable to employee service, rendered to the valuation date.

The actuarial present value of accumulated plan benefits is determined by an actuary and is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

Significant assumptions underlying the actuarial computations as of December 31, 2023 and 2022, are as follows:

Interest rate:	6.00% in 2023 and 2022
Inflation rate:	2.40% increase per year
Mortality rates:	December 31, 2023, mortality is based on Pri-2012 dataset base rate mortality table projected generationally using the Principal Mortality Improvement Scale (Principal 2024). December 31, 2022, mortality is based on Pri-2012 dataset base rate mortality table projected generationally using the Principal Mortality Improvement Scale (Principal 2023).
Retirement:	Various rates ranging from 10% at age 60 to 100% at age 65

The increase in interest due to decrease in the discount period caused a \$2,664,506 increase in the actuarial present value of accumulated plan benefits. As noted above, plan management purchased an annuity contract on behalf of the Plan which reduced the 2023 accumulated plan benefit obligation by \$23,127,478. Refer to Note 6 for further information.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits.

4. Funding Policy

Contributions to provide benefits under the Plan are made solely by the Hospital. The Hospital's funding policy is to make contributions to the Plan in amounts as determined by the Plan's independent actuary. Under the minimum funding requirements of ERISA and the Internal Revenue Codes (IRC) as amended by the Pension Protection Act of 2006, the Hospital made \$997,579 and \$1,893,916 in contributions for each of the years ended December 31, 2024 and 2023, respectively. The Hospital met the minimum funding requirements of ERISA for the years ended December 31, 2024 and 2023.

5. Fair Value Measurement

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation techniques are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation techniques include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation techniques are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

5. Fair Value Measurement (continued)

The following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Registered Investment Companies (Mutual Funds)

Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

Common Collective Trust Funds

The investments held in common collective trust funds (CCT) are valued using NAV practical expedient of the CCT as reported by the issuer of the CCT. The NAV practical expedient is based on the fair value of the underlying assets owned by the CCT, minus its liabilities, and then divided by the number of units outstanding. There are no redemption restrictions or unfunded commitments on the CCTs.

Guaranteed Investment Contract

The guaranteed investment contract held by the Custodian is part of the general corporate funds of John Hancock and allocated to reserve and contingency funds.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Purchase of Annuity Contract

On September 6, 2023, the plan sponsor consummated a purchase agreement with Principal Life Insurance Company as insurer, for a nonparticipating single premium group annuity contract. A single premium of \$23,127,478, to fund the group annuity contract, was paid from the assets of the Plan. The annuity contract was accepted by 549 participants.

7. Unallocated Annuity Contract

The Plan is party to a contract with John Hancock under which the Plan previously contributed a specified amount, and John Hancock maintains the contributions in an unallocated annuity fund to which the contributions earn interest at market rates. The balance in the fund is guaranteed never to be less than the aggregate contributions made to the accumulation fund, less all expenses, taxes, and amounts withdrawn to pay benefits. There are no guarantees as to the amount of interest. At the direction of the plan administrator, monthly payments are made to John Hancock to reimburse them for the benefits of retirees paid that are covered by the contract. There were no unfunded commitments as of December 31, 2024 and 2023. The balances held in the guaranteed investment contract with John Hancock are \$376,918 and \$416,669, as of December 31, 2024 and 2023, respectively.

8. Information Certified by the Trustees and Custodian

Other than the Plan's investment in common collective trust funds of \$11,188,603 and \$9,773,040 as of December 31, 2024 and 2023, respectively, and the related net (depreciation) appreciation of \$(826,438) and \$935,032 during the years then ended, information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net (depreciation) appreciation in fair value of investments, and interest and dividends for the years then ended, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by the Trustees and Custodian, as applicable.

9. Tax Status

The Plan has received a determination letter from the Internal Revenue Service dated July 20, 2017, stating that the Plan is qualified under Section 401(a) of the IRC and therefore, the related trust is exempt from taxation. Subsequent to this determination by the Internal Revenue Service, the Plan was amended and restated. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. The plan administrator has indicated that it will take the necessary steps, if any, to maintain the tax-qualified status of the Plan.

9. Tax Status (continued)

In accordance with guidance on accounting for uncertainty in income taxes, the plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Transactions with Parties-in-Interest

The Hospital is the plan sponsor and administrator. Plan investments include an annuity contract with the Custodian. Transactions with these investments qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services to the Trustees and Custodian were \$59,218 and \$33,780 the years ended December 31, 2024 and 2023, respectively. Fees paid by the Hospital for investment management services to the Trustees and Custodian were \$255,614 and \$166,177 for the years ended December 2024 and 2023, respectively.

11. Plan Termination

In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under plan provisions in effect at any time during the five years preceding plan termination.
- Other vested benefits insured by the Pension Benefit Guaranty Corporation (PBGC) (a U.S. government agency) up to the applicable limitations (discussed below).
- All other vested benefits (that is, vested benefits not insured by the PBGC).
- All nonvested benefits.

11. Plan Termination (continued)

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination. However, there is a statutory ceiling, which is adjusted periodically, on the amount of an individual's monthly benefit that the PBGC guarantees. Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the plan sponsor and the level of benefits guaranteed by the PBGC.

12. Subsequent Events

The Plan has evaluated subsequent events through September 30, 2025, which is the date the financial statements were available to be issued.
