Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Philadelphia Marine Trade Association – International Longshoremen's Association Defined Contribution Pension Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Philadelphia Marine Trade Association – International Longshoremen's Association Defined Contribution Pension Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. DESCRIPTION OF PLAN

The following description of the Philadelphia Marine Trade Association- International Longshoremen's Association Defined Contribution Pension Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed, defined contribution plan established as a result of a Collective Bargaining Agreement between the Philadelphia Marine Trade Association and the International Longshoremen's Association. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The general administration of the Plan and the responsibility for carrying out the provisions of the Plan are maintained by a bank administered trust. The Administrator maintains participant account records and instructs the custodian to execute transactions such as benefit payments to participants. The custodian holds the assets of the Plan and executes transactions at the direction of the Board of Trustees. The custodian also reports to the Plan's management regarding investments and changes in these investments.

Eligibility

In general, employees are eligible to participate in the Plan if they are working in a job covered by a collective bargaining agreement between their employer and the Union that requires the employer to make contributions to the Plan on behalf of the employee.

Contributions

Participating contractors generally contribute to the Plan on a weekly basis. Members participating in the Plan also have the option of deferring their vacation and/or container fund benefit into the Plan.

Participants may make voluntary employee contributions subject to Internal Revenue Service Code restrictions.

The hourly employer contribution rates for the years ended December 31, 2024 and 2023 ranged from \$0 to \$6.00 per hour based upon member classification. Participating employers also contribute an additional \$0.15 per hour to cover the operating costs of the Plan and \$0.05 up to \$50,000 will be held in escrow to cover costs related to the Milliman VAPP study.

Investment Options

Upon enrollment in the Plan, a participant may elect to direct contributions or investment balances within selected investment options. A participant can elect to participate within a number of investment options offered by Fidelity Investments.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of investment income or loss. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Eligible participants are 100% vested in their individual account balance under the Plan at all times.

Payment of Benefits

Upon reaching normal retirement, permanent disability, complete withdrawal from covered employment in which no employer or participant contributions are made for 12 consecutive months, and in-service distributions subject to certain requirements vested amounts credited to a participant's account become distributable. Distributions will be made as soon as administratively feasible, following a participant's request, in the form of a lump sum payment.

Upon a participant's death, the participant's beneficiary is entitled to 100% of the participant's vested account balance.

Upon termination of service, other than for normal retirement or death, the Administrator will direct the current Trustee to pay to the participant his or her benefit in an immediate lump sum or a deferred lump sum, if certain criteria are met.

Benefits are recorded when paid.

Operating Expenses

All operating expenses are paid directly through the Plan and are offset by specific employer contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statement have been prepared on an accrual basis and present the net assets available for Plan benefits of the Plan and the changes in those net assets in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of changes in net assets available for Plan benefits during the reporting period. Actual results could differ from those estimates.

Risk and Uncertainties

The assets for the Plan are primarily financial instruments which are monetary in nature. As a result, interest rates have a more significant impact on the Plan's performance than do the effects of general levels of inflation. Interest rates do not necessarily move in the same direction or in the same magnitude as the prices of goods and services as measured by the consumer price index. Investments in funds are subject to risk conditions of the individual fund objectives, stock and bond market fluctuations, interest rate changes, economic conditions and world affairs.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Subsequent Events

Management has evaluated events and transactions occurring subsequent to December 31, 2024 for items that should potentially be recognized or disclosed in these financial statements. The evaluation was conducted through the date these financial statements were available for issue.

3. INFORMATION CERTIFIED BY THE CUSTODIAN

The Board of Trustees has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company has certified to the completeness and accuracy of all investments reflected on the accompanying statement of net assets available for benefits as of December 31, 2024 and 2023 and the schedule of assets held at end of year as of December 31, 2024, the related investment activity reflected in the statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

4. FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available. An asset's level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement.

The three levels of the fair value hierarchy under ASC 820 are as follows:

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical unrestricted assets.
- Level 2: Quoted prices in markets that are not active, or inputs that are observable either directly or indirectly, for substantially the full term of the asset.
- Level 3: Prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable (i.e. supported with little or no market activity).

Investment securities measured at fair value on a recurring basis for which the Plan has elected the fair value option, are summarized below.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during the period:

Registered Investment Co.: Valued at the closing price reported in the active market in which the individual security is traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at reporting date.

During 2024 and 2023, the Plan's investments including gains and losses on investments bought and sold, as well as held during the year appreciated (depreciated) in value by \$13,279,777 and \$18,589,153, respectively.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Board of Trustees may terminate, amend, modify or suspend the Plan in whole or in part at any time subject to the provisions of ERISA. However, in any such event, the participants' rights to their accrued benefits are nonforfeitable to the extent then funded.

7. RELATED PARTY TRANSACTIONS

Fees paid during the year for investment, legal, accounting, consulting and other professional services rendered by parties-in-interest were based on customary and reasonable rates for such services.

Certain Plan investments are shares of mutual funds managed by Fidelity Investments. Fidelity Investments is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid for investment management services are internal to the mutual funds.

The Plan has three related organizations with whom it has common trustees: the PMTA-ILA Pension Fund, the PMTA-ILA Vacation & Welfare Fund, and the PMTA-ILA Containerization Fund.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

8. TAX STATUS

The Plan adopted a non-standardized prototype plan provided by the Trustee who received its latest IRS determination letter which stated that the Plan, as designed, is in compliance with the applicable section of the Code. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. PLAN AMENDMENTS & MODIFICATIONS

Effective January 1, 2023, the Plan changed the age for the required minimum distribution from age 72 to 73 in accordance with the SECURE ACT 2.0.


