## Independent Auditor's Report

### NOTES TO FINANCIAL STATEMENTS

(See independent auditor's report)

#### 1. Description of plan

The following description of the Ashley F. Ward, Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### General -

The Plan is a defined contribution plan covering eligible employees of Ashley F. Ward, Inc. (the Company). To be eligible to participate in the Plan, an individual must be an employee of the Company who has completed at least three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code of 1986, as amended (the Code).

##### Contributions -

Participants may elect to contribute up to 100% of eligible compensation on either a pre-tax or Roth after-tax basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The combined pre-tax and after-tax contributions cannot exceed established IRS limits. Participants may also rollover to the Plan a distribution from an eligible retirement plan if the distribution qualifies as a rollover amount under the Internal Revenue Service.

The Plan allows for automatic enrollment of eligible employees at an initial salary deferral rate of 3% and increases 1% per year up to a maximum deferral rate of 10%. Employees may opt out of the automatic enrollment and increases at any time.

The Company makes a discretionary matching contribution on each participant's behalf. In 2024, the Company matched 5% of a participant's salary deferral for participants who worked one to four years with the Company, 10% for participants who worked five to nine years with the Company, and 15% for participants who worked ten or more years with the Company, with the exception of former Fi-Tech, Inc. participants. For these participants, the Company matched 50% of salary deferral contributions up to 5% of the participants' annual compensation. The Company may also, in its discretion, elect to make a profit-sharing contribution. There was no profit-sharing contribution for the year ended December 31, 2024. Contributions are subject to certain limitations.

#### Participant accounts -

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses paid by the plan. Allocations are based on the participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting -

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service or upon reaching their normal retirement date while employed.

#### Forfeited accounts -

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$67 and \$2,982, respectively. These accounts may be used to pay Plan expenses or to reduce future employer contributions. In 2024, plan used \$6,051 from forfeited non-vested accounts to pay plan expenses.

#### Investment options -

The participants direct the investment of both their own and the Company's contributions into the investment alternatives offered by the Plan. At any time, participants may also elect to reallocate existing account balances between investment alternatives or to change their investment elections for future contributions. The Plan currently offers various mutual funds and a common/collective trust as investment alternatives.

#### Payment of benefits -

Upon a participant's retirement, death, disability, termination of employment with the Company, or termination of the Plan, the participant's account is eligible for distribution in a lump sum or periodic installment payments. If a participant's vested interest is \$5,000 or less, distributions are paid in the form of a lump sum and the payment can be involuntarily distributed, payable as soon as administratively feasible.

Eligible participants who have both attained age 59-½ and have not yet separated from service may elect partial in-service withdrawals. Rollovers are eligible for distribution at any time.

In conditions of "financial hardship," as defined, a participant may apply to the plan administrator for approval to withdraw that portion of their elective deferrals necessary to meet the financial hardship, subject to the limitations of the Plan and the Code.

Upon termination of the Plan, the assets will be distributed to participants in accordance with the Plan's provisions and existing laws and regulations.

## 2. Significant accounting policies

### Basis of accounting -

The financial statements of the Plan are prepared under the accrual method of accounting.

### Estimates -

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from these estimates.

### Payment of benefits -

Benefits payments to participants are recorded when paid.

### Investment valuation and income recognition -

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on the investments bought and sold, as well as held during the year.

### Administrative expenses -

The Plan pays certain administrative expenses. The Company provides other administrative services at no cost to the Plan, which are excluded from these financial statements.

Fees related to the payment of benefits are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### Subsequent events -

Management has evaluated subsequent events through the report date, the date the financial statements were available to be issued.

### 3. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### 4. Fair value measurements

ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of fair value hierarchy under ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from, or corroborated by, observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds.* Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are considered to be actively traded.

*Common/collective trust:* Valued at the NAV of the trust. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transaction (purchases and sales) may occur daily. If the Plan initiates a full redemption of the Goldman Sachs Stable Value Collective Trust, the trustee of the fund may impose, in its sole discretion, a prior notice period of up to 12 months for any Employer initiated withdrawal of assets from the fund. At December 31, 2024, no prior period notice has been imposed. These investments are not classified within the valuation hierarchy but presented for reconciliation purposes only.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- The amount of investment income for the year ended December 31, 2024.
- The Schedule H, Line 4i – Schedule of Assets (Held at End of Year) at of December 31, 2024.

## 6. Tax status

The Plan has adopted a prototype plan which has received an opinion letter from the Internal Revenue Service (IRS) dated November 14, 2022. The letter states that the provider's prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. Furthermore, the Plan has been amended since the determination letter was received. However, the Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

## 7. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and/or to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

## 8. Party-in-interest transactions

Certain Plan investments are managed by Empower Trust Company, LLC, the asset custodian of the plan assets as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. Any fees paid by the Plan to the custodian, recordkeeper, or other service providers (such as Plan auditors and Plan advisors) are included in administrative expenses.

Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibited transaction rules of ERISA.
