To the Plan Administrator of the

**SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT**

We performed audits of the accompanying financial statements of the Corporate Brokers, LLC Retirement Savings Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**OPINION**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section:

**NOTE 1**    **DESCRIPTION OF PLAN**

The following brief description of the Corporate Brokers, LLC Retirement Savings Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

***General***

The Plan is a defined contribution plan covering all eligible full-time salaried and hourly employees of Corporate Brokers, LLC (Company), provided the employee is at least 21 years old and completes one month of service. Employees whose employment is governed by a collective bargaining agreement under which retirement benefits are the subject of good faith bargaining are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

***Contributions***

Each year, participants may contribute up to 100% of their annual compensation as defined in the Plan, subject to certain annual limitations in the Internal Revenue Code, including catch-up contributions if applicable. Participants may designate some or all of their own contributions as Roth 401(k) contributions. Participants may also rollover distributions received from qualified plans.

The Company may make discretionary contributions at any time during the Plan year. The Company did not make discretionary contributions during the year ended December 31, 2024.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, an allocation of Plan earnings, and any discretionary Company contributions. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant's account is charged with withdrawals and an allocation of administrative expenses.

***Vesting***

Participants are fully vested in their voluntary and rollover contributions. Participants will also immediately become 100% vested if they become disabled. Vesting in Company contributions is based upon years of service with full vesting obtained after six years or the attainment of normal retirement age, whichever is earlier.

***Investment Options***

Upon enrollment in the Plan, a participant may direct employee contributions into various investment options offered by the Plan. Specific information regarding these options may be

*(See Independent Auditors' Report)*

obtained from the Plan Administrator. Participants may change their investment options at any time.

***Notes Receivable From Participants***

Participants may borrow against the balance in their accounts, up to the lesser of 50% of their vested balance or \$50,000 with a minimum borrowing amount of \$1,000. Loan terms require amortization of principal and interest over a period not to exceed five years. Loans used to acquire a principal residence may extend beyond a five-year term. Loans bear interest at a rate comparable to rates charged by commercial lending institutions for loans of similar terms. Loans are repaid through payroll deductions and may be repaid in full at any time.

***Forfeitures***

Forfeited nonvested accounts will be used to reduce future Company contributions and payment of administrative expenses and restore forfeited account balances of rehired employees in accordance with the Plan agreement. There were no forfeited nonvested accounts at December 31, 2024 and 2023.

***Payment of Benefits***

Benefits are payable as soon as practicable following normal retirement, retirement due to permanent disability, death, or termination of employment, subject to specific benefit payment requirements in the Plan agreement. If the balance of the account is less than \$5,000, the balance is automatically distributed as a lump-sum payment.

***Plan Termination***

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. Upon termination of the Plan, all interest of the participants not previously vested would become vested and non-forfeitable, and the net assets of the Plan would be distributed to participants based upon individual equities in the Plan.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Accounting Standards Codification***

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

*(See Independent Auditors' Report)*

***Basis of Accounting***

The accompanying financial statements were prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with GAAP in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Valuation of Investments***

Investments are reported at fair value except for fully benefit responsive investment contracts, which are reported at contract value. See Note 4 for a discussion of fair value measurements.

***Notes Receivable From Participants***

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan agreement.

***Payment of Benefits***

Benefits are recorded when paid.

***Risk and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

***Administrative Expenses***

Substantially all administrative expenses are paid by the Plan.

***Subsequent Events***

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through September 30, 2025, the date the financial statements were available to be issued.

**NOTE 4**    **VALUATION OF INVESTMENTS**

Investments are recorded at fair value in accordance with the provisions of the Fair Value Measurements and Disclosures Topic of the Codification, which establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the Codification are described below:

Level 1    Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2    Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

*(See Independent Auditors' Report)*

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below are descriptions of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

Pooled Separate Accounts: Valued at the closing NAV of the sub accounts. NAV is quoted on a private market that is not active; however, the unit price is based on underlying investments which are traded on an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5**    **GUARANTEED INVESTMENT CONTRACT**

In 2023, the Plan had an investment in the Principal Fixed Income Guaranteed Option Account, which is a fully benefit responsive investment contract and, therefore, reported at contract value. Contract value, as reported to the Plan by Principal, represents contributions made under the fund, plus earnings, less participant withdrawals and administrative expense. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events limit the Plan's ability to transact at contract value with Principal. Such events include the following: (a) amendments to the Plan agreement (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan Administrator does not believe any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**NOTE 6**    **TAX STATUS**

In the June 2020 opinion letter for the Plan's non-standardized, pre-approved profit-sharing plan, the Internal Revenue Service stated the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan was amended since receiving the letter, and the Plan Administrator believes the Plan is currently designed and operating in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes was included in the Plan's financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded that there were no uncertain tax positions taken as of December 31, 2024.

**NOTE 7**    **RELATED-PARTY TRANSACTIONS**

Certain Plan investments are managed by the Custodian of the Plan. The Plan pays administrative fees to parties in interest. The Plan paid approximately \$33,000 to parties in interest for the year ended December 31, 2024. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA.

In addition, administrative fees were paid indirectly through revenue sharing and are included in the net appreciation in fair value of investments.
