1. DESCRIPTION OF PLAN

The following description of the A.N. Deringer, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Adoption Agreement for a more complete description of the Plan’s provisions.

- (a) General - The Plan is a defined contribution 401(k) plan established by A.N. Deringer, Inc. (the “Company”) covering all employees of the Company, except members of a collective bargaining unit, non-resident aliens, leased employees, Canadian employees, interns, and seasonal employees. Participants may join the Plan upon the attainment of age 18 and completion of one month of service. The Plan has a 3% automatic enrollment feature, and those wishing to not be included in the Plan must do so by filling out the appropriate paperwork. In accordance with the SECURE Act and SECURE 2.0, certain long-term, part-time employees may also be eligible to participate if they have completed at least 500 hours of service in three consecutive years (for plan years beginning before January 1, 2025) or two consecutive years (for plan years beginning on or after January 1, 2025), subject to the Plan’s provisions and applicable law. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- (b) Investment Allocation - Participants direct all contributions to any investments offered by the Plan.
- (c) Contributions - Eligible employees are allowed to contribute, through payroll deductions, up to their eligible compensation not to exceed Internal Revenue Service (IRS) established limits. Employees who are 50 years old before the end of the year are allowed to make catch up contributions not to exceed IRS established limits.

The Company, at its discretion, may elect to make a profit sharing contribution each year and in such amount, if any, as it may determine to the Plan. To be eligible, an employee must be 18 years of age, complete 1,000 hours of service, and actively contribute to the Plan at year end. The profit sharing contribution is determined each year as a percentage of eligible compensation or a dollar amount per participant. Total profit sharing contributions were \$263,823 and \$257,458 for the years ended December 31, 2024 and 2023, respectively.

The Company may also elect to make a matching contribution to the Plan. The Board of Directors of the Company, at its sole discretion, shall determine the amount of such optional contributions. The Company made a 1% matching contribution to the Plan totaling \$318,425 and \$305,765 for the years ended December 31, 2024 and 2023, respectively.

The Company also makes a safe harbor contribution. To be eligible, employees must attain age 18 and be a regular full or part time employee. In 2024 and 2023, the Company elected to make a safe harbor contribution of 3% of eligible compensation to the Plan. The safe harbor contribution totals were \$1,070,803 and \$1,027,026 for the years ended December 31, 2024 and 2023, respectively.

- (d) Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company’s discretionary profit sharing and matching contributions portion of the participant’s account plus actual earnings thereon is based on years of continuous service. Vesting in the discretionary profit sharing and matching contributions is zero until the completion of three years when they become 100% vested. Participants are immediately 100% vested in employer safe harbor match contributions.

- (e) Participant Accounts – Each participant’s account is credited with the participant’s contributions, the Company’s safe harbor contributions, and allocations of (a) the profit sharing contribution, (b) the Company’s discretionary matching contribution, (c) Plan earnings, and (d) forfeitures of terminated participants’ non-vested account balances. Allocations are based on participant’s eligible compensation relative to total eligible compensation, deferred contribution amounts or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- (f) Notes Receivable - A participant is permitted to borrow from their fund account a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as participant directed investments with transfer to (from) the investment fund from (to) the participant loan fund. Loan terms range from one to five years with home loan terms of thirty years. The loans are secured by the balance in the participant’s account and bear interest at 1% over the prime interest rate. Principal and interest are paid through regular payroll deductions.
- (g) Payment of Vested Benefits - Upon termination of service, benefits will be distributed as soon as administratively feasible. A participant may elect to receive a lump-sum amount equivalent to their vested benefits. Hardship distributions are permitted in an amount not to exceed the total participant’s elective deferral amount. In-service distributions are also permitted, once the participant has reached the age 59 ½ and five years of service for vesting purposes.
- (h) Unallocated Accounts - Forfeitures represent amounts which could not be paid to terminated participants due to failure to meet vesting requirements. Under the Plan, forfeitures of participants’ nonvested accounts and ERISA expense accounts may be used to reduce administrative expenses or used to reduce employer contributions, as defined by the Plan. Unallocated funds totaling \$0 and \$20,705 were used in 2024 and 2023, respectively. Unallocated funds available were \$23,118 and \$13,310 at December 31, 2024 and 2023, respectively.

2. SUMMARY OF ACCOUNTING POLICIES

- (a) Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.
- (b) Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan’s management to use estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

- (c) Investment Valuation and Income Recognition - Investments are reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Investment contracts held by a defined contribution plan are required to be reported at fair contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Unrealized gains and losses are based on the differences of beginning of the year fair values or cost if purchased during the current year, and year-end fair values. Interest and dividend income is accrued as earned.

- (d) Expenses - Expenses of administering the Plan are generally paid by the Company except for certain investment and recordkeeping fees.
- (e) Risks and Uncertainties - The Plan invests in securities, which in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.
- (f) Benefit Payments - Benefit payments are recorded when paid.
- (g) Notes Receivable - Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.
- (h) Subsequent Events - The Plan evaluated subsequent events through October 8, 2025, the date the Plan's financial statements were available to be used.

3. INVESTMENT CONTRACT

The Plan has entered into a fully benefit-responsive investment contract. The trustee maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits attributable to the investment contract. The investment contract is presented on the face of the statements of net assets available for plan benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, (d) a material misrepresentation. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants are probable of occurring.

The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

4. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, Reliance Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023, the schedule of assets held for investment purposes as of December 31, 2024 and the related investment activity reflected in the statements of changes in net assets available for plan benefits for the years ended December 31, 2024 and 2023.

5. FAIR VALUE MEASUREMENTS

Generally accepted accounting principles in the United States of America establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual and money market funds:* Valued at the closing price reported on the active market on which the underlying securities are traded. These investments are considered Level 1 and total \$57,299,660 and \$48,473,838 at December 31, 2024 and 2023, respectively.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. WITHDRAWING PARTICIPANTS

All participants who have withdrawn from the Plan and requested their benefits have been paid as of December 31, 2024.

7. PLAN AMENDMENT AND TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will automatically become fully vested in their account balances.

Additionally, the Company may amend the Plan at any time without the consent of any participant or any beneficiary, provided that no amendment deprives any participant of the participant's non-forfeitable accrued benefit.

8. TAX STATUS

The Plan is a prototype plan that has obtained its latest determination letter on March 31, 2008, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

9. RELATED PARTY TRANSACTIONS

The Plan has a number of service providers. Such parties are considered parties-in-interest under ERISA.
