Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Gladding Chevrolet, Inc. T/A J.B.A. Chevrolet 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description

The following description of Gladding Chevrolet, Inc. T/A J.B.A. Chevrolet 401(k) Profit Sharing Plan and Trust (the Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan established by Gladding Chevrolet, Inc. (the Company) in which employees are eligible to make pre-tax employee contributions. The Plan covers all employees of the Company who attained age 21 and have been credited with at least six consecutive calendar months of employment. Plan entry dates are the first of the next month in which the employee attains eligibility requirements. The Plan's trustees are responsible for oversight of the Plan, determination of the appropriateness of the Plan's investments and for monitoring investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by a third-party, which uses the services of a custodian and was restated January 1, 2022, to conform to current regulatory requirement.

Contributions: Plan participants may elect to contribute ("elective deferrals") up to 100% of their pretax annual compensation not to exceed the maximum allowable by the Internal Revenue Code. Participants age 50 or older may elect to defer additional "catch-up" amounts. Participants may also contribute amounts representing distributions from other qualified plans ("rollovers"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan does not permit employee voluntary after-tax contributions. Effective January 1, 2024, Long Term, Part Time employees who are participants in the Plan are eligible for catch-up contributions, Roth elective deferrals, rollover contributions and participant loans.

The Company may make discretionary matching, profit sharing and qualified non-elective contributions. For the year ended December 31, 2024, the Company elected to make discretionary matching contributions to participants who elect to defer a portion of their compensation in the amount of 50% of the first 4% of compensation deferred. Participants are eligible to receive matching contributions provided they are credited with at least 1,000 service hours during the current Plan year. There were no profit sharing or non-elective contributions for the year ended December 31, 2024. Contributions are subject to certain limitations.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contribution (if any) and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Investment Options: Participants may direct the investment of contributions into various investment options offered by the Plan in 1% increments. The Plan currently offers various pooled separate accounts with John Hancock Life Insurance Company U.S.A. Participants may change their allocations on a daily basis.

Note 1. Plan Description (Continued)

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. For amounts attributable to the Company's matching and discretionary contributions, vesting begins at 20% upon completion of two years of service and increases ratably to 100% vesting at the completion of six years of service. A participant is credited with a year of service during any full year in which he or she completes 1,000 hours of service. A participant is fully vested at normal retirement age of 65, regardless of service.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have no more than two loans outstanding at any time. Loan terms may not exceed 60 months, but a longer term (up to ten years) is permitted if used for the purchase of a principal residence. The loans are collateralized by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. While an employee, the loan must be repaid via payroll withholdings. Various default and curative provisions are contained within the written loan policy of the Plan.

Payment of Benefits: On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a) a lump-sum amount equal to the value of the participant's vested interest in his or her account, b) for the vested portion of an employee's account, and employment is terminated for any reason other than death, he or she may elect to be paid in a series of annual payments through the purchase of an annuity contract as directed by the plan administrator, or c) defer receiving payment until age 72. If the vested portion of a participant's total account subject to benefit is less than \$7,000, he or she will be paid their entire benefit in a lump sum. The Plan provides for financial hardship withdrawals from a participant's elective deferral account. Participant's age 59½ and older may withdraw any portion of their elective deferral account, Roth deferral account or voluntary contribution account.

Forfeitures: If a participant terminates employment before being fully vested, the non-vested portion of the participant's account will remain in the Plan. Forfeited non-vested accounts are used to reduce future employer contributions or pay plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$673 and \$7,792, respectively. During 2024, forfeitures of \$7,792 were used to reduce employer match.

Administrative Expenses: Expenses incurred for administration of the Plan may be paid by the Plan if not paid by the Plan Sponsor. Expenses that are paid by the Company are excluded from these financial statements.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting: The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balances plus any accrued interest. Delinquent loans are treated as distributions based upon the terms of the plan document surrounding defaulted loans.

Payment of Benefits: Benefits are recorded when paid.

Subsequent Events: In preparing these financial statements, the Plan Sponsor has evaluated events and transactions for potential recognition or disclosure through October 3, 2025, the date the financial statements were available to be issued. See Note 11.

Note 3. Information Certified by the Custodian

Certain information related to investments and notes receivable from participants is disclosed on the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net depreciation in fair value of investments, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to information certified as complete and accurate by John Hancock Life Insurance Company U.S.A. (JHLIC), the Plan's Custodian.

Note 4. Investments and Fair Value Measurements

The Plan measures on a recurring basis its investments at fair value in accordance with Financial Accounting Standards Board (FASB) codification *Fair Value Measurement*, which provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy are as follows:

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The inputs or methodology used for valuing investments are not an indication of the risk associated with investing in those securities.

The following is a description of the valuation methodology used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Units of participation in pooled separate accounts are reported at the accumulated value of units held by the Plan at year-end as reported to the Plan by the insurance company. The accumulated unit value is determined daily by John Hancock Life Insurance Company U.S.A. and is based on the net asset value of shares in the underlying fund, the fund's dividends and the contract's separate account charges. Pooled separate accounts are stated at fair value as determined by observable Level 1 inputs. While some pooled separate accounts may have publicly quoted pricing inputs (Level 1), the account values of pooled separate accounts are not publicly quoted and are, therefore, classified as Level 2 investments.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain investments or financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Investment Contract with Insurance Company

The Plan has entered into a group annuity contract with John Hancock Life Insurance Company (U.S.A.) which provides for investments in various pooled separate accounts. These accounts are credited with earnings on underlying investments and charged for participant withdrawals and certain administrative expenses. The pooled separate accounts consist of various fund investment options covering multiple asset classes.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 7. Related Party and Party-In-Interest Transactions

Certain Plan investments consist of units of pooled separate accounts managed by John Hancock Life Insurance Company U.S.A., the Custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Note 8. Tax Status

The Plan adopted a non-standardized pre-approved profit-sharing plan with CODA sponsored by CCH Incorporated DBA FTWILLIAM.com. The non-standardized pre-approved plan received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, as to the Plan's qualified status. The IRS has determined that the non-standardized pre-approved plan is designed in accordance with the applicable section of the Internal Revenue Code (IRC). The non-standardized pre-approved opinion letter has been relied upon by this Plan. Although the Plan has since been amended, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

Note 10. Prohibited Transactions

During 2024 and 2023, the Plan Sponsor inadvertently failed to deposit approximately \$35,704 and \$664, respectively, of participant contributions within the required timeframe as stated by the United States Department of Labor (DOL). The DOL considers late deposits to be prohibited transactions. Lost earnings on the 2024 and 2023 late deposits were deposited in 2024.

Note 11. Subsequent Events

The Plan was amended and restated on April 1, 2025, to incorporate several provisions related to the Secure Act 2.0 as follows:

- The Plan allows for elective deferral contributions to be made as Roth contributions to be treated in the same manner as pre-tax elective deferrals except Roth deferrals are made on an after-tax basis. A “qualified” distribution from the Roth contributions and earning is not taxable.
- Roth elective deferrals are included in the definition of “matched employee contributions” from the employer perspective.
- Hardship withdrawals are allowed from the participant’s Roth elective deferral account subject to the same terms and conditions applicable to the participants elective deferral account.
- A participant may take a distribution after attainment of age 59 ½. Withdrawals from the Participant’s Roth elective deferral account are subject to the same terms and conditions that apply to the Participant’s elective deferral account.
- Participants may make up to one in-plan roth rollover election annually.
- Allows participants to receive emergency personal expense distributions and allows for recontribution of such amounts.
- Allows participants to receive distributions due to domestic abuse and allows for recontribution of such amounts.
- Allows participants to receive qualified disaster recovery distributions and allows for recontribution of such amounts.
- Allows participant recontributions of distributions for home purchases to the Plan.
