Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Silver State Schools Credit Union Defined Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities For The Audit Of The Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis For Opinion On The Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities For The Audit Of The Financial Statements section of our report. We are required to be independent of Silver State Schools Credit Union Defined Benefit Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities Of Management For The Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Silver State Schools Credit Union Defined Benefit Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities For The Audit Of The Financial Statements

Except as described in the Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with auditing standards generally accepted in the United States of America will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with auditing standards generally accepted in the United States of America, we:

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Silver State Schools Credit Union Defined Benefit Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

1. Plan Description

The following description of the Silver State Schools Credit Union Defined Benefit Plan (the Plan), provides only general information. Participants should refer to the Plan Document for a more comprehensive description of the Plan's provisions.

General

The Plan is a defined benefit pension plan and became effective April 1, 1973. The Plan provides pension benefits to all employees of Silver State Schools Credit Union (the Employer) who have completed six months of service and attained 20 years of age. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On June 1, 2010, the accrued benefits of the Plan were frozen. Employees can no longer join or rejoin the plan as an active participant on or after this date. Earned benefits are frozen and no additional benefits can be earned.

On April 1, 2018, the Plan was amended in order to adopt disability claim procedures that would make the Plan compliant to the requirements under the regulations of ERISA Section 503.

On January 1, 2024, the Plan was restated to incorporate amendments for the Setting Every Community Up for Retirement Enhancement Act of 2019 and the SECURE 2.0 Act of 2022.

Pension Benefits

Employees with 5 or more years of service are entitled to annual pension benefits (paid monthly) beginning at normal retirement age (65) equal to 67.5% of average monthly compensation not in excess of the covered compensation, plus 80% of their total average monthly compensation in excess of the covered compensation. The average monthly compensation is calculated using the five consecutive years (all compensation years, if less than five) that give the highest average out of all compensation years.

However, the average compensation is the frozen average compensation determined as of the date the accrued benefit was frozen. In determining the frozen average compensation as of the date the accrued benefit is frozen, compensation after that date shall be disregarded.

The Plan permits early retirement for participants at ages 55-65 with 5 or more years of service. A reduced retirement benefit will result from early retirement. Employees will receive their pension benefits in the form of a qualified joint and survivor annuity, or in any other form as agreed upon between the employee, the employer, and Principal Life Insurance Company.

Death And Disability Benefits

Death benefits are provided in the form of monthly pension payments or lump sum payment (after Annuity Starting Date) to the surviving spouse. The spouse may elect to start benefits on any first day of the month or after the earliest date retirement benefits could have been paid to the participant if the participant had ceased to be an employee on the date of death and survived to retire.

Disability benefits are provided if employment ceases, prior to retirement, due to a total and permanent disability. The benefit is reduced by early retirement factors.

Vesting

Vesting in the Plan is based on years of continuous service. A participant vests in 20% increments beginning at the end of year three and is 100% vested after seven years of credited service as follows:

Administrative Expenses

The Plan pays for all expenses incurred by the Plan from the assets of the Plan, except for certain professional fees, which are paid by the Employer.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation And Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements. Actual results could differ from those estimates.

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

The Employer pays certain administrative expenses, including PBGC premiums, on behalf of the Plan.

Subsequent Events

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

3. Certified Investments

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule that was prepared by or derived from information certified by Principal Life Insurance Company and Principal Trust Company (collectively, Principal), the Custodians, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Principal that the information provided to the Plan Administrator related to the following information is complete and accurate.

Accordingly, as permitted by CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets as of December 31:

4. Actuarial Present Value Of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments that are attributable, under the Plan's provisions, to the service which employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of deceased employees and (c) present employees or their beneficiaries. Benefits under the Plan are based on employee's years of service. The accumulated plan benefits for active employees are based on their years of service on the date the benefit information is presented (the valuation date). Benefits payable under all circumstances - retirement, death, disability and termination of employment - is included to the extent they are deemed attributable to employee service rendered to the valuation date.

The actuarial present value of accumulated plan benefits is determined by the Plan's actuary and is the amount that results from applying independent actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements for death, withdrawal or retirement) between the valuation date and the expected date of payment. The prior service cost and contributions were actuarially determined under the asset smoothing method.

The actuarial valuation of assets is different from the fair market value. The market value of each year's assets is accumulated to the current valuation date using the lesser of the assumed interest rate or the maximum allowable rate and reflecting the timing of transactions. The adjustments include contributions, distributions, and any deducted administrative expenses.

The accumulated values from the two preceding years are averaged with the current year market value. The resulting value of the assets is then restricted to be no more than 110% and no less than 90% of the current market value.

5. Income Tax Status

The Plan Sponsor is an adopter of a pre-approved plan. The Internal Revenue Service (IRS) has determined and informed the Plan Sponsor by a letter dated February 28, 2023 that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (the IRC).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Risk And Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

7. Party In Interest Transactions

Certain Plan investments are managed by the Custodians. Therefore, these transactions qualify as party in interest transactions. For the years ended December 31, 2024 and 2023, administrative expenses paid by the Plan were \$90,734 and \$82,209, respectively.

8. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts (PSAs)

Pooled separate accounts values are not publicly quoted but are available to current investors via the Employer website or when Plan participants access their account values. PSAs are valued at the NAV reported by the investment manager of the accounts and are deemed to have a readily determinable fair value. The NAV is determined by dividing the net assets, at fair value, of the fund by the number of units outstanding on the day of valuation. PSAs are primarily comprised of shares of registered investment companies (mutual funds) held through subaccounts of a separate account of an insurance company at December 31, 2024 and 2023. The Plan has concluded that the NAV as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the insurance company represents fair value of the investments.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in the fair value methodologies used at December 31, 2024 or 2023.

9. Funding Policy

The Employer contributes amounts necessary on an actuarial basis to provide the Plan with sufficient assets to meet the benefits to be paid to participants. The Employer's contributions for 2024 and 2023 met the minimum funding requirements of ERISA. Annual contributions consist of a prior service contribution which funds the cost of benefits for qualifying service prior to establishment or amendment of the Plan. Actuarial gains and losses, due to difference between actual prior experience and the actuarial assumptions, impact the contribution.

10. Plan Termination

The Employer has the right under the Plan to terminate the Plan at any time, subject to the provisions of the Plan Document and ERISA. Upon termination of the Plan or complete discontinuance of contributions to the Plan, the participants would be 100% vested in benefits earned as of the termination date.

Pursuant to ERISA requirements, if a termination is the result of the bankruptcy or near bankruptcy of the Plan Sponsor and the Plan's assets are not adequate to pay all benefits vested prior to the termination, the Pension Benefit Guaranty Corporation (PBGC) will take over the Plan and will pay those benefits which it guarantees. In this case, some participants may receive a smaller benefit than if the Plan had continued. Whether a participant's accumulated plan benefits will be paid depends on both the priority of the benefits (as described in the Plan) and the level of benefits guaranteed by the PBGC at that time.

If, however, the Plan is terminated for any reason other than the bankruptcy or near bankruptcy of the Employer and the Plan has insufficient assets, the Employer will be required to pay to the Plan an amount which, together with Plan assets, will satisfy all benefits accumulated to the date of the Plan termination.

Upon termination or partial termination of the Plan, the benefits accrued up to the date of termination by the affected participants and their beneficiaries, respectively, shall be non-forfeitable; however, actual payment of such benefits shall only be to the extent permitted from Plan assets (or from PBGC assets).

The assets of the Plan available to the participants, or their beneficiaries, affected by the termination or partial termination shall, unless otherwise required under PBGC regulations, be allocated to provide such non-forfeitable benefits, to the extent possible, in the following order:

- Benefits to participants or beneficiaries who began receiving benefits at least three years before the termination date of the Plan (including those benefits which would have been received for at least three years if the participant had retired) based upon Plan provisions in effect during the five years prior to termination which produce the least benefits
- All other benefits insured by the PBGC (including benefits that are guaranteed except for the special limitation on coverage of a substantial owner)
- All other benefits that were non-forfeitable hereunder immediately prior to Plan termination
- All other benefits under the Plan

The Society of Actuaries (SOA) is an actuarial organization that periodically reviews mortality data and publishes mortality tables and improvement scales. In October 2019, the SOA released the Pri-2012 Mortality Tables for private-sector retirement plans in the U.S. The Pri-2012 report contains different sets of mortality tables based on complete dataset or various subsets. The Blue collar base rate table was selected based on information provided by the plan sponsor.

Pri-2012 section 12.4. provided three approaches for designated beneficiaries in the calculation of joint-and-survivor annuities. We believe "Approach 1" is reasonable for this plan.

Interest rate used to value liabilities

The interest rate used to value ASC 960 liabilities is developed as long-term expected geometric return on plan assets. Arithmetic expected return is calculated as the weighted average of broad asset classes' arithmetic returns of the plan's target asset allocation, and then converted to the geometric under lognormal distribution assumption. Treatment of administrative expenses

No adjustments are made for administrative expenses, either through a reduction in the discount rate or by calculating a present value of future expenses.

Plan sponsors may change their administrative expense handling at any time. Our approach provides consistent handling of ASC 960 liabilities from year to year, whether expenses are paid with plan assets or directly by the employer.

Note - expenses paid with plan assets are required to be included in funding normal cost. As a result, the plan is reimbursed annually through required funding. Exception – contributions are not required due to assets sufficiently in excess of liabilities to fund both expenses and normal cost. In this case, administrative expenses are taken from the excess assets.
