To the Trustee and Participants

Scope and Nature of the *ERISA Section 103(a)(3)(C)* Audit

We have performed audits of the accompanying financial statements of the Advantage Home Health Care, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to *the Employee Retirement Income Security Act of 1974 ("ERISA")*, as permitted by *ERISA Section 103(a)(3)(C)*. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with *ERISA Section 103(a)(3)(C)* pursuant to *29 CFR 2520.103-8* of the *Department of Labor's Rules ("DOL") and Regulations for Reporting and Disclosure under ERISA*. As permitted by *ERISA Section 103(a)(3)(C)*, our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with *29 CFR 2520.103-5* of the *DOL's Rules and Regulations for Reporting and Disclosure under ERISA* ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of *ERISA Section 103(a)(3)(C)*.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our *ERISA Section 103(a)(3)(C)* audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the *ERISA Section 103(a)(3)(C)* audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following description of the Advantage Home Health Care, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering all employees of Advantage Home Health Care, Inc. (the “Company” or “Plan Sponsor”). Employees become eligible to participate when they attain the age of twenty-one and complete one thousand hours of service. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974 (“ERISA”)*.

Administration – The Company has designated certain employees, who serve without additional compensation, to administer the Plan. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.

Contributions – Participants may elect to reduce their compensation by a specific percentage or dollar amount, subject to the annual limitation established by the Internal Revenue Service (“IRS”). These contributions may be deferred on a pre-tax basis or an after-tax Roth basis. Participants may also contribute amounts from other qualified plans.

The Company may make a discretionary matching contribution equal to a uniform percentage of salary deferrals. This percentage is determined annually by the Company. No matching contributions were made by the Company during 2024 or 2023.

The Company may also make a discretionary profit-sharing contribution to the Plan allocated to each participant’s account as a percent of the participant’s compensation to total compensation of all eligible participants. No profit-sharing contributions were made by the Company during 2024 or 2023.

Participant Accounts – Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contributions, the Company’s matching contributions, the Company’s profit-sharing contributions, and Plan earnings, as applicable. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, specific participant transaction costs or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are fully vested in their voluntary contributions plus actual earnings thereon. A participant earns 20% vesting in Company contributions after two years of credited service, increasing 20% annually and reaches 100% vesting after six years of credited service. A participant also becomes 100% vested in the event of normal retirement, disability, or death.

Investment Options – Upon enrollment in the Plan, participants may direct the investment of their accounts into various investment options offered by the Plan. Participants may change their investment elections quarterly among those investments provided.

Participant Loans – The Plan does not allow for participant loans.

1. DESCRIPTION OF THE PLAN (continued)

Payment of Benefits – Upon termination of service or attaining normal retirement age, a participant may elect to receive a lump sum amount equal to the value of the participant’s vested interest. Hardship withdrawals are also allowed as defined in the Plan document.

Forfeited Accounts – The non-vested portion of former participants’ accounts may be used to pay administrative expenses of the Plan or reduce the amount of Company contributions. Forfeited accounts totaled \$1,355 for both the years ended December 31, 2024 and 2023. During the Plan years ended December 31, 2024 and 2023, there were no forfeitures used.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared using the accrual method of accounting which is in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – The Plan’s investments are reported at fair value. GAAP defines fair value as the exchange price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the Plan year.

Investment Management Fees and Operating Expenses – Investment management fees and operating expenses charged to the Plan for certain investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Payment of Benefits – Benefits are recorded when paid. There were no benefit payments requested and not yet disbursed at December 31, 2024 and 2023.

Administrative Expenses – Administrative expenses of the Plan are paid by the Company or the Plan participants, as defined in the Plan document.

3. INFORMATION CERTIFIED BY THE QUALIFIED INSTITUTION (UNAUDITED)

The Plan administrator has elected the method of annual reporting compliance permitted by *ERISA Section 103(a)(3)(C)* pursuant to *29 CFR 2520.103-8 of Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure* under *ERISA*. Accordingly, John Hancock Life Insurance Company, a qualified institution, has certified to the completeness and accuracy of the following data included in the accompanying financial statements and supplemental schedule.

- Investments at fair value, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Schedule of assets held at end of year as of December 31, 2024.

At the request of the Plan administrator, the Plan's independent auditor did not perform auditing procedures with respect to this certified information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

4. FAIR VALUE MEASUREMENTS

GAAP provides a framework for measuring fair value. The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Pooled Separate Accounts ("PSAs") – Valued at the net asset value ("NAV") of units held by the Plan at year-end provided by the issuer of the account. The NAV is used as a practical expedient to estimate fair value and is based on the value of the underlying investment assets held through subaccounts of a separate account of an insurance company. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV. PSAs are comprised, primarily, of shares of mutual funds held through sub-accounts of an insurance company at December 31, 2024 and 2023. The PSAs seek to mirror the investment objectives and strategies of the underlying mutual fund for which the PSA is named. The investments are redeemable at the adjusted NAV on a daily basis under agreements with the insurance company. There are currently no redemption restrictions or unfunded commitments on these investments.

The preceding method described may produce a fair value measurement that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

ADVANTAGE HOME HEALTH CARE, INC. 401(k) PLAN**NOTES TO FINANCIAL STATEMENTS****5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain administrative services are provided by the Company at no costs to the Plan and certain administrative costs incurred by the Plan are paid by the Company. The Plan has entered into various service agreements with parties-in-interest.

The Plan invests in pooled separate accounts managed by John Hancock, the custodian of the Plan and, therefore these transactions qualify as party-in-interest transactions.

6. INCOME TAX STATUS

The IRS ruled on June 30, 2020, that the pre-approved profit-sharing plan of CCH Incorporated dba FT William.Com, upon the Plan is based, is designed in accordance with the applicable sections of the Internal Revenue Code (“IRC”). The Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. PLAN TERMINATION

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of *ERISA*. In the event of Plan termination, participants will become 100% vested in their accounts.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants account balances and the amounts reported in the financial statements.

9. SUBSEQUENT EVENTS

The Plan has evaluated all subsequent events through October 2, 2025, which is the date these financial statements were available to be issued and has determined there are no subsequent events that require disclosure.
