Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

Note 1 – Plan Description

The following description of The Beauty Health 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General – The Plan was established effective January 1, 1999, and is intended to qualify as a profit sharing plan under Sections 401(a) and 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Administration – The Plan is sponsored by The Beauty Health Company (the Company or Sponsor), which also serves as the Plan administrator. Fidelity Management Trust Company (Fidelity Trust) and Fidelity Workplace Services, LLC, respectively are the Plan's trustee and recordkeeper. Effective January 1, 2024, the Plan passed an amendment to contribute and remit employer contributions on a weekly basis from an annual basis.

Eligibility – Full-time employees of the Company are generally eligible to participate in the Plan upon date of hire. Eligible employees can enter the Plan the first day of the month subsequent to their date of hire. However, non-resident aliens, union, part-time, and leased employees are excluded from participating in the Plan.

Contributions – Participants may make pre-tax contributions of up to 100% of their annual eligible compensation, which shall not exceed the maximum allowed under the IRC limitations, which was \$23,000 for the 2024 plan year. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants that are 50 years of age or older who have met the annual IRC deferral limit or the specified plan limits for deferral may contribute a catch-up contribution of up to \$7,500 for 2024. Participants may also rollover amounts representing distributions from other qualified plans. All participant contributions are participant-directed by the participant in one or more of the investment options offered under the Plan. Contributions are subject to IRC regulation limitations.

The Plan also provides for safe harbor matching contributions equal to 100% of participant deferrals, up to 3% of compensation, plus 50% of participant deferrals in excess of 3% up to 5% of compensation, for a maximum matching contribution equal to 4% of compensation for 2024. Participants who have at least six months of service are eligible for the safe harbor matching contributions. In addition, the Plan also provides for discretionary non-elective contributions, of which there were none in 2024. Participants who have at least six months of service are eligible for the discretionary non-elective contributions.

Participants' accounts – Participants' contributions are invested in various funds according to participant elections and must be allocated among the available funds in whole percentages. Individual accounts are maintained for each of the Plan's participants to reflect each participant's contributions and related employer contributions, as well as the participant's share of the Plan's income and any related administrative expenses. Allocations of the Plan's income and expenses are based on the proportion that each participant's account balance bears to the total of all participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are 100% vested at all times in their deferral contributions, plus actual earnings or losses thereon. In addition, participants are also 100% vested at all times in any safe harbor matching contributions.

Vesting in employer contributions other than safe harbor matching contributions is based on years of continuous service. Participants vest in accordance with the following schedule:

Forfeited accounts – If a participant’s employment is terminated before full vesting of employer contributions and related earnings is attained, the amount not vested is allocated to pay any administrative expenses of the Plan or to reduce any employer contributions. At December 31, 2024 and 2023, non-vested forfeited balances in the Plan totaled \$100 and \$24,793, respectively. During the year ended December 31, 2024, \$24,850 was used to reduce employer contributions.

Payment of benefits – Upon termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant’s vested interest in his or her account. These payments may be paid in a lump sum payment or paid in installments over time. Any withdrawal made by a participant prior to attaining age 59½, that is not rolled over into another retirement account and for reasons other than death or disability, is subject to a 10% federal excise tax.

Participant loans – Participants may borrow from their accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance of the participant’s account and must be repaid at a fixed rate which is commensurate with local prevailing rates. Interest rates ranged from 4.25% to 9.50% with maturities through July 2037.

Loans must be repaid within five years, unless the loan is for the purchase of a principal residence, in which case, the repayment period may be extended.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The accompanying financial statements of the Plan have been prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of estimates – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could materially differ from those estimates.

Investment valuation – Investments are stated at fair value (see Note 3).

Income recognition – In accordance with the policy of stating plan assets at fair value, the Plan presents the net appreciation in the fair value of its investments in the statement of changes in net assets, which consists of the realized gains or losses and the unrealized appreciation on those investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of benefits – Benefit payments are recorded when paid.

Promissory notes from participants – Promissory notes from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loans to be in default, the participant loan is reduced and a benefit is recorded.

Administrative expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of promissory notes from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events – Subsequent events are events or transactions that occur after the statements of net assets available for benefits date but before the financial statements are issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statements of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statements of net assets available for benefits but arose after the statements of net assets available for benefits date and before the financial statements are issued.

The Plan has evaluated subsequent events through October 7, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies – The fair value of registered investment companies (mutual funds) is determined based on quoted market prices in active markets, which represent the net asset value of shares of the mutual fund held by the Plan at year end. Registered investment companies are classified in Level 1 of the valuation hierarchy.

Collective trusts – Units held in collective trusts (CTs) are valued using the net asset value practical expedient (NAV practical expedient) of the CT as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of a CT is calculated based on a compilation of primarily observable market information. There are no unfunded commitments or redemption restrictions.

Note 5 – Income Tax Status

The Plan is a non-standardized defined contribution Plan. The Plan adopted the Fidelity Pre-Approved Defined Contribution Plan effective October 1, 2023, that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the IRC. Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 – Risks and Uncertainties

The Plan provides various mutual funds as investment options. Such investments are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in their value, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7 – Plan Termination

Although the Company has not expressed any such intention, the Plan may be discontinued at any time by the Company. In the event of termination, participants' rights to Company contributions become fully vested and the net assets of the Plan would continue to be held for normal withdrawal by participants assuming the Company's operations continue, or would be distributed to participants immediately if the Company's operations cease.

Note 8 – Delinquent Participant Contributions

As disclosed in the accompanying supplemental schedules, certain employee deferrals were not remitted to the Plan within the timeframe required by the Department of Labor. The total of \$1,598,738 was comprised of delinquent contributions for the years ended December 31, 2019, December 31, 2020, December 31, 2022, December 31, 2023, and December 31, 2024. A total of \$1,598,651 were corrected outside VFCP, and lost earnings were calculated and remitted to participant accounts during 2024. The remaining \$87 were corrected subsequent to year end.
