## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Calcium Products Inc. Retirement Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Calcium Products Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

## **Other Matter**

### *Supplemental Schedule Required by ERISA*

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 — DESCRIPTION OF PLAN**

The following brief description of the Calcium Products Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement (Agreement) for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution 401(k) plan covering substantially all employees of Calcium Products Inc. (the Company or Plan Administrator), except leased employees, union employees, and non-resident aliens, who have completed two months of service. Plan participants may enter the Plan on the first day of the next month following the date the employee meets the eligibility requirements. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for the oversight of the Plan.

**Plan Administration**

The Company has contracted with Transamerica Life Insurance Company, Inc. (TLIC) to hold the Plan's assets, execute investment transactions, perform allocations of contributions and investment earnings, and make benefit payments.

**Contributions**

The Plan allows for employee contributions up to 100% of eligible compensation, subject to certain Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit plans (rollover).

The Plan included an automatic-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically-enrolled participants have their deferral rate set at 3% of eligible compensation, and their contributions invested in a designated balanced fund until changed by the participant.

The Plan provides for matching Company contributions equal to 100% of the participants' first 3% of contributions. Additional discretionary contributions may be made by the Company from time to time. There were no discretionary contributions in 2024 and 2023.

**Participant Accounts**

Participants direct the investment of their contributions into various investment options offered by the Plan. Each participant's account is increased or decreased by the participant's contributions, withdrawals, and an allocation of Plan earnings (losses), net of administrative expenses, and an allocation of the Company's contributions. Allocations to participants are based on the funds selected by the participant, as defined in the Agreement. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

**Vesting**

Participants are immediately vested in their voluntary contributions plus earnings and Company matching contributions. For Company discretionary contributions, a participant is 100% vested after six years of credited service in which they have at least 1,000 hours of service each year.

**Participant Loans**

The Plan does not allow participants to borrow on their accounts.

**Payment of Benefits**

Upon termination of employment, death, retirement, hardship, or disability, the participant may elect to receive a lump sum amount equal to the value of the participant's vested account balance. Participants can also elect to leave the balance in the account to share in investment gains and losses.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Participants are responsible for certain transaction-related expenses, investment advisory, third party administrative services, and asset-based recordkeeping fees. Certain investment-related expenses are included as a reduction of net appreciation in fair value of investments.

**Expense Budget Account**

The Plan has an unallocated expense budget account (EBA), which receives expense reimbursements based on asset values and is used to pay Plan administrative fees during the year. As of December 31, 2024 and 2023, the unallocated EBA balance was \$4,269 and \$3,269, respectively.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the accrued benefits of all participants shall be distributed to participants as provided in the Agreement.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements of the Plan have been prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**

The preparation of the financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported in the financial statements and accompanying notes. Actual results could differ from these estimates.

**Investment Valuation and Income Recognition**

Investments in pooled separate accounts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The Plan holds an insurance group contract (Stable Value Core Option), which is maintained in the general account of TLIC. The Stable Value Option is a fully benefit-responsive investment contract. Investment contracts held by a defined contribution plan are required to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Contributions**

Contributions from the Plan participants and the matching contributions from the Company are recorded in the year in which the participant's contributions are withheld from compensation.

**Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

**NOTE 3 — CERTIFIED INFORMATION**

Certain information related to investments disclosed in the accompanying financial statements, Note 4, and supplemental schedule of assets (held at end of year), including investments held at December 31, 2024 and 2023 and net appreciation in fair value of investments for the years then ended was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by TLIC. The following is a summary of this information as of December 31, 2024 and 2023 and the years then ended.

**NOTE 4 — FAIR VALUE MEASUREMENTS**

A three-tier hierarchy is used to classify fair value measurements for disclosure purposes. Inputs refer broadly to the assumptions that market participants would use in pricing the asset or liability, including assumptions about risk. Inputs may be observable or unobservable.

Observable inputs are inputs that reflect the assumptions market participants would use in pricing the asset or liability and are developed based on market data obtained from sources independent of the reporting entity. Unobservable inputs are inputs that reflect the Company's own assumptions regarding the assumptions market participants would use in pricing the asset or liability, based on the best information available in the circumstances. The hierarchy of inputs is summarized in the levels listed below.

- Level 1            Quoted prices in active markets for identical investments.
- Level 2            Other significant observable inputs (including quoted prices for similar investments, interest rates, prepayment speeds, credit risk, etc.).
- Level 3            Significant unobservable inputs (including the Company's own assumptions in determining the fair value of investments).

Investments carried at fair value are classified, in their entirety, based on the lowest priority level of input that is significant to the fair value measurement. The assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the placement of assets within the levels of the fair value hierarchy.

The Company uses the following valuation methods and assumptions to estimate fair value:

*Pooled separate accounts:* The fair value of units held in pooled separate accounts are valued at net asset value (NAV), determined by using available market information and appropriate valuation methods, as provided by TLIC, the insurer of the Plan. There are no imposed redemption restrictions on participants. There are no limitations on redemptions.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Company believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 — INVESTMENTS AT CONTRACT VALUE**

As of December 31, 2024 and 2023, the Plan had an investment in the TLIC Stable Value Core Option. The contract underlying this investment option is considered to be fully benefit responsive. As of December 31, 2024 and 2023, the contract value of the investment in insurance contracts was \$435,596 and \$281,661, respectively.

Contributions to the Stable Value Core Option are maintained in a general account that is credited with earnings on the underlying investment and charged for participant withdrawals and administrative expenses. The contracts are included in the financial statements at contract value as reported to the Plan by TLIC. Contract value represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all, or a portion, of their investment at contract value. There are no reserves against contract value for credit risk.

The average crediting interest rates to participants for the Stable Value Core Option as of December 31, 2024 and 2023 was 1.58% and 1.18%, respectively.

There are no unfunded commitments. Under the terms of the contracts, the Company must provide a minimum of a 270-day notice to TLIC prior to redemption of the contracts. Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) changes to the Plan's prohibition on competing investment options, (2) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (3) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

**NOTE 6 — PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are managed by TLIC. TLIC is the recordkeeper and insurance company for the Plan and provides investment advice to the Company as to the selection of investment options. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each fund. Therefore, these transactions with TLIC qualify as party-in-interest transactions. Additionally, the Plan paid TLIC recordkeeping and transactional fees of \$11,711 and \$10,789 for the years ended December 31, 2024 and 2023, respectively.

The Plan paid Edward Jones for investment advisory services of \$14,985 and \$11,382 for the years ended December 31, 2024 and 2023, respectively.

The plan paid Mesirow for investment advisory services of \$1,237 and \$946 for the years ended December 31, 2024 and 2023, respectively.

The Plan utilizes SuperiorUSA Benefits for third party administrative services. The Plan paid \$2,530 and \$2,830 for these services for the years ended December 31, 2024 and 2023, respectively.

**NOTE 7 — RISKS AND UNCERTAINTIES**

Under the Plan, participants invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 — INCOME TAX STATUS**

The Plan's nonstandardized prototype plan document has received an opinion letter dated November 19, 2020, in which the IRS stated that the prototype plan was acceptable under Section 401(a) of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan has not applied for a separate determination letter from the IRS; however, the Plan Administrator believes that the Plan is currently designed, and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

**NOTE 9 — SUBSEQUENT EVENTS**

The Plan evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Company adopted an amendment to permit safe harbor contributions from the Company, which will be 100% match of the first 3% of employee compensation and 50% match of the next 2% of employee compensation for a maximum matching contribution of 4% of eligible compensation.
