Management, having determined it is permissible in the circumstances, has elected to have the audits of DAS Acquisition Company 401(k) Profit Sharing Plan & Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of DAS Acquisition Company 401(k) Profit Sharing Plan & Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about DAS Acquisition Company 401(k) Profit Sharing Plan & Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note 1: Description of Plan

The following description of the DAS Acquisition Company 401(k) Profit Sharing Plan & Trust (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### SECURE 2.0 Act

The Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. Each of the provisions in SECURE 2.0 has its own effective date ranging from the date of enactment to 2028 and beyond, with the bulk of the provisions taking effect in 2023 and 2024. In accordance with SECURE 2.0, the Plan increased the age for required minimum distributions (RMD) from age 72 to age 73 effective January 2023. Further changes set forth in the SECURE 2.0 Act include eliminating pre-death RMD rules for Roth accounts and several voluntary changes to distribution provisions, effective January 2024. The Plan is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

#### General

The Plan, which was adopted on January 1, 1996 and most recently amended on March 1, 2024, by DAS Acquisition Company, LLC (the "Plan Sponsor"), is a defined contribution plan covering all employees of the Plan Sponsor who have completed 1 month period of service and are at least age 18.

The Plan has automatic enrollment at a rate of 2% of compensation after meeting the eligibility requirements above. Employees who opt out of automatic enrollment must complete a form to decline participation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

DAS Holdings Company, Inc.; DAS Title LLC; DAS Insurance, LLC; DAS Partnerships, LLC; Red Eagle Appraisals, LLC; and DAS Mortgage Services, LLC have also adopted this Plan as adopting employers for the benefit of their employees.

#### Contributions

Participants may defer up to an annual maximum of the lesser of 100% of eligible compensation or the Internal Revenue Service (IRS) limits for the year ended December 31, 2024. The total of employee and employer contributions for a given year cannot exceed the lesser of the IRS limits or 100% of the employee's annual compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also defer Roth contributions.

Employees can rollover any balance from a qualified retirement plan from another employer to this Plan. Such rollover contributions are kept in a separate rollover contribution account established on the employee's behalf. Participants direct the investment of their contributions into various investment options offered by the Plan. The employee will have a 100% vested interest in all amounts credited to the rollover contribution account.

#### Contributions (Continued)

The Plan Sponsor may make discretionary matching contributions which are determined by the participant's eligible compensation and deferrals. For the year ended December 31, 2024, the Plan Sponsor made matching contributions totaling \$382,149, before forfeitures, and no discretionary profit sharing contributions.

#### Participant Accounts

Each participant account is credited with the participant contributions and employer contributions and an allocation of the Plan's earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their account balance is based on years of continuous service. Participants hired prior to January 1, 2018, vest in their employer contributions plus actual earnings thereon at a rate of 25% per year after two years of credited service and are fully vested after five years of credited service. Participants hired after January 1, 2018, vest in their employer contributions plus actual earnings thereon at a rate of 20% per year after two years of credited service and are fully vested after six years of credited service.

#### Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued interest. Notes receivable are made in any amount greater than \$1,000, but less than 50% of the participant's vested account balance. In no event can the participant borrow more than \$50,000. Notes receivable transactions are treated as transfers from the investment funds to the participant loan accounts. Notes receivable terms range from one to five years or up to 15 years for the purchase of a primary residence. The notes receivables are secured by the balance in the participant's account and bear interest at a rate determined by the Plan Administrator. Interest rates ranged from 4.25% to 9.50% during 2024 and 2023. Principal and interest are paid ratably through payroll deductions.

#### Payment of Benefits

The Plan provides for retirement benefits to begin upon retirement. Retirement age for the Plan is 65. The Secure 2.0 Act, passed on December 29, 2022, states that anyone reaching age 73 in 2023 or later must take required minimum distributions by April 1 of the year after they reach age 73.

Upon death or disability of a participant while employed, the account balance becomes fully vested.

#### **Payment of Benefits (Continued)**

Upon termination of service, if the distribution amount is more than \$1,000 and less than \$7,000, the distribution will be automatically rolled over by the Plan to an Individual Retirement Account (IRA) with Charles Schwab Trust Bank as soon as administratively feasible. If the amount of the distribution is \$1,000 or less, participants will receive a lump-sum distribution. Participants with account balances exceeding \$7,000 will have their funds maintained in the Plan until a written request is submitted to the Plan Sponsor for payment.

Benefits are recorded when paid.

#### **Investment Options**

Upon enrollment in the Plan, participants may direct contributions to any of the applicable investment options available to Plan participants.

#### **Forfeitures**

Participants who terminate their employment and are less than 100% vested in their employer account will forfeit their non-vested portion. The Plan Sponsor may use these funds to reduce their contributions to the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$368,334 and \$414,437 respectively. Forfeitures of \$381,746 were used to reduce employer contributions during the year ended December 31, 2024. Forfeitures of \$22,496 were used to reduce administration fees during the year ended December 31, 2024.

#### **Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The Plan follows the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### **Use of Estimate**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from estimated amounts.

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value with the exception of the common collective trust which is stated at net asset value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 3 for discussion of fair value measurements and investments measured at net asset value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as, held during the year.

#### Administrative Expenses

Administrative expenses of the Plan are paid by both the Plan Sponsor and the participants of the Plan.

#### Subsequent Events

The Plan has evaluated subsequent events through September 30, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs according to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820 are described as follows:

Level I – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level II – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability

Level III – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Registered investment companies:* Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These investments are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

*Common collective trust:* Composed primarily of fully benefit-responsive investment contracts that are valued at net asset value of units of the fund's underlying collective trust. The net asset value is used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

### Note 4: Tax Status

The Plan is a volume submitter plan that received a favorable opinion letter from the IRS on March 31, 2014 updated on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code("IRC"). Although the Plan has been amended since receiving the opinion letter, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### Note 6: Related Party Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, or a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Company, which is the Plan Sponsor, provides certain administrative services at no cost to the Plan.

The fees paid by the Plan for the investment management services are netted with the investment income (loss) on each investment option of the Plan for the year ended December 31, 2024. The Plan paid an asset management fee of \$12,259 and a recordkeeping fee of \$60,513 to Schwab for the year ended December 31, 2024.

### Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
