Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the 401(k) Profit Sharing Plan for DISC Village, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Page Two

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Notes to Financial Statements

Years ended December 31, 2024 and 2023

1. Description of Plan

The following description of the 401(k) Profit Sharing Plan for DISC Village, Inc. (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established January 1, 2000, restated effective January 1, 2022, for the benefit of the employees of DISC Village, Inc. (the Company) and its affiliates at DISC Village Foundation and Woodville Properties, Inc. The Plan is intended to satisfy all the requirements for a qualified retirement plan under the provisions of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company serves as the Plan's Sponsor and Administrator. The Plan's directed Custodian is John Hancock Life Insurance Company (John Hancock) and its third party administrator is Retirement Solutions Specialists. Its investment advisor is Barnes Capital Group and its investment broker is LPL Financial Corporation. The Plan's Discretionary Trustees and the Company's Board of Directors are responsible for oversight of the Plan and determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Eligibility

The Plan covers all employees of the Company, with the exception of nonresident aliens, leased employees, and independent contractors. Employees are eligible to participate upon hire. Employees become eligible to receive employer safe harbor nonelective contributions, discretionary matching contributions, and discretionary nonelective contributions upon reaching 21 years of age and completing one year of service.

Contributions

Contributions from Plan participants and the safe harbor nonelective contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation. Participants may contribute up to 100% of pre-tax or post-tax annual compensation, as defined in the Plan, limited by the provisions of the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirements plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes safe harbor nonelective contributions equal to 4% of compensation to eligible employees which are invested directly into the investment options selected by the participant. The Company may elect to make discretionary matching or discretionary nonelective contributions to eligible employees, which are determined solely at the discretion of the Plan's Discretionary Trustees and the Company's Board of Directors. The Company did not make additional discretionary contributions for the year ended December 31, 2024. Contributions are subject to Internal Revenue Service (IRS) limitations.

1. Description of Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contributions, as well as Plan earnings.

Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and Company safe harbor nonelective contributions, plus the actual earnings thereon. Discretionary contributions are vested based on years of continuous service using a five-year graded schedule. Participant accounts immediately become 100% vested upon death or total and permanent disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates of 4.25% to 9.50% as of December 31, 2024. The interest rate is set at 1% above the prime rate, as defined by the Plan document. Participants may only have one outstanding loan at any given time. Loan terms range from one to five years or longer for the purchase of a primary residence. Principal and interest is paid ratably through semi-monthly payroll deductions.

Payment of Benefits

Upon termination of service due to retirement, death, disability, or termination of employment, a participant with a vested balance greater than \$5,000 may elect to receive a lump-sum or installment payments equal to the value of the participant's vested interest within their account, or have assets rolled into another qualified retirement plan. A single lump-sum distribution will be made to terminated participants whose vested balance is less than \$5,000 unless alternative instructions are provided by the participant within a reasonable period of time.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$7,345 and \$11,056, respectively. These accounts will be used to pay qualified Plan expenses or reduce future employer contributions. Forfeitures used to pay qualified Plan expenses totaled \$11,000 during the year ending December 31, 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments generally are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Discretionary Trustees and the Company's Board of Directors determine the Plan's valuation policies utilizing information provided by the investment advisors and Custodian. See Note 3 for additional discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable or distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 4, 2025, the date the financial statements were available to be issued. During the period from December 31, 2024 to September 4, 2025, the Plan did not have any material recognizable subsequent events.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at fair value of units held by the plan at year end. Fair value is determined by the issuer and is valued daily using publicly available quoted market prices that match the current underlying investment holdings of the account.

Noninterest bearing cash: Valued at the closing account balance held by the Plan at year end.

Guaranteed interest accounts: Valued at net asset value (NAV) of shares held by the plan at year end. The NAV, as provided by the custodian, is used as the practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

Investment earnings for amounts held in the Guaranteed Interest Accounts reflect a combination of interest income, dividend income, realized gains and losses and unrealized gains and losses depending on the composition of the underlying investments. Contributions made by the Employer shall be applied or invested in accordance with participant directed allocations.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

5. Tax Status

The Plan adopted a non-standardized pre-approved profit sharing plan sponsored by FIS Business Systems, Inc. The pre-approved profit sharing plan has received an opinion letter dated June 30, 2020 from the Internal Revenue Service that the pre-approved profit sharing plan is designed in accordance with applicable sections of the IRC. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC, and as such, no provision for income tax has been included in the Plan's financial statements.

6. Accounting for Uncertainty in Income

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2020.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Related Party Transactions and Party In Interest Transactions

Certain plan investments are managed by John Hancock, the Plan's Custodian. Transactions involving these investments are considered to be party in interest transactions. During the year ended December 31, 2024, total fees paid for recordkeeping and administration services totaled \$67,139.


