NOTE 1 - DESCRIPTION OF PLAN

The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan of Tidewater Direct, LLC (Company) and its affiliate, American Direct Imaging, Inc. (collectively, the Companies) and was established on December 16, 2005. The Plan is subject to the provisions of ERISA.

On December 29, 2022, the SECURE 2.0 Act of 2022 ("SECURE 2.0 Act") was signed into law. The SECURE 2.0 Act makes various required and optional changes applicable to tax qualified retirement plans with varying effective dates through 2027. Certain mandatory changes to plan provisions or optional changes to be made to plan provisions as a result of the SECURE 2.0 Act are discussed in these financial statements. The plan document is required to be amended in regard to the requirements of SECURE 2.0 Act by December 31, 2026.

Eligibility: The Plan covers substantially all employees. Nonresident aliens, leased employees, independent contractors and employees who are covered by a collective bargaining agreement are not eligible to participate in the Plan. Service with Tidewater Publishing Corporation, as defined, is included for eligibility and vesting purposes. Employees are eligible to participate once they have attained one year of service, as defined by the Plan, and are age twenty-one or older. Employees may enter the Plan on the first and seventh month of the plan year coincident with or following the attainment of these requirements.

Contributions: Each year, participants may elect to contribute from 1% up to 100% of their eligible compensation (as defined), up to the maximum allowable contribution under the Internal Revenue Code (IRC). These contributions may be made as pre-tax or after-tax Roth deferral contributions. Under the Plan's auto enrollment provision, a pre-tax deferral contribution of 2% of eligible compensation will automatically be elected, unless otherwise directed by the employee. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Companies may make the following contributions on behalf of participants:

A discretionary matching contribution, as determined by the Companies' Board of Directors. In order to receive the discretionary matching contribution, participants must be employed by the Companies on the last day of the plan year, unless they terminated employment during the year due to death, disability, or retirement, as defined. No discretionary matching contribution was made for 2024.

A discretionary profit sharing contribution, as determined by the Companies' Board of Directors. In order to share in the allocation of the discretionary profit sharing contribution, a participant must be employed on the last day of the plan year, unless they terminated employment during the year due to death, disability, or retirement, as defined. The contribution is to be allocated using a new comparability allocation formula. No discretionary contribution was made for 2024.

Qualified Nonelective Contributions (QNECs) and Qualified Matching Contributions (QMACs), as defined in the Plan. No QNECs or QMACs were made for 2024.

NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

Participant Accounts: Each participant's account is credited with the participant's contributions and the Companies' contributions, as well as allocations of plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings/losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options: Participants may direct the investment of their contributions and the Companies' contributions into a Group Annuity Contract (the Contract) with John Hancock Life Insurance Company (U.S.A) (John Hancock) offered by the Plan, which contains various pooled separate accounts. For those participants who do not make an investment selection, their contributions and the Companies' contributions are automatically invested in the Plan's qualified default investment account.

Vesting: Participants are immediately vested in their contributions, QNECs and QMACs, plus earnings thereon. Vesting in the Companies' contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service. Regardless of the vesting schedule, participants will become fully vested upon attainment of age 65 while employed.

Notes Receivable from Participants: The Plan does not allow for participant loans.

Payment of Benefits: Benefit payments may be in the form of lump sums, systematic withdrawals and partial withdrawals and are payable upon termination of employment, disability, death or retirement at age 65. For benefit payments payable as a result of a participant's death, the participant's entire account must be distributed by the end of the year containing the fifth anniversary of the participant's death. The Plan shall make automatic distributions of vested account balances that are less than \$7,000 (as updated by the SECURE 2.0 Act) in accordance with plan provisions. Distributions from a participant's rollover account may be made at any time. Hardship withdrawals, in-service withdrawals at age 59 ½ and qualified birth and adoption distributions, are also permitted, subject to provisions defined in the plan document.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Basis of Accounting: The Plan's financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by John Hancock. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Unit Values: Individual participant accounts for the pooled separate accounts are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the separate accounts, but do have an interest therein represented by units valued daily. The separate accounts earn dividends and realized gain distributions, which are automatically reinvested in additional units. Unit values are calculated daily before taking into consideration unitholders' contributions and withdrawals made on that day. These transactions are then valued using those unit values and recorded for that day.

Contributions: Contributions from plan participants are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits: Benefits are recorded when paid. As of December 31, 2024 and 2023, there were no significant amounts due but unpaid to participants.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from these financial statements. Investment management fees of individual fund investments are charged to the respective investment and included in the net appreciation/depreciation of the investment, as they are paid through revenue sharing. Fees related to the daily administration of the Plan and fees for participant distributions are charged directly to the participant's account and are included in administrative expenses.

NOTE 3 - FAIR VALUE MEASUREMENTS

ASC Topic 820, *Fair Value Measurement*, provides a practical expedient permitting a reporting entity to measure the fair value of certain investments using the net asset value (NAV) per share (or its equivalent) of the underlying investment (NAVPE, the net asset value per share practical expedient). The Plan invests in pooled separate accounts whose fair value at December 31, 2024 and 2023 as \$2,945,026 and \$2,665,896, respectively.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Pooled Separate Accounts: Unit value, as determined by John Hancock, based on the observable NAV of the underlying investments and adjusted for reinvested investment income or distribution of investment income from the underlying investments and John Hancock levied charges. The unit value is not a publicly-quoted price in an active market.

The underlying investments of the pooled separate accounts consist solely of mutual funds, each of which follows a separate investment strategy. The primary investment strategies of the Plan are described below:

Growth includes pooled separate accounts seeking to produce income and to provide an opportunity for growth of principal consistent with sound common stock investing.

Target Date includes pooled separate accounts seeking high total return through the separate account's target retirement date, with a greater focus on income as the target date approaches.

NOTE 3 - FAIR VALUE MEASUREMENTS - CONTINUED

The pooled separate accounts do not have unfunded commitments or significant restrictions on redemptions, as they may be redeemed daily. However, in the event an underlying investment or John Hancock determines that a fund transfer may result in disruptive short term trading, trading restrictions may be imposed and may include restricting, the number of transfers made during a defined period, the dollar amount of transfers, the method used to submit transfers and transfers into and out of certain investments.

NOTE 4 - INFORMATION CERTIFIED BY A QUALIFIED INSTITUTION

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock, a qualified institution.

NOTE 5 - TAX STATUS

The Internal Revenue Service has determined and informed CCH Incorporated, DBA ftwilliam.com, by a letter dated June 30, 2020, that the prototype plan adopted by the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

Plan investments consist of pooled separate accounts managed by John Hancock, and therefore, these transactions qualify as party in interest transactions.

John Hancock provides certain administrative services to the Plan pursuant to the Contract between the Company and John Hancock. As stated in the Contract, John Hancock receives an annual maintenance charge based on the value of investments calculated monthly. In addition, John Hancock receives, as additional compensation, certain fees paid by the underlying source of the Plan's pooled separate accounts, for recordkeeping and other services provided to the Plan. These fees reduce the annual maintenance charge. The Plan or Company may make payments to John Hancock for administrative expenses not covered by revenue sharing. Fees paid by the Plan to John Hancock and included in administrative expenses amounted to \$3,775 for 2024.

American Retirement Plan Services, LLC (ARPS) provides certain administrative services to the Plan pursuant to the Third Party Administrator Service Agreement (the Agreement) between the Company and ARPS. As stated in the Agreement, ARPS receives compensation from the Plan for the transactional services provided and also receives additional compensation directly from John Hancock relative to the administrative services provided.

NOTE 6 - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS - CONTINUED

The Company makes payments to ARPS for administration services. In addition, participants pay transactional fees to ARPS relative to distributions. Fees paid by the Plan to ARPS amounted to \$1,893 for 2024.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits. As of December 31, 2024 and 2023, 74% and 71%, respectively, of net assets available for benefits is invested in the John Hancock Lifetime Blend pooled separate accounts; however, by their nature, these funds are a diversified mix of equities and fixed income that rebalance over time.

NOTE 9 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.
