## Independent Auditors' Report

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Mannington 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



### (1) Description of Plan

The following description of the Mannington 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all regular full-time employees of Mannington Mills, Inc. and wholly-owned subsidiaries (the Company) with the exception of Georgia Carpet Finishers, Inc., upon completion of one hour of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is administered by the Retirement Funds Investment Committee (the Committee), whose members receive no remuneration from the Plan with respect to their service in such capacity. The Committee is the named fiduciary and the plan administrator. The Committee has been assigned certain fiduciary duties. The Board of Directors is responsible for oversight of the Plan. The Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's Board of Directors.

The Plan has an automatic enrollment provision. Employees hired or rehired by the Company shall be automatically enrolled in the Plan at a deferral rate of 3 percent of compensation unless, during their initial election period, participation is waived, or they elect to contribute a different amount.

Effective January 1, 2010, the Burke Industries, Inc. 401(k) Plan (Burke Plan) was merged with and into the Plan. Effective January 1, 2010, each covered employee who was participating in the Burke Plan on December 31, 2009 became a participant in the Plan.

The Company acquired Amtico International Inc. (Amtico) on March 5, 2012. The Plan was amended effective January 1, 2013 to reflect the plan merger of the Amtico International Inc. 401(k) Plan (Amtico Plan). Effective January 1, 2013, the participants' account balances and net assets of the Amtico Plan were merged into the Plan and are defined as Former Amtico Employees.

Effective January 1, 2014 the DSN 401(k) Plan (DSN Plan) was merged with and into the Plan. Each covered employee who was participating in the DSN Plan on December 31, 2013 became a participant in the Plan as of January 1, 2014.

#### **Contributions**

Participants may contribute an amount between 1 percent and 25 percent of their base compensation, as defined, for the contribution period, subject to certain limitations allowable under the Internal Revenue Code (IRC).

Effective October 1, 2017, the Plan was amended to permit after-tax (Roth) contributions.

#### *Contributions, Continued*

Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Participant contributions are recorded in the period during which the Company makes payroll deductions from the participant's earnings.

The Company provides matching contributions contingent on what participant group the plan participants are part of as defined by the plan document. During the years ended December 31, 2024 and 2023, the Company made matching contributions equal to \$1 for each \$1 contributed by a participant, up to a maximum of 3 percent of compensation, plus \$0.50 for each \$1 contributed by a participant up to a maximum of 2 percent of compensation for all participant groups except for the Legacy Group. During the years ended December 31, 2024 and 2023, the Company made matching contributions equal to \$0.50 for each \$1 contributed by a Legacy Group participant up to a maximum of 6 percent of compensation. Company matching contributions are recorded in the same period as employee contributions. The Company may also elect to make an additional discretionary matching contribution in an amount it so determines. There were no discretionary matching contributions made by the Company during 2024 or 2023.

Certain employee groups, defined by age, years of service, and position, may be eligible for additional Company Contributions, Special Company Contributions and Discretionary Company Contributions, as defined.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, specific participant transactions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants hired by the Company or Burke Industries, Inc. prior to January 1, 2009, and Former Amtico Employees, are 100 percent vested in their employer matching contributions. Former DSN Plan participants vest in their matching contributions earned prior to 2014 following a 2/20 graded vesting schedule. All other participants are 100 percent vested in their employer matching contributions after three years of service.

#### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their account balance, whichever is less. The loans are secured by the balance in the participants' accounts and bear interest at rates that range from 3.25 percent to 8.50 percent, which are commensurate with local prevailing rates as determined by the plan administrator. Loan proceeds are reduced by a loan processing fee of \$50. Principal and interest are paid ratably through semi-monthly payroll deductions.

#### *Payment of Benefits*

Upon termination of employment with the Company due to death, disability or retirement, participants are eligible for a benefit equal to the full value of their account. A participant may elect to keep the value of their account balance within the Plan or take a partial or full lump-sum distribution. Distributions are subject to the applicable provisions of the plan agreement and are recorded when they have been approved for payment and paid by the Plan.

#### *Forfeited Accounts*

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,824 and \$105, respectively. During 2024 and 2023, forfeitures of \$1,006,831 and \$803,970, respectively, were used to reduce employer contributions.

### (2) Summary of Significant Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

Investments are reported at fair value, except for the fully benefit-responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by its investment advisors and plan trustee. See Note 4 for discussion of fair value measurements.

##### *Investment Valuation and Income Recognition, Continued*

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### *Contributions*

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

##### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

##### *Excess Contributions Payable*

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions.

##### *Payment of Benefits*

Benefits are recorded when paid.

##### *Expenses*

Certain expenses of maintaining the Plan are paid directly by the Company, at its discretion, and are excluded from the financial statements. No person who already receives full-time pay from the Company shall receive compensation from the Plan, except for reimbursement of expenses properly and actually incurred. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

##### *Subsequent Events*

The Plan has evaluated subsequent events through September 18, 2025, the date the financial statements were available to be issued.

#### (3) Certified Financial Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments, excluding self-directed brokerage accounts, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company (formerly Prudential Retirement Insurance and Annuity Company (Prudential)), the trustee of the Plan.

#### (4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open end registered investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The shares of registered investment companies held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Participant-directed brokerage accounts allow participants to invest in securities that are traded on active exchanges. Such securities include interest bearing cash, common stock, registered investment companies, private equity funds and real estate investment trusts (REITs). These investments are valued using quoted market prices available in an active market for identical instruments for which the individual securities are traded, with the exception of the private equity funds and the REITs. The private equity funds and the REITs are valued as follows:

- *Private equity funds:* Valued using the NAV of the Plan's ownership interest in the individual limited partnership. The funds invest primarily in corporate acquisitions and leveraged buyouts. Redemptions are not permitted, except those received through quarterly distributions. There were no unfunded commitments at December 31, 2024.
- *REITs:* Valued using the NAV of the participant's interest in the individual REIT. REITs acquire, invest in, finance, and manage mortgage-related financial assets, including various types of mortgage-backed securities and mortgage loans. Redemptions are not permitted, except those received through quarterly distributions. There were no unfunded commitments at December 31, 2024.

*Pooled separate accounts:* Valued at the NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

#### **(5) Investment Contract with Insurance Company**

The Plan has entered into a fully benefit-responsive contract with Prudential through its investment in the Prudential Guaranteed Income Fund totaling \$41,834,128 and \$47,387,905 at December 31, 2024 and 2023, respectively. Prudential maintains the contributions in a general account. The guaranteed investment contract issuer is contractually obligated to repay the principal and interest rate that is guaranteed to the Plan.

This contract meets the fully benefit-responsive contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Prudential, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plans' ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a break of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

#### **(6) Related Party Transactions and Party-In-Interest Transactions**

Certain plan investments are shares of pooled separate accounts, registered investment companies, and an investment contract managed by Empower Annuity Insurance Company (Empower). Empower is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment. The Company provides personnel and facilities to perform administrative functions for the Plan at no charge to the Plan.

#### **(7) Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their account balances, and participants' accounts will be distributed in accordance with the plan agreement.

#### **(8) Tax Status**

The IRS has determined and informed the Company by a letter dated March 27, 2018, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **(9) Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
