Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of TMP Technologies, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to financial statements.

Notes to Financial Statements

December 31, 2024 and 2023

(1) Description of Plan

The following description of TMP Technologies, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution retirement plan with salary reduction features as permitted under Section 401(k) of the Internal Revenue Code (IRC), covering eligible employees of TMP Technologies, Inc. and Time Release Sciences, Inc. (collectively, the Company and Plan Sponsor). The Plan is funded by employee and employer contributions. The assets of the Plan are maintained in investment funds held by Ascensus Trust Company (Ascensus), the trustee of the Plan. The Plan is intended to conform with the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent legislation, where applicable.

(b) Eligibility

Employees of the Company are eligible to participate in the Plan upon attaining age 21 and completing one year of service, as defined in the Plan agreement.

(c) Contributions

Participants may authorize an elective deferral contribution and/or a Roth contribution up to 100% of their compensation, as defined by the Plan document, up to the maximum annual limitations per the IRC. Participants who have attained age 50 before the end of the Plan year are allowed to make an additional "catch-up" contribution; this contribution was limited to \$7,500 in 2024 and 2023. Participants may also rollover amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company may make a discretionary matching contribution, which would be allocated in a nondiscriminatory manner based on participant elective deferrals. The Company can also make additional discretionary profit sharing contributions each year; profit sharing contributions of \$670,805 and \$640,499 were allocated for the years ended December 31, 2024 and 2023, respectively, and are included in employer contributions in the statements of changes in net assets available for benefits.

(d) Participant Accounts

Each participant's account is credited with (a) the participant's contributions, (b) an allocation of the Company's contributions, (c) Plan earnings, and (d) charged with an allocation of investment and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(1) Description of Plan, Continued

(e) Vesting

Under the Plan, participants are 100% vested in their salary reduction contributions and employer matching contributions, plus actual earnings thereon. Participants are 20% vested in employer profit sharing contributions after two years of service, as defined, with a 20% annual increase in each of the next four years.

(f) Notes Receivable from Participants

Participants may borrow from their individual accounts a minimum of \$1,000, up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years but may exceed five years for the purchase of a primary residence. The loans are collateralized by vested balances in the participants' accounts and bear interest at a rate of prime plus 1%. Principal and interest are paid ratably through payroll deductions.

(g) Payment of Benefits

Upon termination of service due to retirement, death or disability, a participant will receive a lump-sum distribution equal to the value of their account if the total vested account balance does not exceed \$1,000. If the total vested account balance does exceed \$1,000, the participant may elect to receive a distribution at any time or the vested account balance will be distributed following the later of the date the participant reaches normal retirement age of 65 or the date the participant terminated employment. In-service distributions of fully vested accounts are only allowed upon attaining age 50; participants must reach age 59½ to be eligible for in-service distributions on deferred accounts.

(h) Forfeited Accounts

Employer profit sharing contributions forfeited by participants are used to offset plan administrative costs, reduce employer matching and profit sharing contributions, or restore forfeitures. Accumulated forfeited nonvested accounts of \$28,175 were used in 2023 to reduce the discretionary contributions. Accumulated forfeited nonvested accounts of \$931 and \$6,677 were used to pay administrative expenses during 2024 and 2023, respectively. At December 31, 2024, there were no forfeited accounts available for future use. At December 31, 2023, there were \$895 of forfeited accounts available for future use.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

(b) Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

(c) Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received from the sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 3 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

(d) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

(e) Contributions

Contributions from Plan participants and the Company contributions are recorded in the year in which the participants compensation is earned.

(f) Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan had no excess contributions in 2024 and 2023.

(g) Payment of Benefits

Benefits paid to participants are recorded when paid.

(h) Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

(i) Subsequent Events

Management of the Plan has evaluated subsequent events through the date of the report which is the date the financial statements were available to be issued.

(j) Reclassifications

Reclassifications have been made to certain 2023 balances in order to conform to the 2024 presentation.

(3) Fair Value Measurements

The framework established for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

- Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds' unit values (UV) include daily asset based fees. The mutual funds held by the Plan are deemed to be actively traded.

(5) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants shall have a 100% vested interest in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

(6) Tax Status

The Plan and related trust were established under a non-standardized pre-approved profit sharing prototype plan that received a favorable tax determination letter dated June 30, 2020 from the IRS indicating the features of the Plan, as then designed, conform with the requirements of Section 401(k) of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions and the Department of Labor; however, there are currently no audits for any tax periods in progress.

(7) Party-in-Interest Transactions

Certain Plan investments are shares in mutual funds managed by Vanguard (institutional partner of Ascensus (the Plan trustee)) which qualify as party-in-interest transactions. Additionally, notes receivable from participants qualify as party-in-interest transactions.

(8) Risks and Uncertainties

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
