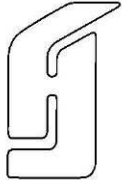

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of LINKBANK 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters - Supplemental Schedule Required by ERISA

The supplemental schedule of assets held for investment purposes at December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

At December 31, 2024 and 2023 and For the Year Ended December 31, 2024

(1) Description of Plan

The following description of the LINKBANK 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan covering all employees of LINKBANCORP, Inc. (the "Company") who have completed three months of service. The Plan is subject to the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions. Participants may contribute up to 100% of their base compensation, as defined in the Plan, subject to the limitations of the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company's matching contribution is fixed at 50% on the first 6% of deferrals. Participants direct the investment of their contributions into various investment options offered by the Plan. All employer contributions are invested ratably in the investment options selected by the participants. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

Rollover Contributions. On November 30, 2023, the Company acquired Partners Bancorp ("Partners"). Partners approved an amendment to terminate their 401(k) Plan. All participants in the Partners Plan became 100 percent vested upon termination and were provided with the option to have their account balances rolled into any qualified plan (including the Plan) or IRA, receive a lump-sum distribution, or be paid through an annuity contract. Individual participants rolled an aggregate of \$4.0 million into the Plan during the year ended December 31, 2024 and are included in rollovers in the statement of changes in net assets available for benefits.

Participant Accounts. Each participant's account is credited with the participant's contribution and the Company matching contributions, as well as allocation of Plan earnings. Allocations are based on participant earnings or account balances, as defined in the Plan. Participants are charged a fee for distributions from the Plan. The benefit to which a participant is entitled is the participant's vested account balance.

Vesting. Participants are immediately vested in their voluntary contributions and employer contributions plus actual earnings thereon.

Forfeitures. At December 31, 2024 and 2023, there were no forfeited nonvested accounts. Forfeitures may be used to pay plan expenses and reduce future employer contributions, if any. There were no forfeitures used during the year ended December 31, 2024.

Investment Options. Upon enrollment in the Plan, a participant may direct their contributions in 1% increments in any of the Plan's investment options. Participants may change their current or future investment options periodically.

Payment of Benefits. On termination of service due to death, disability, retirement or any other reason, a participant may, elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account or periodic payments.

Notes Receivable from Participants. Participants may take only two loans during any twelve-month period and no more than two loans may be outstanding at any time. The minimum amount of any loan is \$1,000. The maximum is an amount not to exceed the lesser of \$50,000 or 50% of the participant's vested account balance. Loans are secured by the balances in the participants' accounts. The repayment period shall not exceed five years for a general-purpose loan. Participants may take out loans used to acquire a principal residence. For loans used to acquire a principal residence, participants may select a repayment period up to fifteen years, with a minimum period of five years. Any unpaid loan balance that exists upon a participant's termination will be subtracted from the total account balance in determining the amount of actual distribution. The unpaid loan balance will be included as part of the taxable distribution from the Plan. Each loan shall bear interest at the prime rate plus 1%. Loan repayments are generally handled through payroll deductions.

(2) Summary of Significant Accounting Policies

Basis of Presentation. The Plan's financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America ("GAAP"). The following is a summary of the significant accounting policies:

Subsequent Events. Management has evaluated all significant events occurring subsequent to the financial statements date through September 22, 2025, which is the date the financial statements were available to be issued, determining no events require additional disclosure in the financial statements.

Estimates. The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition. The Plan's investments are stated at fair value except for its guaranteed return investment accounts, which is valued at contract value. The fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions. Contributions from participants are accrued and credited to participants' accounts as of each pay period.

Benefits. Benefit payments to participants are recorded when paid.

Party-In-Interest. Certain of the Plan's investments were offered by Voya, the Plan's trustees. These transactions qualify as party-in-interest.

(2) Summary of Significant Accounting Policies, Continued

Notes Receivable From Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Expenses. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

(3) Information Certified by Trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Voya Retirement Insurance and Annuity Company ("Voya") held the Plan's investment assets and executed investment transactions from January 1, 2023 to December 31, 2024. Accordingly, Voya, the custodian of the Plan, have certified that the information regarding the value of investments, notes receivable from participants, the related investment income, interest income on notes receivable from participants, and appreciation in fair value of investments as of December 31, 2024 and 2023 and for the year ended December 31, 2024 is complete and accurate.

(4) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(5) Fair Value Measurements

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. The fair value hierarchy requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The hierarchy describes three levels of input that may be used to measure fair value:

Level 1: Observable inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities.

Level 2: Inputs other than quoted prices that are observable for the asset or liability, either directly or indirectly. These include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities that are not active; and model-driven valuations whose inputs are observable or whose significant value drivers are observable. Valuations may be obtained from, or corroborated by, third-party pricing services.

(5) Fair Value Measurements, Continued

Level 3: Unobservable inputs to measure fair value of assets and liabilities for which there is little, if any market activity at the measurement date, using reasonable inputs and assumptions based upon the best information at the time, to the extent that inputs are available without undue cost and effort.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation method used for assets measured at fair value-

Mutual Funds. Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at the price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust. Common Collective Trusts (the "Trust") are valued at their NAV per unit, as provided by the custodian of the Trust. The NAV is determined based on the fair value of the underlying assets within the Trust, which is recalculated daily. These assets are generally classified under Level 2 of the fair value hierarchy, as the NAV is based on actively traded mutual funds.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(6) Investment Contract with Insurance Company

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Voya totaling \$452,143 and \$557,338 at December 31, 2024 and 2023, respectively. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a quarterly basis for resetting. The interest rate for 2024 was 1.65%. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. The Company does not believe that any events that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants are probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

(7) Tax Status

The Internal Revenue Service has determined by a letter of opinion dated October 6, 2020, that the Plan prototype and related trust are designed in accordance with applicable sections of the IRC. The Plan administrator and Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Management has analyzed the tax positions taken by the Company, and has concluded that at December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Related Party Transactions and Party-In-Interest Transactions

Certain Plan investments include investment funds managed by the Trustee, as defined by the Plan, and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan participants for the investment management services were included as a reduction of the return earned on each fund.

(9) Risks and Uncertainties

The Plan has made available various investment options. These investment options are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' balances and the amounts reported in the statements of net assets available for benefit and the statement of changes in net assets available for benefits. The Plan permits every participant to direct the investment of their account balances under the Plan.
