INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
TJ Hale Company 401(k) Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of TJ Hale Company 401(k) Savings Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

ERISA-Required Supplementary Information

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audit of the 2024 financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - The TJ Hale Company 401(k) Savings Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through October 6, 2025, which is the date the financial statements are available to be issued.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Key parties of the plan - TJ Hale Company, LLC is the plan sponsor, employer and the plan administrator. Bank of America, N.A. and its affiliate, Merrill Lynch, Pierce, Fenner and Smith Inc. (collectively referred to as "Bank of America") is the corporate trustee that has custody of plan assets, third party administrator that maintains investment and participant records, tax counsel that performs various compliance tests and investment advisor. Two officers of the plan sponsor are individual plan trustees.

Investments - The plan administrator determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. The earnings on investments bought, sold and held during the years are reflected in the statements of changes in net assets available for benefits. Participants should refer to the prospectuses and annual reports of the investments for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodologies used for assets measured at fair value.

Common/collective trust - Valued at net asset value ("NAV") based on the units of the common/collective trust. The common/collective trust is a direct filing entity. The NAV is used as a practical expedient to estimate fair value of the underlying investments held by the common/collective trust less its liabilities. This practical expedient would not be used if it is determined to be probable that the common/collective trust will sell the investment for an amount different from the reported NAV.

Money market and mutual funds - Valued at the daily quoted market prices as reported by the funds. The funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily NAV and are deemed to be actively traded.

2. DESCRIPTION OF PLAN

The following brief description of the plan is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

General - The plan was established as a defined contribution plan with a 401(k) salary deferral arrangement on January 1, 1970. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - The plan covers all full time, non-union employees who have completed 90 days of service. Employees can begin participating in the plan on the first day of the month immediately following the date the plan's eligibility requirements are met.

Contributions - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made as follows:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). Eligible employees are automatically enrolled in the plan and have 3% of their compensation withheld as elective deferral contributions. These participant deferral percentages will automatically increase by 1% each year until they reach a maximum of 5%. Such employees have the option to increase, decrease, or stop the deferral by completing the necessary documentation. The plan also permits Roth elective deferral contributions.
- b. Employee rollover contributions are accepted by the plan from other qualified plans.
- c. The employer may make flexible discretionary matching contributions. The employer matching contribution was equal to 50% of the first 5% of employee compensation contributed to the plan as employee elective deferral contributions in 2024 and 2023. The contributions are funded coinciding with each payroll.
- d. Additional nonelective contributions may be made at the employer's discretion. To be eligible for such contributions, participants must work at least 1,000 hours during the year and be employed on the last day of the plan year to which the contribution relates. There were no nonelective contributions made to the plan in 2024 or 2023.

Participant accounts - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral, related employer contributions and any rollover contributions. Participants are allowed to change their investment options on a daily basis and change their deferral percentage each payroll.

Vesting - Employee contributions, rollover contributions and related earnings are always 100% vested. Employer contributions and related earnings vest 20% after two years of service and an additional 20% each year thereafter until benefits are fully vested after six years. Upon death, disability or attainment of early retirement age (defined as age 60 with four years of service) or normal retirement age (defined as age 65) while employed, participants become 100% vested.

Payment of benefits - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or attainment of normal retirement age. Participants may receive their distribution in the form of a single lump sum or installment payments. In-service withdrawals can commence upon attaining the age of 59 ½. Hardship withdrawals are permitted under certain circumstances.

Forfeitures - Forfeitures of unvested balances may be used to reduce employer contributions and pay plan expenses. Unapplied forfeitures were \$3,000 and \$6,000 as of December 31, 2024 and 2023. Forfeitures used to reduce employer contributions were \$16,000 and \$5,000 in 2024 and 2023.

Administrative fees - Certain administrative fees of the plan are paid by the employer. Certain other administrative fees are paid by the plan from plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for loan and distribution fees and nonparticipant directed charges for services and administrative and advisory fees. Nonparticipant directed charges are allocated to participants on an account value basis.

Notes receivable from participants - Participants may obtain loans from their accounts. The minimum loan amount is \$1,000 and the maximum loan amount is the lesser of 50% of the participant's vested account balance, or \$50,000. Participants may have two loans outstanding at any time. Loans must generally be paid back over a period not to exceed 5 years, unless used to purchase a primary residence. As of December 31, 2024, the notes receivable from participants had various repayment schedules through February 2028, with interest from 5.75% to 9.50%. The notes receivable from participants are valued at the unpaid principal balance plus any accrued but unpaid interest, which approximates fair value.

3. PARTY-IN-INTEREST TRANSACTIONS

Bank of America manages certain plan investments and is the corporate trustee as defined by the plan. In addition, Bank of America provides certain administrative services to the plan pursuant to a services agreement between the plan sponsor and Bank of America. Direct fees paid to Bank of America by the plan were \$44,000 and \$40,000 in 2024 and 2023. Bank of America receives indirect compensation from mutual fund service providers for services Bank of America provides to the funds. This indirect compensation is used to offset certain amounts that would be otherwise owed by the plan to Bank of America for its administrative services to the plan. If the indirect compensation received by Bank of America from such service providers exceeds the amount owed under the services agreement, Bank of America remits the excess, in the form of refunds, to the plan on a quarterly basis. Such refunds can be used to reduce employer contributions or to pay administrative expenses. There were no refunds received by the plan in 2024 and 2023.

Notes receivable from participants also qualify as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the employer has the right to terminate the plan at any time subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions and related earnings.

5. INCOME TAX STATUS

The plan adopted a Merrill Lynch, Fenner & Smith Inc. Non-Standardized Pre-Approved Plan that received a favorable opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan. However, the plan administrator and tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) if the plan has taken any uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are no audits in progress.
