STATEMENT RE: LATE FILING OF 5500

The Plan Sponsor's business was acquired by another company in January 2023. As part of the acquisition, the Sponsor's 401(k) plan was terminated and employee accounts distributed. Because the staff of the now liquidated sponsor was no longer present at the successor's office, the 2023 Form 5500 was not filed.

The Sponsor's former owner received a notice of non-filing dated 9/8/2025 and immediately produced the attached return once information was gathered from the Plan's old recordkeeper.

Due to the immediate correction of the error and the filer's long history of compliance, we ask that all penalties related to the filing of this return be waived.
