Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of iN DEMAND 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

1. Description of Plan

The following brief description of the iN DEMAND 401(k) Savings Plan (the “Plan”) is provided for general information purposes. iN DEMAND L.L.C. is the Plan Sponsor (“iN DEMAND” or the “Company”). More complete information about the plan agreement and the vesting and benefit provisions is contained in the Plan Document and Summary Plan Description, which is available from the iN DEMAND Human Resources Department.

General

The Plan was established on January 1, 1993 as a participant-directed, contributory defined contribution plan sponsored and administrated by the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) (see Note 6).

Eligibility

Under the terms of the plan agreement, all employees of the Company over the age of 21 are eligible to become contributing participants in the Plan after completing three months of service. Contributing participants will be eligible to receive matching contributions after completion of one year of consecutive service with 1,000 hours of credited service from the initial date of employment.

Contributions

Each participant can contribute between 1% and 60% of his or her annual compensation, limited to the maximum annual dollars as prescribed by the Internal Revenue Service (“IRS”). The IRS maximum contribution was \$23,000 for 2024. Participants can elect pre-tax deferral contributions. As of January 1, 2020, participants can also designate some or all of the deferral contribution elections as Roth deferral contributions. Furthermore, participants may elect to have certain vested assets held on a pre-tax basis converted to be considered designated Roth contributions and the Plan will also accept direct rollover contributions of Roth deferral amounts. Roth deferral and Roth rollover contributions in 2024 were \$66,034 and \$0, respectively. Employees who elect to make contributions are also entitled to employer matching contributions equivalent to 50% of the employees’ contributions, not to exceed 6% of annual compensation. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions, subject to the limitations of the Internal Revenue Code (the “Code”), as amended.

1. Description of Plan (continued)

Beginning the fourth quarter of 2021, participants can also elect to make voluntary, non-deductible, after-tax contributions as well as perform in-plan conversions to convert the after-tax contributions to a Roth account. After-tax contributions are subject to the larger annual additions limit which includes employee and employer contributions. This limit, before catch-up contributions, was \$69,000 for 2024.

Participant Accounts

Each participant's account is credited daily with the participant's contributions, the employer contribution, and any interest, dividends, and investment gains since the preceding valuation date. The participant's account is reduced daily by withdrawals, losses on investments, and forfeitures.

Vesting

Participants immediately vest in their contributions and in the income earned thereon. In addition, participants are fully vested in any prior plan balances that were transferred into the Plan and the income earned thereon. Gradual vesting occurs with respect to matching contributions made by the Company in accordance with the following schedule:

<u>Years of Service</u>	<u>Vesting Percentages</u>
1 year	20%
2 years	40%
3 years	60%
4 years	80%
5 or more years	100%

Notwithstanding the above schedule, a participant becomes 100% vested upon attainment of normal retirement age, disability, or death, or upon termination of the Plan or complete discontinuance of contributions by iN DEMAND (see Note 6).

Forfeitures

Upon termination of employment, participants forfeit their non-vested balances. If a participant is rehired within a five-year period, the forfeited contributions are reinstated. Forfeited balances of terminated participants' non-vested accounts are used to reduce future Company contributions. There were no material unallocated forfeitures balances as of December 31, 2024 and 2023. Forfeitures used to reduce Company contributions were \$27,729 for 2024.

Administrative Expenses

Substantially all of the administrative expenses of the Plan are paid by the Company.

Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Loan terms range from one to five years or up to ten years for the purchase of a primary residence. A participant may not have more than one loan outstanding at any point in time. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

Withdrawals

Prior to termination of employment, the Company may grant a participant's request for a withdrawal if either (i) the Company makes a determination that such withdrawal is necessary in light of the immediate and significant financial needs of the participant and is in accordance with the requirements of the Code and the regulations promulgated thereunder, or (ii) the participant is over age 59½ at the time of withdrawal.

Distributions

A distribution, in the form of a lump-sum payment, up to the vested account balance can be made to a participant upon his or her request due to death, disability, retirement, or termination of employment. If the vested account balance exceeds \$5,000, the distribution may be delayed, at the employee's discretion, until the participant is required by law to receive minimum distributions. If the vested account balance is \$1,000 or less, the distribution cannot be postponed and a lump-sum distribution equal to the participant's vested account balance will be distributed to the participant without his or her consent.

Plan Termination

The Company has the right to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA at any time. If the Plan is terminated, participants will become 100% vested in the value of their respective participant accounts (see Note 6).

2. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies (continued)

Investments

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., the “exit price”). The Plan uses a fair value hierarchy for inputs used in measuring fair value that gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The fair value hierarchy is categorized into three levels:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate or yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level of input that is significant to the fair value measurement in its entirety.

2. Summary of Significant Accounting Policies (continued)

Quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year-end. Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

At December 31, 2024 and 2023, the Plan's investments consisted of mutual funds. All investments are classified as Level 1.

Gains and Losses on Investments

Net realized gains and losses on investments are the difference between the proceeds received and the cost of investments sold using the specific identification method. The change in the difference between the fair value and the cost of investments held, plus net realized gains or losses, is reflected in the statements of changes in net assets available for benefits as net appreciation or depreciation in fair value of investments.

Risks and Uncertainties

The Plan allows participants to invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

Notes Receivable From Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance, plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

3. Investments

Participants choose from different investment options, which consist of various mutual funds. The accounts are credited proportionately with investment earnings. Certain investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

4. Income Tax Status

The underlying pre-approved defined contribution plan has received an advisory letter from the IRS dated June 30, 2020, stating that the form of the plan is qualified under Section 401 of the Code and, therefore, the related trust is tax-exempt. The plan administrator has determined that it is eligible to, and has chosen to, rely on the current IRS opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax exempt; however, the plan administrator has indicated it will take the necessary steps, if any, to maintain the Plan's qualified status.

Accounting principles generally accepted in the United States require the plan administrator to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. Party-In-Interest Transactions

The Plan holds units of mutual funds managed by the trustee of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

6. Subsequent Events

Management evaluated subsequent events for the Plan through September 29, 2025, the date the accompanying financial statements were available to be issued. In May 2024, the Plan Sponsor announced that it will cease its operations approximately at the end of calendar year 2025 and transition its services to its owner companies. The Plan was terminated effective June 6, 2025. On this date, all contributions to the Plan ceased and all participants became 100% vested in the balance of matching contributions made by the Company. Any participant assets of the Plan remaining as of August 29, 2025 were forced out through a rollover. All participant assets of the Plan were distributed as of September 3, 2025.
