Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Specialty Coating Systems 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Notes to Financial Statements

Note 1. Description of Plan

The following description of the Specialty Coating Systems 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible employees of Specialty Coating Systems, Inc. (the Company). The Plan was amended on November 15, 2016, to permit all eligible employees of Kisco Conformal Coating, LLC (KCC), an entity under common control, to participate in the Plan effective January 1, 2017. There were no assets rolled over into the Plan from KCC employees. Subsequent to December 31, 2017, and effective January 1, 2018, the Company purchased all ownership interest in KCC from Uniglobe Kisco, Inc. The Plan was amended on January 1, 2020, to change the non-elective Safe Harbor contributions to equal 100% of deferrals up to the first 6% of a participant's compensation. The Plan was amended on November 1, 2021, to allow excess credits in the Plan to be allocated to participant accounts. The Plan was amended on October 3, 2022, to cap the automatic increase provision at 10% of the employee's eligible compensation.

Eligible employees are employees age 18 or older who have completed three months of service and are not covered under a collective bargaining agreement or not a nonresident alien as defined by the Plan agreement. The Plan allows for automatic enrollment of eligible employees at 3% of employee compensation as defined by the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year, the participants may elect to contribute a percentage of their wages, as defined in the Plan agreement, limited to the maximum amount allowed by the Internal Revenue Service (IRS). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct their contributions into various investment options offered by the Plan. The Plan also permits participants to make Roth 401(k) contributions into the Plan. For participants with a deferral rate greater than zero but less than 10% (who are not suspended from making deferral contributions), the deferral rate will be increased annually by 1% as a pretax deferral contribution until a deferral rate of 10% is reached.

The Company contributes a non-elective Safe Harbor contribution equal to 100% of deferrals up to the first 6% of a participant's compensation. Company contributions are invested in a manner consistent with the participant's contributions. Contributions are subject to certain limitations. For the year ended December 31, 2024, the Company matched \$1,408,458.

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Participant accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contribution and (b) plan earnings and charged with an allocation of certain administrative expenses. Allocations are based on account balances or employee compensation, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50% of their vested account balance not to exceed \$50,000. The number of loans allowed per participant to be approved in a 12-month period is limited to one. One outstanding loan is permitted per participant. The maximum loan term allowed is five years unless used to purchase the participant's principal residence. The loans are collateralized by the balance in the participant's account and bear interest at rates commensurate with prevailing rates. Principal and interest are payable each pay period, primarily through payroll deduction.

Notes receivable from participants related to these loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. At December 31, 2024, participant loans have maturities through November 2031 at an interest rate of between 5.25% and 10.5%.

Vesting: Participants are immediately vested in their voluntary contributions and employer matching contributions plus actual earnings thereon. Should a discretionary employer contribution be made, vesting for this portion of the account is based on years of continuous service, as defined by the Plan. A participant is 100% vested in discretionary employer contributions after three years of credited service. As defined in the Plan document, a participant is entitled to 100% of his or her total account balance upon retirement, death or disability regardless of years of service, provided he or she is an employee. During the 2024 plan year, no discretionary matching contributions were made.

Payment of benefits: Upon termination of service, a participant may elect to receive either a lump-sum or direct rollover amount equal to the vested value of his or her account, or upon death, disability or retirement, receive periodic installments over a period not to exceed the life expectancy of the participant or joint lives of the participant and spouse. Participants may withdraw all or portions of their vested account at any time after reaching 59½. A participant may make only two such withdrawals in any 12-month period. Benefits are recorded when paid.

Administration of plan assets: Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses for the 2024 plan year for the trustee's fees were paid by the Plan.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment custodians. See below for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

Note 4. Fair Value Measurements

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Codification 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of registered investment companies: Valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Interest-bearing cash: Valued at cost which approximates fair value.

Notes to Financial Statements

Note 1. Description of Plan

The following description of the Specialty Coating Systems 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible employees of Specialty Coating Systems, Inc. (the Company). The Plan was amended on November 15, 2016, to permit all eligible employees of Kisco Conformal Coating, LLC (KCC), an entity under common control, to participate in the Plan effective January 1, 2017. There were no assets rolled over into the Plan from KCC employees. Subsequent to December 31, 2017, and effective January 1, 2018, the Company purchased all ownership interest in KCC from Uniglobe Kisco, Inc. The Plan was amended on January 1, 2020, to change the non-elective Safe Harbor contributions to equal 100% of deferrals up to the first 6% of a participant's compensation. The Plan was amended on November 1, 2021, to allow excess credits in the Plan to be allocated to participant accounts. The Plan was amended on October 3, 2022, to cap the automatic increase provision at 10% of the employee's eligible compensation.

Eligible employees are employees age 18 or older who have completed three months of service and are not covered under a collective bargaining agreement or not a nonresident alien as defined by the Plan agreement. The Plan allows for automatic enrollment of eligible employees at 3% of employee compensation as defined by the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year, the participants may elect to contribute a percentage of their wages, as defined in the Plan agreement, limited to the maximum amount allowed by the Internal Revenue Service (IRS). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct their contributions into various investment options offered by the Plan. The Plan also permits participants to make Roth 401(k) contributions into the Plan. For participants with a deferral rate greater than zero but less than 10% (who are not suspended from making deferral contributions), the deferral rate will be increased annually by 1% as a pretax deferral contribution until a deferral rate of 10% is reached.

The Company contributes a non-elective Safe Harbor contribution equal to 100% of deferrals up to the first 6% of a participant's compensation. Company contributions are invested in a manner consistent with the participant's contributions. Contributions are subject to certain limitations. For the year ended December 31, 2024, the Company matched \$1,408,458.

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Participant accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contribution and (b) plan earnings and charged with an allocation of certain administrative expenses. Allocations are based on account balances or employee compensation, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50% of their vested account balance not to exceed \$50,000. The number of loans allowed per participant to be approved in a 12-month period is limited to one. One outstanding loan is permitted per participant. The maximum loan term allowed is five years unless used to purchase the participant's principal residence. The loans are collateralized by the balance in the participant's account and bear interest at rates commensurate with prevailing rates. Principal and interest are payable each pay period, primarily through payroll deduction.

Note 1. Description of Plan (Continued)

Notes receivable from participants related to these loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. At December 31, 2024, participant loans have maturities through November 2031 at an interest rate of between 5.25% and 10.5%.

Vesting: Participants are immediately vested in their voluntary contributions and employer matching contributions plus actual earnings thereon. Should a discretionary employer contribution be made, vesting for this portion of the account is based on years of continuous service, as defined by the Plan. A participant is 100% vested in discretionary employer contributions after three years of credited service. As defined in the Plan document, a participant is entitled to 100% of his or her total account balance upon retirement, death or disability regardless of years of service, provided he or she is an employee. During the 2024 plan year, no discretionary matching contributions were made.

Payment of benefits: Upon termination of service, a participant may elect to receive either a lump-sum or direct rollover amount equal to the vested value of his or her account, or upon death, disability or retirement, receive periodic installments over a period not to exceed the life expectancy of the participant or joint lives of the participant and spouse. Participants may withdraw all or portions of their vested account at any time after reaching 59½. A participant may make only two such withdrawals in any 12-month period. Benefits are recorded when paid.

Administration of plan assets: Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses for the 2024 plan year for the trustee's fees were paid by the Plan.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment custodians. See below for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

Subsequent events: Management evaluated subsequent events for the Plan through August 25, 2025, the date the financial statements were available to be issued.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Codification 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of registered investment companies: Valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Interest-bearing cash: Valued at cost which approximates fair value.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 6. Parties-in-Interest Transactions

Certain Plan investments are managed by affiliates of Fidelity. Fidelity and its affiliates perform services for the Plan and, therefore, these transactions qualify as party-in-interest. The Plan enrolled in a fee leveling program with Fidelity and received a net refund of fees during the period. The refund, received by the Plan, net of fees paid, totaled \$25,245 for the year ended December 31, 2024.

Note 7. Income Tax Status and Uncertain Tax Positions

The IRS has determined and informed the Plan Sponsor, by a letter dated June 30, 2020, that the Plan, as designed, is qualified and the trust established under the Plan is tax-exempt under the appropriate section(s) of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. The Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believes the Plan is qualified, and the related trust is tax exempt.
