Summary of Significant Accounting Policies December 31, 2024 and 2023

Basis of Accounting

High Point Networks, LLC 401(k) & Profit Sharing Plan (the Plan) presents its financial statements on the accrual basis of accounting.

Use of Estimates

In preparing financial statements in conformity with accounting principles generally accepted in the United States of America, Plan management is required to make estimates and assumptions that affect the reported amounts of net assets available for Plan benefits and changes therein, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan's custodian. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as investments held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of administering and maintaining the Plan are paid by the Plan, unless otherwise paid by the employer. Expenses that are paid by High Point Networks, LLC (the Plan sponsor) are excluded from these financial statements. Fees related to the administration of notes receivable from participants and payment of benefits are charged directly to the participants' accounts when incurred and are included in administrative expenses. Investment and other administrative expenses are allocated to participant accounts based on the average quarterly investment balances of each participant.

1. Description of Plan

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, covering qualifying employees of the Plan sponsor.

The Plan is intended to satisfy all the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The administrative committee of the Plan Sponsor is responsible for oversight of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Contributions

All nonunion employees are eligible to become participants in the Plan on the first day of the Plan year (January 1) or the first day of the seventh month (July 1) of the Plan year coincident with or immediately following the date the employee completes six months of service and attains age 18. A participant specifies a specific amount or percentage of eligible compensation, not to exceed Internal Revenue Service (IRS) limits, to be contributed to the Plan (participant salary deferral contributions). Participants may elect to designate their salary deferral contributions as a pre-tax deferral or as a Roth deferral.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Rollover contributions are not subject to contribution limitations.

The Plan sponsor makes safe harbor matching contributions equal to 100% of the elective deferrals that do not exceed 4% of the employee's compensation. The employer may also make a discretionary contribution. Participants do not need to make salary deferral contributions to receive a discretionary employer contribution. Those who are employed on the last day of the Plan year and have completed 1,000 hours of service share in any discretionary contribution. There was no discretionary contribution during the year ended December 31, 2024. The total of the annual employee and employer contributions on behalf of each participant cannot exceed certain IRS limits.

A participant may direct contributions to any of the investment options available from the Plan. Salary deferral contribution amounts can be changed at any time and take effect as soon as administratively possible. Each participant's directed account is credited/charged with an allocation of the directed investment's earnings/losses based on the participant's account balance and credited with the following contributions:

- Participant's salary deferral contributions
- Participant's rollover contributions
- Employer safe harbor matching contributions
- Employer discretionary contributions

1. Description of Plan (continued)

Forfeitures

Forfeitures will be used to pay administrative expenses or to reduce future employer contributions. For the year ended December 31, 2024, no forfeitures were used to pay administrative expenses or reduce employer contributions. As of December 31, 2024 and 2023, forfeited nonvested balances totaled \$74 and \$70, respectively.

Vesting

Participants are vested immediately in their contributions and the safe harbor match plus actual earnings thereon. Discretionary employer contributions are subject to a five-year graded vesting schedule. There have been no discretionary employer contributions to date as of December 31, 2024, thus all balances in the Plan are fully vested.

Notes Receivable from Participants

Participants may borrow from their benefit account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants can have no more than two loans outstanding from the Plan at any time. The loans are secured by the vested balance of the participant's account and bear interest at rates ranging from 4.25% to 9.50% at December 31, 2024 and 2023. Note terms cannot exceed five years except notes for the purchase of a primary residence, which may be longer. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Through March 31, 2024, upon termination of service, a participant whose vested balances exceeds \$5,000 may elect to receive either a lump-sum distribution equal to the vested amount or installment payments. Participants whose vested balance does not exceed \$5,000 are paid a lump-sum amount. Effective April 1, 2024 the limit for the above distributions increased from \$5,000 to \$7,000 under a SECURE Act 2.0 election. Additionally, participants may withdraw any portion of a vested balance upon incurring a hardship as specified by the Plan.

SECURE Act 2.0

On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as "SECURE Act 2.0." These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system, finding ways for them to accumulate more assets, and then ensuring they get connected with those assets when retirement comes. Plan management is monitoring the SECURE Act 2.0 provisions and will implement mandatory provisions as they become effective and relate to the Plan. Although formal amendments have not been made the Plan implemented the following voluntary SECURE Act 2.0 provisions during the year ended December 31, 2024:

- Effective April 1, 2024, mandatory cash-out distributions maximum limit increased to \$7,000.
- Effective May 1, 2024, the Plan allows domestic abuse distributions.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs other than quoted market prices that are observable. These include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used to determine the fair value of Plan investments. There have been no changes in the methodology used at December 31, 2024 and 2023.

- Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Pooled separate accounts are valued at the NAV of the shares held by the Plan at year end. The NAV is based on the fair value of the underlying assets held by the fund less its liabilities. There have been no changes in the valuation methodology used at December 31, 2024 and 2023.
- Common collective trust funds: Valued at the NAV of shares held by the Plan at year end. The NAV, as provided by Empower at December 31, 2024, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the trust, less its liabilities. The practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common collective trust, the investment advisor generally reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

3. Fair Value Measurements (continued)

The preceding valuation method may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. For the years ended December 31, 2024 and 2023, there were no transfers.

4. **Tax Status**

The Plan has adopted a nonstandardized pre-approved profit sharing plan with Empower Retirement, LLC which has received an opinion letter dated November 14, 2022 from the IRS indicating that the Plan, as then designed, was qualified for tax-exempt status under the appropriate sections of the IRC. The Plan has not been amended since receiving the opinion letter. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan is qualified and tax-exempt as of the financial statement date and no provision for income taxes has been recorded in the financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

5. **Plan Termination**

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their accounts.

6. Risks and Uncertainties

The Plan allows participants to invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for Plan benefits and the statement of changes in net assets available for Plan benefits.

7. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are managed by Empower. Empower is the custodian, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing.

The Plan paid fees directly to Empower, the third-party administrator, of \$42,582 during the year ended December 31, 2024. These fees are also included in administrative expenses.

The Plan paid fees directly to Woodbury Financial Services, Inc. and Osaic Wealth, Inc., the investment advisors, of \$9,768 and \$34,674, respectively, during the year ended December 31, 2024. These fees are also included in administrative expenses.

The Plan also paid fees from Plan assets for other advisor services to Empower totaling \$3,276 during the year ended December 31, 2024. These fees are also included in administrative expenses.

These investments, as well as fees paid by the Plan, qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

Additionally, notes receivable from participants are considered party-in-interest transactions.

8. Subsequent Events

Management of the Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.
